SUBJECT: MEMBERSHIP ON METRO SERVICE COUNCILS

ACTION: APPROVE NOMINEES FOR APPOINTMENT TO METRO SERVICE

COUNCILS

RECOMMENDATION

Approve nominees for membership on Metro's Gateway Cities, San Gabriel Valley, South Bay, and Westside/Central Service Councils.

ISSUE

Each Metro Service Council is comprised of nine Representatives that serve a term of three years; terms are staggered so that the terms of three of each Council's nine members expire annually on June 30. Incumbent Representatives can serve additional terms if re-nominated by the nominating authority and confirmed by the Metro Board.

DISCUSSION

The individuals listed below have been nominated or re-nominated to serve by their respective Council's appointing authorities. If approved by the Board, these appointments will serve an additional three-year term ending on June 30, 2017. A brief listing of qualifications for new nominees is provided along with the nomination letter(s) from the nominating authorities for all nominees:

DETERMINATION OF SAFETY IMPACT

Maintaining the full complement of representatives on each Service Council to represent each service area is important. As each representative is to be a regular user of public transit, and each Council is composed of people from diverse areas and backgrounds, this enables each Council to better understand the needs of transit consumers including the need for safe operation of transit service and safe location of bus stops.

FINANCIAL IMPACT

There is no financial impact imparted by approving the recommended action.

ALTERNATIVES CONSIDERED

The alternative to approving these appointments would be for these nominees to not be approved for appointment. To do so would result in reduced effectiveness of the Service Councils, as it would increase the difficulty of obtaining the quorum necessary to allow the Service Councils to formulate and submit their recommendations to the Board. It would also result in each of the Service Councils having less diverse representation of their respective service areas.

NEXT STEPS

There are four Service Council representatives with current terms of service that will expire on July 1, 2014 for which no nomination to reappoint or replace has been received. Staff will continue to work closely with the nominating authorities for these four positions. These representatives may continue to sit with their Service Council and participate in discussions but will not be eligible to vote on any matter before their Service Council. When the Board of Directors approves the nominating authority's candidate, that representative will be eligible to vote at their Service Council meeting.

NEW APPOINTEE BIOGRAPHY AND LISTING OF QUALIFICATIONS

Angie Reyes English, Nominee for South Bay Service Council



Ms. Reyes English has served on the Hawthorne City Council since 2009. She was Mayor Pro Tem from 2010- 2014 and City Clerk 2005-2009. Her work history includes serving for the Los Angeles City Council, District Nine from 2001-2007 and Office of the Mayor Crisis Response Team, Homeland Security (in a volunteer capacity) from 2003-2007 under Mayor(s) Hahn and Villaraigosa. She worked for the California State Assembly (51st) and State Senate (26th) as a Senior District Representative from 2007-2013 before returning to the Los Angeles City Council, District Nine. Today, Ms. Reyes English serves as a Senior Field Deputy to Councilmember Price.

Ms. Jeng's entire working career has been in the field of civil and transportation engineering.
