Metro Orange Line Testing

The station is reporting on the beginning of Metro Orange Line testing, scheduled to begin tomorrow, and will preview safety at Rapidway intersections. Interviews will be aired live and will run in later broadcasts.

Metro's First Explosive Detection K-9 Arrives

Metro has received our first explosive detection K-9, "Napoleon". A formal event will occur when the second explosive detection K-9 is assigned to Security and the dogs assigned to Sheriff's deputies finish training. Metro Security Officer Gus Lozano and "Napoleon" are in the attached photo. For the near future, Officer Lozano and Napoleon will be working in Metro's bus and rail divisions.

Operation "Green Line" Terrorism Training Exercise to be held at the Metro Green Line Marine Station in Hawthorne

Operation "Green Line" is a terrorism training exercise being held in the city of Hawthorne at the Metro Green Line Marine station, tomorrow, Wednesday September 21st. The area "G" command team, which consists of over twelve agencies including both police and fire will be participating in the exercise. The deployed agencies will be responsible for responding to a simulated suicide bombing and "active shooter" scene. Incident responders will be tasked with dealing with what at first is merely a report of an explosion of unknown nature. The situation will rapidly evolve and require immediate action to rescue victims and bring a halt to a sudden violent assault. Members of the media are invited to attend a media briefing at 8:00am and participate in escorted tours of the
