## Metro's Big Rig Tow Truck Press Event

Numerous media outlets attended today's media event where L.A. Mayor Villaraigosa, Long Beach City Councilmember Bonnie Lowenthal, CHP Assistant Chief Art Acevedo, Caltrans District 7 Direct Doug Failing, the California Trucking Association's Sr. Vice President Stephanie Williams and I announced the start of the Metro Freeway Service Patrol's (FSP) Big Rig Tow Service exclusively for the busy I-710 (Long Beach) Freeway.

Mayor Villaraigosa noted that the Big Rig Tow Service is the first of its kind in the nation that is aimed at freeway congestion caused by freight and goods movement. Councilmember Lowenthal spoke of continuing to work with the corridor cities to develop and implement long-term solutions to the congestion and safety issues on the Long Beach Freeway. I mentioned the success of the FSP program over the nearly 15 years of its existence. It covers 400 miles of LA County freeways and has helped more than three million motorists so far.

Media in attendance at today's event included KCBS/KCAL TV, KABC-TV, KMEX-TV, Ch. 35, Korean Television, Los Angeles Times, Copley News, The Daily Journal, International Daily News, Chinese Daily News, La Opinion and the City of Lakewood Cable TV.
