Infrastructure Bond Update

The Infrastructure Conference Committee held its first meeting Thursday morning and had an overview discussion of the Governor's proposal. The committee outlined many of the issues that have already been identified with the proposal and specifically mentioned that the lack of public transit projects was a problem. The Senate Transportation and Housing Committee continues to hold its hearings. This week's hearing was on Public Private Partnerships and the committee was skeptical of the proposal because the public agency loses a fair amount of control. Next week's hearing is to cover the use of design build contracting.

Today, Assembly Speaker Fabian Nunez, Mayor Villaraigosa, LA Councilmember Wendy Greuel and Director Katz spoke at a press conference stressing that the Governor's "Strategic Growth Initiative" needs to include funding for public transportation and that Los Angeles should receive its fair share.
