Glass Windows for MBL (IFB)

Procurement will release an Invitation for Bids (IFB) next week to procure glass windows for the Blue Line Rail Vehicle. The procurement process blackout period is expected to run from April 15, 2013 through July 25, 2013. Replacing the current plastic windows with glass windows that have a harder surface will reduce the amount of damage and etching to the windows along with providing clean interiors for the riding public.
