# **Touring the Expo Line with Congressman Ted Lieu**

This morning, I was honored to join United States Representative Ted Lieu (D-33), Metro 2nd Vice Chair and City of Inglewood Mayor James Butts, Metro Board Member Jacquelyn Dupont-Walker and representatives from the National Railroad Construction & Maintenance Association for a tour of the Metro Expo Line to Santa Monica. We had an opportunity to discuss this unique project designed and built by a construction authority under Metro's oversight. I was pleased to have a shared dialogue with the Congressman about the Expo line, our plans with respect to the construction of the Westside Purple Line Extension and a variety of other issues related to projects and programs being advanced through Measures R and M.





#### Metro's BIF Awards \$10 Million in Grants to Small "Mom and Pop" Businesses

This week, Metro's Pilot Business Interruption Fund (BIF) achieved a significant milestone through the award of more than \$10 million in BIF grants to over 200 small "mom and pop" businesses directly impacted by Metro transit rail construction. The BIF launched during spring 2015 and has successfully awarded:

- more than \$5 million to "mom and pop" businesses along the Crenshaw/LAX transit line;
- more than \$2.3 million to businesses along Purple Line Extension (PLE), Section 1;
- more than \$1.6 million to "mom and pop" businesses within the Little Tokyo area of the Regional Connector;
- and more than \$950,000 to businesses located along the 2nd & Broadway Segment of the Regional Connector;
- Resulting in over 900 jobs retained.

In December 2016, Metro's Board of Directors authorized the expansion of the BIF to include "mom and pop" businesses directly impacted by transit rail construction along Metro's PLE, Section 2. Metro's staff and the contracted fund administrator, Pacific Coast Regional Small Business Development Corporation (PCR) will commence outreach to "mom and pop" businesses along PLE, Section 2 as construction progresses.

Recognizing that small businesses are vital to the economic stability of our communities, it is Metro's goal to support small "mom and pop" businesses to help ensure they continue to thrive in their communities as Metro builds for the future of transportation throughout LA County. Premo. Jerry facilitated conversation with questions such as how did we get where we are, what were our biggest stumbles and challenges in our careers, and what is leadership? # Update on Metro Leadership Academy Class of 2017

As we hit the midway mark of the Metro Leadership Academy (MLA) program, the MLA Class of 2017 has had an opportunity to advance their personal leadership philosophy, develop a more robust understanding of public transportation, and acquire a deeper understanding of what it takes to lead not only at Metro but throughout the transportation industry. Over the last three months, the class has participated in engaging sessions with various Metro departments including Information Technology Services (ITS), System Security and Law Enforcement, and Program Management. In addition to a series of presentations from respective department Chiefs, Senior Executive Officers (EO), Directors and Project Managers, each session included a tour or an engaging exercise.

The ITS department shared information about how they support internal and external customers, innovative technologies in the pipeline, and included a tour of the Data Center at Gateway.

The session with the System Security and Law Enforcement department covered the development and implementation of innovative security and law enforcement strategies; advancing the use of crime analysis tools, problem-solving methodologies and technology; and building and sustaining regional community and law enforcement partnerships. The MLA Class broke into small teams to travel Metro rail stations and note safety observations they experienced.

The Program Management department focused on the successful delivery of capital projects and on-time/on-budget delivery goals in addition to successfully managing teams. The day started with an insightful construction tour of the Crenshaw/LAX Transit Project led by one of the MLA 2017 class participants, Matt Gallagher, Senior Director, Construction Management for the Crenshaw/LAX Transit Project.

The Class has also participated in sessions with Southern Methodist University on "Building and Leading High Performance Teams", "Critical Thinking Skills and Decision Marking Tools" and "Inclusive Leadership". Each session provided a better understating of the factors and dynamics that can either impede their team's performance or propel them to higher levels of achievement as well as the importance of valuing diversity and inclusion.





## Draft EIR Released for Union Station Forecourt and Esplanade Improvements Project

Today, Metro released the Draft Environmental Impact Report (DEIR) for the <u>Los Angeles Union Station</u> <u>Forecourt and Esplanade Improvements Project</u>. This project will enhance pedestrian and bicycle safety and access to and from the Los Angeles Union Station, and reestablish the connection between the station and surrounding communities. The DEIR will be available for public review and comment between Friday, August 11, 2017 and Monday, September 25, 2017, during which time interested individuals, organizations, and agencies can provide written comments.

ExpressLanes: Roadside Toll Collection System (RFP)

Metro will release a Request for Proposals (RFP) to procure the Roadside Toll Collection System (RTCS) for Metro ExpressLanes. The procurement process blackout period is expected to run from Tuesday, August 15, 2017 through Monday, May 7, 2018.

This solicitation seeks the design, development, testing, and installation of a complete and integrated toll collection system for Metro ExpressLanes. The work includes the provision of in-lane roadway equipment with all required support systems to transmit customer trip records to the Back Office System.

#### Connect Bus Services (RFP) - Small Business Prime

Metro released a Request for Proposals RFP to furnish and install Connect Bus wireless equipment services. This solicitation is open to Metro Certified Small Businesses only. The procurement process blackout period is expected to run from Tuesday, August 8, 2017 through Thursday, November 30, 2017.

Metro is seeking the services of a vendor to plan, procure, install, configure and validate wireless local area network (WLAN) communication equipment within the identified bus fleet vehicles.
