#### Metro Participates at the 2020 VerdeXchange Conference

Last week, I participated in a panel discussion at the 13th Annual VerdeXchange Conference on "Reimagining a Metropolis through the Investment in Transportation" with Mayor of City of Inglewood and Metro Board Chair James Butts and Metrolink CEO Stephanie Wiggins to share what's in-market, about-to-be-in-market and needed-in-market to strategically align and optimize clean energy and decarbonization solutions. I explained that as part of our Vision 2028 Strategic Plan, Metro is dedicated to the sustainability of L.A. County's people, environment, and economy. Our commitment means we design, build, operate and maintain infrastructure – and the development around our infrastructure – to meet current needs, without compromising the future. My discussion included the Electric Bus Program, Traffic Reduction Study, P3 opportunities, Metro's Vision 2028 Strategic Plan, major rail projects, transit school, and Transit Oriented Communities. Metro Board of Directors Eric Garcetti and Mark Ridley Thomas also participated at the conference as well as Metro's Chief of Staff Nadine Lee and Chief Innovation Officer Joshua Shank.

We are pleased to join Metro's African American Employees Association (AAEA) and the rest of the country in celebrating Black History Month throughout the month of February. The month-long celebration began in 1976 following a history of various celebrations by Harvard-trained historian Carter G. Woodson and the prominent minister Jesse E. Moorland. February was the chosen month to coincide with the birthdays of Frederick Douglass and Abraham Lincoln.

This is a month to celebrate the significant accomplishments, achievements, advancements and broken barriers made by Black and African Americans throughout United States history. At Metro, we want to especially acknowledge trailblazers in the transportation and infrastructure industries.




### APTA Business Members Annual Meeting on Capital and Small Business Programs

On Friday, January 31, Chief of Vendor and Contact Management Officer, Debra Avila and I attended the APTA Business Members annual meeting to discuss critical issues shaping business member interests in public transportation. The program included sessions and interactive discussions on the impact of new technologies, demographic change, ridership challenges, working with transit CEO's, and maximizing the power of sponsorships. I provided a high-level overview of Metro's Capital and Small Business Programs, explaining that at Metro, we believe small businesses are essential to building and maintaining our fast-growing transportation network. Ultimately, our commitment is to increase the number of small businesses that are certified with Metro so they can proactively participate in the procurement process. We want to make sure that small businesses can compete fairly with the big companies and make it as easy as possible to work with Metro by creating a level playing field.

### NextGen Bus Plan Workshops Begin on a High Note

We kicked-off our NextGen workshops on Saturday with more than 120 people joining us at LA Trade Technical College in downtown Los Angeles. Over three hours, members of the public learned about the draft Plan, spoke with staff, used interactive tools to view line-specific proposals, and shared their thoughts. This was the first of nearly two dozen workshops planned through March around the County. This week, we have workshops scheduled for Tuesday, February 4th in San Pedro and Wednesday, February 5th in Van Nuys. ## Metro Kick's Off the Second Annual Youth Career Experience Program

On Wednesday, January 29, I kicked off the second annual Metro Youth Career Experience Program (MYCE). This youth engagement program uses project based learning activities to expose and educate high school students to the development stages, strategies and career pathways involved in a capital improvement project affecting their local community. This year, we used the Regional Connector project as the case study to engage students.

In this first module, we introduced students from three different local high schools to careers in Transportation Planning, Architecture, Civil and Environmental Engineering. As a team, students worked with their peers and Metro staff to build a light rail station by selecting architectural elements, developing a budget and schedule for their project while considering the community's feedback for each element. Students were given a budget to purchase design features to modernize their station by including landscaping, lighting, security, signage, and art while maintaining a schedule and keeping the project within budget.

In this second year, we have connected our MYCE curriculum to California State Common Core and Next Generation Science Standards to allow participating students to earn high school credit towards graduation. A special thanks to all internal stakeholders from Human Capital & Development, Program Management, Communications, System Security & Law Enforcement, and Planning for coming together and making this program happen for a second year.





## Metro's Leadership Academy Class of 2020 Kick Off

On Monday, January 27, the Metro Leadership Academy Class of 2020 kicked of the program's fifth year with 40 participants from multiple departments and levels of the organization. This 12-month program has attracted over 150 employees who have committed themselves to learning and development, beyond their regular roles at Metro. The program leaves participants with a heightened awareness of personal leadership style, enhanced self-confidence, individual influence and leadership development for a stronger corporate succession plan.



#### Gathering with the Westside Faith Community

Last Thursday, January 30, I hosted a Faith Leaders Roundtable with religious leaders from the Westside to learn

more about Metro and provide us feedback about our homelessness outreach program on the Metro system, transformative projects in the Westside like the Sepulveda Transit Corridor and Purple Line Extension, and the latest about the NextGen Bus Plan. This Roundtable is one of many efforts Metro has been working on to manifest my vision for engaging the faith community so that we may collaboratively design and improve Metro programs to benefit communities. Some leaders in attendance have supported Metro's efforts in the past, including the passage of Measure M, and I look forward to this partnership and more strengthening with the Westside faith community moving forward.

Imperial Highway, Los Angeles, California 90059 and at CMF Bldg. 3 at 470 Bauchet St, Los Angeles, CA 90012. **This solicitation is open to Metro Certified Small Businesses only.** The procurement process blackout period is expected to run from February 2, 2020 to April 21, 2020.

The intent of this project is to provide emergency backup generator needed to support Metro's 24/7 operation.

## Construction Notices: Regional Connector, Orange Line, I-5

#### Regional Connector: Street Restoration closures at 1st/Alameda in DTLA

Street restoration at the 1st St and Alameda St intersection is now scheduled to start January 10, 2020. Plan ahead as lane reductions and road closures will be in place through the summer, as this work will be completed in two stages, each lasting approximately four months.

#### Purple Line Extension: Orange Grove Closure at Wilshire Blvd

Orange Grove Ave. south of Wilshire Blvd. and north of 8th St. will be closed for 8 months starting Friday, October 18. The existing sound walls will be extended west to surround the closure area, which is required to construct the Wilshire/Fairfax Station. Residents of Orange Grove Ave. will continue to have access.
