First Week of NextGen Virtual Public Hearings

Our first week of NextGen Virtual Public Hearings was a success. More than 60 people logged in and participated in the three hearings held last week. The first two focused on proposed changes in the San Fernando Valley and South Bay Cities, and the third hearing held on Saturday focused on changes being considered for all regions of LA County. These hearings give the public an opportunity to learn about the changes under consideration and tell us what they think about the proposed major service changes to Metro's bus system. The NextGen team led by Senior Executive Officer of Service Planning Conan Cheung, presented an overview of the NextGen Bus Plan including our commitment to upgrade our bus system for everyone in LA County. Metro is accepting comments through Thursday, August 27, 2020. The final three public hearings are scheduled for this week beginning tonight:

The public hearings are available to watch live on our webage, <u>metro.net/nextgen</u>. Simultaneous translation for all hearings will be available in Spanish, Mandarin, and Russian. Public comments received online prior to and during the public hearing will be read aloud during the public hearing session and will become part of the public record. All comments will be reviewed and evaluated as part of the decision-making process.

Alternator Belt Drive (IFB)

Metro released an Invitation for Bids (IFB) to procure alternator belt drive. The procurement process blackout period is expected to run from Friday, August 21, 2020 through Friday, December 18, 2020.

Award of a contract will provide a commitment from the supplier to ensure availability as outlined in the Technical Requirements on an Indefinite Delivery/Indefinite Quantity (IDIQ) contract basis.

Inverter Control Box (IFB)

Construction Notices: Regional Connector, I-5

Regional Connector: Street Restoration closures at 1st/Alameda in DTLA

Street restoration at the 1st St and Alameda St intersection is now underway and scheduled to last through August 31, 2020. Plan ahead as lane reductions and road closures will be in place through the summer, as this work will be completed in two stages, each lasting approximately four months.
