
## **Operations April 2021 Employees of the Month**

#### the Central Avenue Angels Walk LA Project

Last Tuesday, April 13, a ribbon-cutting ceremony was held for the Central Avenue Angels Walk LA project. The event was hosted by City of Los Angeles Councilmember Curren D. Price, Jr., 9th District, and was attended by Frank Ching, Deputy Executive Officer, Countywide Planning & Development, as Metro's representative. This project celebrates the rich history of South Los Angeles through a guided walking tour utilizing information stanchions installed at 15 different locations along Central Avenue and through information provided in a guidebook, which is available both as hardcopy and also digitally. ## Transit App Now Displays COVID-19 Vaccination Locations

Thanks to a collaboration with the Los Angeles County Department of Public Health, Metro's official app, *Transit*, is now displaying locations across L.A. County where residents and workers age 16 and older can get vaccinated against COVID-19. Metro riders open Transit every day to track their bus or train. Now riders will also see yellow pins in the app showing where they can get vaccinated, including at local pharmacies, thanks to regularlyupdated information directly from Public Health. Riders can tap on the yellow pins in *Transit* to make a vaccination appointment through the official Public Health website and get transit directions to their vaccination location. #### **Procurement Postings**

#### Rescue Ride Pilot (RFP)

Metro released a Request for Proposals (RFP) to procure bulk ride coupon codes (also known as credits) from one or more on-demand ride providers. The procurement process blackout period is expected to run from Friday, April 9, 2021 through Thursday, June 3, 2021.

Metro is seeking one or more qualified service providers from whom Metro can purchase credits that are available for Metro to distribute through its official App and other channels, and that riders can redeem in real time for a timely ride.

Joint Development On-Call Design Review Consultant (RFP) - Small Business Prime Metro will release a Request for Proposals (RFP) to procure professional services for Joint Development On-Call Design Review Consultant. **This solicitation is open to Metro Certified Small Businesses only.** The procurement process blackout period is expected to run from Wednesday, April 21, 2021 through Monday, July 19, 2021.

Metro is seeking to procure an "on call" contract with a qualified urban and architectural design Consultant. The purpose is to assist with site planning, development program feasibility, and design review for potential joint development projects on Metro-owned properties.

#### Construction Notices: Regional Connector, Purple Line Extension, I-5

<u>Regional Connector Transit Project</u> - <u>Bikes Prohibited Westbound 1st Street at Vignes</u> Due to increasing construction activities for Metro's Regional Connector Transit Project including excavation of the 1st St Portal and future removal of the Gold Line tracks across 1st St—westbound 1st St is closed at Vignes St to all bicyclists through the duration of construction. <u>Purple Line Extension Project: Gale Dr. Closure, Utility Duct Bank Installation</u> Beginning Monday, April 12, and continuing through Friday, May 7, Gale Dr. north of Wilshire Blvd. will be fully closed to support the installation of a utility duct bank.
