### Visiting Troops at the National Training Center at Fort Irwin

I had the honor of traveling to the US Army's National Training Center at Fort Irwin,

California to speak to the troops about leadership. I made the trip with Metro's Veteran Liaison Dennis Tucker and Communications Manager Chris Balish, who assisted with support and logistics. The National Training Center is the largest military training installation in the world, and home to the National Training Center Operations Group Wolf Team. 2021 marks the fifth year that Metro's Office of Civil Rights and Inclusion has recognized Bus Operators for their dedication to serving customers with disabilities.

Traditionally, the Accessibility Awards recognizes Metro's outstanding Bus Operators who have demonstrated excellent securement skills in the Annual Wheelchair Securement Competition. This year, the Covid-19 pandemic prevented Metro from conducting the accessibility fairs and securement challenge in person, compelling the Office of Civil Rights and Inclusion's Accessibility Team to explore other ways to celebrate Bus Operators' excellence in accessibility compliance.

Through careful examination of Mystery Rider Program statistics, customer comments, and nominations from Division leadership, the Office of Civil Rights and Inclusion has chosen the areas of customer service, securement compliance, and customer commendations to spotlight Operators' dedication to serving Metro riders with disabilities during these difficult times.

### **Crenshaw North Extension Bridging Divides: Scoping Meetings**

The Crenshaw Northern Extension project completed its first of three (virtual) scoping meetings as part of the environmental review process taking place April 15 through May 28. Over 165 participants attended the first scoping meeting on Thursday, April 29, from 11:30

a.m. to 1:30 p.m., where they were able to provide input and feedback. Staff presented scoping and project objectives and walked participants through the environmental review process for the three alignments currently being studied. The next two meetings will be held via Zoom on Thursday, May 6 and Saturday, May 8.

This study is evaluating three potential alignments to extend the Crenshaw/LAX line north from the E (Expo) Line with connections to the D (Purple) and B (Red) Lines and five of our busiest bus lines, with a potential terminus at the Hollywood Bowl. The potential alignments are projecting impressive ridership numbers around 90,000 boardings per day with significant travel time savings to key destinations such as the Hollywood Bowl, LAX, West Hollywood's Rainbow District, Farmers Market/The Grove, West Adams, and Cedars Sinai.

Measure M allocated \$2.24 billion for this project with a groundbreaking of 2041 to be completed in 2047. As part of Metro's early project delivery strategy, the cities of West Hollywood, in coordination with the City of Los Angeles and Metro, are exploring ways to secure additional funding that could accelerate the project. We anticipate updating the public with responses from the scoping meetings in Fall 2021.

Attendees impressed by the breadth of workforce programs asked the panelists how they got involved with their respective programs at Metro, and wondered how Metro can measure social sustainability. Social sustainability is one of the three pillars of sustainability and is an integral part of Metro's sustainability Strategic Plan, *Moving Beyond Sustainability*, which guides the agency's decision-making and operations, while also prioritizing community resilience, equity, and workforce development.
