Groundbreaking for Construction on Purple Line Extension Section 3

This morning, we held a groundbreaking for the third and final section of the Purple Line Extension Project: the two-and-a-half-mile segment between Century City, UCLA and Westwood/VA Hospital. The ceremony was staged at the U.S. Department of Veterans Affairs property. I joined Metro Chair and Los Angeles Mayor Eric Garcetti, FTA Deputy Administrator Nuria Fernandez, Metro Board Member and Los Angeles Councilmember Mike Bonin, Metro Board Member and Whittier Councilmember Fernando Dutra, West LA VA Director Steve Braverman, and Vice Chancellor of UCLA Michael Beck to speak at the event to mark this important early project milestone. Special thanks to U.S. Representative Karen Bass who sent virtual greetings to the ceremony and thanks to our local, state, and federal partners who sent representatives to attend. We are very excited to bring a fast and efficient transportation option to our Veterans needing access to the VA property.

Metro is currently 19 percent complete constructing Section 3 of the project. To date, most construction activities have centered on advance utility relocation work and final design and engineering work. Metro has inserted one tunnel boring machine (TBM) into the ground on the VA property site, with the second planned to be inserted within the next couple of months. Metro's contractor will soon begin piling operations to build a station box perimeter prior to station excavation work. Section 3 funding includes a \$1.3 billion federal grant that will be delivered through a multi-year Full Funding Grant Agreement that is governed by the FTA's Capital Investment Grant program, popularly referred to as New Starts.

Metro Receives First Place APTA AdWheel Awards



Metro Launches Adopt-A-Bike Program in Partnership with Community-Based Organization's

Last Friday, Metro launched the Adopt-a-Bike Program and distributed for free more than 100 previously owned bicycles. Senior Executive Officer, Holly Rockwell and Deputy Executive Officer, Frank Ching from Countywide Planning welcomed the recipients to the Union Station Bike Hub where the event was held. The bicycles that were distributed represent some of the hundreds of bikes abandoned on a monthly basis on the bus and rail system and at Metro facilities. Through the Adopt-a-Bike Program, these bicycles will now be offered to Los Angeles County residents living in equity focused communities in an effort to improve their mobility options and access to jobs, recreation, and other opportunities. The Adopt-a-Bike Program brings equity value directly to people's hands.

To reach recipients, Metro is partnering with six community-based organizations (CBO's) that include Active SGV, Walk n' Rollers, People for Mobility Justice, Healthy Active Streets, Willowbrook Inclusion Network (WIN), and Instituto de Avance Latino a Community Development Corporation (IDEAL CDC). These CBOs will also assist in preparing the bicycles for distribution by conducting safety checks and repairs. Additional Adopt-a-Bike giveaway events will be held in the coming months. Metro released an Invitation for Bids (IFB) to procure Special Event Audio/Visual Services & Equipment Rental Services. **This solicitation is open to Metro Certified Small Businesses only.** The procurement process blackout period is expected to run from Friday, May 21, 2021 through Monday, June 21, 2021.

The Metro Public Relations Department is seeking a contractor to provide special event audio-visual services and rental equipment for upcoming Metro events.

The selected contractor must have the capability to support multiple special events with possible events going on simultaneously and up to 40 events or more, a year. Events can range in scale between high level press conferences, outdoor concerts, community festivals, formal and invitation-only affairs, industry conferences, rail line openings, etc.

Special Event Services & Equipment Rental (IFB)

Elevator Attendant Services (IFB) - Small Business Prime

Metro released an Invitation for Bid (IFB) to seek a qualified contractor to provide elevator attendant services as part of a pilot program at two Metro B Line (Red) rail stations: Civic Center and Pershing Square Stations. The procurement blackout period is expected to run from Thursday, May 20, 2021 through Friday, September 3, 2021.

Interested bidders must demonstrate a minimum of three (3) years' experience in performing elevator attendant services, frontline customer service with attendants or comparable customer service experience for a minimum of three (3) public or private entity clients.

<u>Labor Compliance Monitoring Services Bench (RFIQ)</u>

Metro will release a Request for Information and Qualifications (RFIQ) to establish a Labor Compliance Monitoring Services Bench. The procurement process blackout period is expected to run from Thursday, May 27, 2021 through Friday, November 5, 2021.

The Los Angeles County Metropolitan Transportation Authority (Metro) seeks to establish a bench of qualified firms to provide labor compliance program support services to monitor construction projects in accordance with State of California and Federal Labor Code.

Tasks include evaluating, monitoring, and enforcing prevailing wage requirements on Metro's construction projects. Bench consultants shall maintain all required labor compliance records, provide assistance to field personnel and contractors, conduct field interviews, conduct investigations, prepare appropriate notices following the conclusion of any investigation and perform any and all other duties necessary to carry out the function of the compliance activities in accordance with the laws, regulations and provisions which govern public works contracts in California.
