New RTD Valley division opens

Southern California Rapid Transit District bus service expansion in the San Fernando Valley is supported by new RTD division 15 which formally opened Sunday, December 22,

The first bus to roll out of the facility at 4:14 a.m. that day was the Line 39 driven by operator Donald Rabjohn, Line 39 operates from Glenoaks and Burbank Boulevards to 11th and Main Streets in downtown Los Angeles.

On hand for pre-dawn refreshments and the ribbon-cutting ceremony were several members of RTD's Transportation and Maintenance departments. Operator Rabjohn cut the ribbon which officially opened the operating division, located at 11409 Penrose Street.

The new division will ultimately serve as a "home port" for 220 buses serving the San Fernando Valley

"The opening of this operating division stands as perhaps the most graphic evidence of the expanded bus service being planned for Valley

residents," said Thomas G. Neusom, RTD president. "Early next year, the District will initiate service on the San Fernando Valley Grid System. New lines will blend with established services to cross-hatch the Valley on major north-south and east-west streets approximately one-half mile

According to Jack R. Gilstrap, RTD general manager, the division will eventually become the base of operations for over 300 drivers and 60 maintenance personnel. "Division 15 will make our transit services in the Valley much more efficient and less costly," he explained. "Each day, we will be able to operate with a

greatly reduced 'deadhead' factor that is the time a bus has to travel from the division yard to the starting point of a line to pick up fare-paying passengers. With the added capacity of the new facility, we will be able to assign to Division 15 most of the buses necessary to implement the Valley Grid System."

Manager of the new division is Luther "Ed" Edmondson, who has been with the District for 28 years. 'The maintenance department has literally built these offices around us," he said. "There's one thing about opening up a new division . . . it doesn't happen too often. There are always things you have to do without, a lot of supplies you don't have, and a lot of forms that you'd forgotten existed."

Most of the drivers at division 15 are transfers from divisions 8 and 10. Many of them elected to come to the Valley division because it was more convenient to their homes. Mechanics and utility men transferred to the new division for similar reasons.

According to C.B. "Tex" Lawson, division 15 maintenance supervisor, the new division covers about 13 acres. It presently houses 107 buses,

"For the past three years, several members of RTD management and I go around to the divisions just before the Christmas holidays," said George W. Heinle, manager of operations. "It's just a casual thing. We go around, shake employes' hands and wish them a good holiday. We just want them to know we appreciate the hard work that they do for the District and that we haven't forgotten

This past holiday season was no different. Heinle, along with "Johnnie" Johnston, superintendent of transportation, Frank Barnes, deputy administrator for operations, George Powell, general superintendent of maintenance and equipment, and George Wells, deputy administrator for equipment, extended cordial wishes for a happy holiday and prosperous new year to employes at RTD's operating divisions.

Heinle stated that the visit also gave the employes a chance to pass on suggestions to the District policymakers.

One consistent request that came out of every division was that we resume the 'rap sessions'," he said.

The 'rap sessions' which began early last year, were designed to promote a healthy exchange between the District's executives and the employes. During the sessions management officials 'rapped' with employes about anything concerning Districtemploye relations. RTD would supply coffee and the employes would supply the questions.

"The response to the sessions has been so positive, that we have decided to start them again in the very, near future," said Heinle. "I really look forward to these visits. Something valuable always comes out of them."

'Fairfax Connection'

An RTD transit innovation will soon have many Los Angeles residents riding the "Fairfax Connection.'

The Southern California Rapid Transit District began an experimental "saturation service" on Monday, January 6, in the heart of its Line 89 on Fairfax Avenue. Bus service will be doubled on Fairfax between Wilshire and Hollywood Boulevards to make more buses available along the busy thoroughfare, and cut waiting and transfer times to the many east-west lines in the area.

'The Fairfax line has been one of the major north-south crosstown routes in L.A. public transportation," said Thomas G. Neusom, RTD president. "With the high population density in the area and the corresponding traffic congestion, we expect to attract many new riders to the line."

In its entirety, Line 89 runs up Fairfax from Adams Boulevard into Hollywood, via Sunset, Vine, Franklin, and Western. Monday through Saturday, service from Wilshire to Hollywood Boulevard will be improved from 12 to six minutes and from 15 to 71/2 minutes on Sundays.

"With just one transfer, passengers can utilize the saturation service to connect with any of the 10 intersecting east-west lines and travel all over the metropolitan area," said Jack R. Gilstrap, RTD general manager. "We hope to see an increase in patronage on Line 89 commensurate with the increased level of service."

The first phase of the experiment will be evaluated after 13 weeks, Gilstrap said. Passenger

RTD trainees up early for District tour

It is four-thirty on the morning of Friday, December 20. The cold wind whips under the coats and jackets of the Southern California Rapid Transit District's six management trainees. Teeth chatter, hungry stomachs rumble, and weary eyes long to give into sleep. Almost dramatically, a new RTD bus rolls up to the curb, offering warm shelter to the group assembled.

This early morning gathering was the beginning of a tour of RTD facilities provided for RTD's management trainees. The tour was designed to familiarize them with major operating components in the District.

Trainees were treated to a firsthand view of RTD drivers being scheduled for their various bus routes, the cash counting room, the dispatch center, as well as the division 2 maintenance shops which currently house the double-deck bus.

"I thought the tour gave better insight into what RTD is all about, beyond the downtown office," said trainee Diane Moran, of the person-

nel department. "We had a chance to know just how an operator feels going to work in the middle of the night, while many of us are still asleep."

After four hours of intense observation and education, the trainees were treated to a leisurely, muchappreciated breakfast, prepared by the maintenance department.

From division 2, the trainees were transported to the South Park shops, and were taken on the "grand tour" of the facilities by George Powell, general superintendant of maintenance and equipment, and Harry Macguire of the transportation department. "Mr. Powell and Mr. Macguire were wonderful," said advanced training train-

ee Barbara Osborne. "We all appreciated their enthusiastic effort to teach us the interworkings of the District."

Still another fascinating tour, according to the trainees, was yet to come...one of RTD's most successful innovations... the El Monte Busway. The trainees reached the Busway via the recently installed Spring Street contraflow lane.

"The Busway has a good-looking, modern design, which seems to lend to its efficiency," said Paul Sun from the purchasing and stores department. "However, I would like to see RTD getting the maximum use out of it. It is a facility that is desperately needed and I am proud that we were the first to come up with it."

In spite of the broadened knowledge which filled the heads of the six observers, a pause for lunch did much to relieve the gnawing of empty stomachs.

"We still had a lot more to see. We were yet to discover some of the interesting operations that were going on inside of the RTD office building, said Massoud Javadizadeh, who is currently training in the operations department. "The data processing department is the one that interests me. Considering the extensive amount of work to be done at RTD, the existing computers are inadequate." Javadizadeh continues. "The new computer that we are getting will be a great asset. A lot of the operations that are now performed manually will become computerized under the new system."

Rick Wilson, who is presently working in the Administrative offices, insists that the "room where they count the money" is the most fascinating. "It's amazing to think how many coins pass through our fare boxes each day, and even more amazing to think that a handful of people get it all counted," he said. "The cash-counting room works like a machine and it was fascinating to watch it in action."

All of the trainees agreed that the tour was impressive. However, transportation trainee Michael Leahy points out that there was nothing unusual about the early morning hours.

Improved Line 149

Travelers from as far west as the Arlanza area will be able to reach March Air Force Base and the University of California-Riverside on a single bus when the Southern California Rapid Transit District's extended Line 149 goes into effect on Sunday, Jan. 5.


Improved service on Line 149 features buses on 30-minute headways (at half-hour intervals) to the University of California-Riverside from approximately 6:00 a.m. to 9:30 a.m. and 3:30 p.m. to 6:00 p.m. and 60 minute headways to the air base from 7:00 a.m. to 5:00 p.m. Monday through Friday. Saturday service will be provided at hourly intervals to these locations from 7:00 a.m. to 5:00 p.m. There will be no Sunday or holiday service.

Referring to the Line 149 change and to improved east-west service on RTD Line 62, also to begin on Jan. 5, RTD General Manager Jack R. Gilstrap said "the two line improvements represent major advances in Riverside public transportation."

Service along Magnolia Avenue between Tyler Street and Van Buren Boulevard will be provided by Line 62.

The eastward extension of Line 149, from its former terminal at the RTD Riverside Station, goes along University Avenue to West Campus and Canyon Crest Drives and follows Central Avenue to the Escondido Freeway. The extended route will follow the freeway to Allesandro Road, turn south on Graham Street and end at Dekay and Eschscholtzia Avenues at March Air Force Base.

South Central grid begins



Nine new bus lines began service in South-Central Los Angeles on January 19, and according to the Southern California Rapid Transit District, they are only a forerunner of things to come.

Together with established lines already serving the community, the new routes form the first phase of a comprehensive grid pattern of bus lines running on every major north-south and eastwest street in the area. The new program is known as RTD's "Streetway System 321."

When the second phase is completed in March, residents will be able to walk to a bus line within three blocks of their home, and within 20 minutes board a bus,

purchase *one* transfer (if necessary) and travel anywhere in their neighborhood without a schedule.

"As a first step, we are implementing service on these nine new lines," said Thomas G. Neusom, RTD president. "This improved level of public bus service will greatly aid the travel of local residents and bring many employment and educational opportunities within their grasp."

According to Jack R. Gilstrap, RTD's general manager, the new line operate every 20 minutes from 6 a.m. to 7 p.m. Monday through Saturday, and from 8 a.m. to 6 p.m. on Sunday. "Thanks to the Los Angeles County Board of Supervisors, RTD will be able to greatly improve the level of service to the community under the terms of the 25-cent flat fare subsidy," he said. "These service improvements are long overdue, yet this is the first time we have had the funding to support such a program." Gilstrap noted, however, that the program is funded by the County for 90 days only on an experimental basis.

The nine new lines include:


