

Mayor Reappoints A Letter From The General Manager Dear Fellow Employees: dedicated RTD employees, gets is based up

Dr. Norman Topping, president of RTD, has been reappointed to the board of directors for another four-year term by Mayor Sam Yorty.

Dr. Topping has been a director with RTD since the agency was formed in 1964 and has long been dedicated to the improvement of public transportation in the Los Angeles area.

In addition to his duties as president of the Board, Dr. Topping is chancellor and former president of the University of Southern California. He has served as chairman of the former Citizens' Rapid Transit Action Committee, and is active in many professional, civic and business organizations.

Dear Fellow Employees:
On November 4, 1971,
Governor Reagan signed into law Senate Bill 325 which enables the continued growth and development of public transit in California.

Never before has there been such widespread community support for our Rapid Transit District. Tremendous efforts was exerted by civic leaders and individual citizens to convince the Legislature and the Governor that this measure was vital to the District and the community. The only reason we received such support was because these people believe in the need for good public transit and our agency's ability to provide this serv-

This trust in the District is based on the work of

dedicated RTD employees, such as yourself. Whether you are an operator in daily contact with our patrons, or behind the scenes as a mechanic or a clerk, you can take pride in knowing that you played an important part in building this confidence.

By way of general explanation, Senate Bill 325, authored by Senator James R. Mills, applies the general sales tax to gasoline statewide. This raises about \$150 million statewide, of which roughly \$30 million goes to the cities and counties for general fund help and approximately \$120 million becomes available for transit in urban areas and for streets and roads in our State's rural counties.

The amount each county

gets is based upon the sales tax generated in that county. Los Angeles County should receive about \$43 million annually for transit. RTD may be able to claim up to \$35 million a year of this, and the eight municipal operators in the county will share the other \$8 million a year.

All of this occurs by way of some rather complicated changes that SB 325 makes in our statewide sales tax law. Essentially what happens is that the overall sales tax remains at 5%. The State's current 4% share of the 5% is reduced to 3¾% (which, however, makes no change in the actual dollars the State receives, since the 3¾% is applied to the larger base which now includes

Funds Earmarked To Help Transit Systems Maintain And Improve Service

An ongoing effort to secure permanent public fund support for transit has culminated in the passage of public transit funding legislation at the current session of the California legislature.

Governor Reagan on November 4, signed into law Senate Bill 325, which removes gasoline from its sales-tax-exempt status and earmarks the receipts for the benefit of public transit, city and county roads and the general funds of cities and counties.

Dr. Norman Topping, RTD president, said the emergence of SB 325 into law is a "tribute to leadership in the Legislature and Governor Reagan."

Speaking in behalf of the 11-member Transit District Board of Directors, Dr. Topping added that the signing of the measure by the Governor "speaks to the state-wide support for the measure. RTD vigorously supported the bill."

A host of diversified groups and individuals strongly endorsed the need for the legislation, which was introduced by Senate President Pro-tem James R. Mills and co-authored by Assemblyman Wadie P. Deddeh, chairman of the lower house's Transportation Committee, and Senator Alfred E. Alquist.

In signing the bill, the Governor said "it will enable local officials to accelerate their efforts in developing comprehensive and balanced transportation systems."

Author Mills termed his successful bill "unquestionably

the greatest accomplishment of this legislative session."

"The hundreds of individuals and groups throughout the state who vigorously worked in behalf of transit financing legislation are to be thanked for their contributions to an improved way of life in the form of greater mobility, along with other benefits," said Jack R. Gilstrap, RTD general manager.

Gilstrap added:

"The Governor and the members of the Legislature have responded to numerous appeals from government, business and civic groups that it is imperative public transit be placed on a firm financial footing.

"Most assuredly, the passage of the bill marks a breakthrough in the effort to achieve balanced transportation.

"Our Legislators, to their credit, responded to the wishes of the people for a way out of the daily sigalert-maze and pollution-enveloped skies."


Those supporting the bill included the Governor Reagan-appointed California State Transportation Board, the California State Chamber of Commerce, the City and County of Los Angeles, the Automobile Club of Southern California, the California Retailers Association, the Associated General Contractors, and the statewide and Los Angeles County Division, League of California Cities, as well as major oil companies.

In urging the Governor to sign the bill, Los Angeles Mayor Samuel W. Yorty said:

"We must face up to the public nature of transportation and recognize that an adequate system requires the support of the entire community which will, in turn, reap the

benefits of less congestion, reduced pollution and alternative means of travel."

Among those in County government favoring the new revenue source for transit was Supervisor Ernest E. Debs, who declared;

"The members of the Legislature have properly recognized the need for public fund support for transit. It is a fact that the major cause of air pollution is the automobile. For this, among other reasons, there is sufficient cause to tax gas in order to provide improved public transportation with resulting environmental benefits."

The business community's viewpoint was expressed, by among others, Philip E. Walsh, president of the Los Angeles Area Chamber of Commerce, who told Governor Reagan:

"... we are pressing for the measure in order to assure the continuance of the present Southern California bus system, improvement programs, and supply new capital for the development of an area-wide rapid transit system.

"... we see SB 325 as necessary, and long overdue, towards furnishing the funds to provide truly balanced transportation for people and goods throughout the area."

In Los Angeles County, the availability of funds will benefit RTD and municipally-owned bus lines in Commerce, Culver City, Gardena, Long Beach, Montebello, Pomona, Santa Monica and Torrance.

The District will be able to continue its ongoing transit improvement and expansive program, as well as its innovative projects, such as the El Monte-Los Angeles Busway, an effort now being implemented.

In including gasoline as among the items subject to the general sales tax, the Legislature changed the formula for allocating the 5 per cent sales tax.

Henceforth, the state will receive 3¾ per cent of all receipts. Counties will receive 1¼ per cent of the funds to be used for transit.





the tax on gasoline). The local 1% share of the total 5% sales tax remains the same. The ½% taken from the State share is made available at the local level for transportation. This ¼% of the general sales tax is what we will be calling upon annually. In sumsary, the California general sales tax now will look like this statewide:

334% to the State

1% to cities and
counties for
general fund

1/4% to transit in
urban counties
and roads in
rural counties

5 % Total

With the passage of this Act, we have an even greater-commitment to provide improved public transportation service. We have always operated under careful financial scrutiny; however, this new tax money brings with it even more demanding and stringent controls. Of course, as taxpayers ourselves we can all agree this is as it should be.

All claims for tax funds under SB 325 must first be approved by the regional planning agency. The Bill further provides that at least 75% of all money claimed normally must be for capital expenditure items such as buses, equipment and facilities. Clearly, the challenge remains — we must spend our money in a wise and prudent manner.

In closing, let me say that as an employee of the District you can take great pride in the stature our agency gained by the passage of Senate Bill 325 and the recognition by the community of a job well done.
