# RTD To Integrate Pomona Valley Transit System Into District

Pomona's municipally-owned bus line will be integrated into RTD's system commencing October 1.

"Acquisition of the Pomona Valley Municipal Transit System is consistent with the District's charge to improve bus service in the area," said Leonard S. Gleckman, member of the RTD Board of Directors representing the Pomona area.

Mayor Richard Brownell of Pomona stated:

"I am extremely pleased that RTD has consented to assist us with our transportation problems. With their wide public transit experience, I am sure they will be able to do an effective job in our area."

Four lines will provide comprehensive city service, with a fifth line providing Sunday service to Chino Correctional Institute, explained Jack R. Gilstrap, RTD general manager. The lines will connect with RTD routes to adjacent cities, including metropolitan Los Angeles.

#### **Thousands Tour RTD Bus Displayed At Los** Angeles County Fair

The District has spotted one of its latest model 7100 Class buses at the Los Angeles County Fair in Pomona. Passengers and prospective passengers are getting a first hand look at the type of new equipment the District is buying to replace older vehicles.

Bus #7136 is equipped with air-conditioning, two way radio and color coordinated interior. Passengers have more leg room and the seats are more comfortable. Fluorescent lighting inside cuts down on eye glare.

Inside 7136 are renderings of the El Monte-Los Angeles Express Busway, the El Monte Busway Terminal (now under construction behind Division 9) and photographs of the District's downtown Mini-bus operation.

Cook, who will represent the Northwest Corridor cities of Burbank, Glendale, Hidden Hills and San Fernando on the Transit District Board, was chosen by members of the City Selection Committee during the monthly meeting of the League of California Cities, Los Angeles County Division. He succeeds Charles E. Compton.

# **Construction Begins** On RTD's El Monte **Busway Station**

A San Gabriel Valley ceremony September 11 marked the commencement of construction on the nation's first bus terminal built exclusively for a mass rapid transit opera-

The \$945,000 El Monte Station will serve as the easterly terminal for the El Monte-Los Angeles Busway, the 11-mile, high-speed, grade-separated transit facility now under construction.

Representatives of area cities, the county, the state and the federal government joined RTD officials for the ceremony.

RTD Vice President Thomas G. Neusom; Leonard S. Gleckman, who represents Northeast Corridor cities as a Transit District director, and the agency's general manager, Jack R. Gilstrap, described the project for those assembled at the station site near Santa Anita Avenue and Ramona Boulevard. Also participating was Director Herbert H. Krauch. The location is adjacent to RTD's El Monte Division.

District officials said that the Busway — and its ultramodern station facilities will prove to be an initial step in the renaissance in public transportation for Los Angeles County.

The distinctive design of the station, it was noted, is fully in keeping with the progressive outlook and spirit of the City of El Monte.

District officials explained that the new station is designed to speed bus movement, as well as passenger flow.

The passenger waiting area will be centrally located in an air conditioned rotunda, where all bus arrivals and departures will be readily observable.

When completed in the Spring of 1973, the terminal will have a parking capacity of 700 cars with a second parking facility scheduled for 1974, providing a total parking capacity of 1400 cars.

# Steam Bus Makes Debut In L.A.

Marking introduction of the bus into Los Angeles area passenger service in early September are (from left) Herbert H. Testing of the steam engine by the State has shown a dramatic reduction in emissions of hydrocarbons and nitric oxides, as well as a greatly diminished noise level. A grant to the California Assembly by the Urban Mass Transportation Administration of the Federal Department of Transportation made funding of the project possible.

Others participating include a joint venture of Kaiser Engineers/Daniel, Mann, Johnson & Mendenhall, planning and engineering; a joint venture of Wallace, McHarg, Roberts & Todd/Kennard & Silvers, environmental impact; Alan M. Voorhees & Associates, patronage and revenue; and Stone & Youngberg, financing.

A \$400,000 grant to complete the project was approved recently by the Urban Mass Transportation Administration with the Transit District providing an additional \$200,000.

Scheduled for completion in eight months, the analysis is being undertaken in coordination with the City and the County, explained Jack R. Gilstrap, RTD general manager.

Gilstrap said the following information will be provided when the project is completed:

- —An analysis of the specific available transit financing resources at the local, state and federal level.
- —A description of the kind of rapid transit system most suitable for the area.
- —A determination as to where the rapid transit routes should be built and the priorities for completing construction.
- —The effect of rapid transit development on the citizenry.

Dr. Topping said the Transit District "is committed to an action program culminating in the creation of a major rapid transit system in the Los Angeles region."

RTD officials noted that the undertaking has been made possible by the availability — for the first time — of public fund support for transit on a continuing basis.

Removal of the sales tax exemption on gasoline, it was explained, has produced the monies which now make it possible for the community to qualify for federal matching funds to place rapid transit on the construction track.

Peat, Marwick, Mitchell & Company's function in project control and systems management will include the refinement and coordination of the work programs of the technical consultants. In addition, the firm is responsible for the scheduling and monitoring of all elements of the effort.

Kaiser Engineers/Daniel,
Mann, Johnson & Mendenhall has primary responsibility for the overall technical
work including an analysis of
the several major transportation corridors in the region in
order to permit a determination of the priorities for construction in each. These two
firms, Gilstrap noted, will also
recommend the system
technology for the ultimate
regional transit system,
including a determination as to

the suitability of using existing railroad rights-of-way for interim commuter service.

The patronage and revenue consultant — Alan M. Voorhees & Associates — will be responsible for the preparation of patronage and revenue estimates for the potential transit corridors.

Once the corridors for detailed study are selected, estimates will be prepared and the impact on the existing bus system will be investigated.

The environmental consultant — Wallace, McHarg, Roberts & Todd/Kennard & Silvers — will be responsible for examining the impact on both the natural and socioeconomic environments of the construction of a transit system in the corridors.

They also will assist in the preparation of criteria for the selection of both the corridors and the systems to serve them and will be responsible for providing the assurance that the system proposed will meet fully the environmental goals of both the local communities and the region as a whole.

Stone & Youngberg, as financing consultant, will investigate all feasible financing methods and will determine the level of funds that could be made available from them. Possible funding sources at all levels of government will be considered.

"Were it not for the information developed for the 1968 rapid transit proposal submitted area voters," said Gilstrap, "a much more exhaustive and expensive undertaking would be necessary at this time.

"The community is not just talking improved transit. We are involved in an action program intended to result in the construction of an initial element of a regional rapid transit network."

### District Board Votes Purchase Of 219 New Buses

Southern California Rapid Transit District directors have authorized the purchase of 219 new, ultramodern air conditioned buses for Los Angeles area public transit service.

Costing \$9,422,311, the new buses will be delivered in the spring of 1973 for use on the El Monte-Los Angeles Busway, now under construction, and to replace older transit vehicles now in service.

The buses are being purchased from the General Motors Corporation and the Flxible Company

arrive at the terminal daily, Gilstrap said.

The District also will build a new bus maintenance facility adjacent to the new terminal, providing speedy, modern and efficient maintenance services for transit vehicles operating on the Busway and on local feeder bus lines.

Being built at a cost of approximately \$53 million, the Busway is a joint undertaking of the Rapid Transit District, the Urban Mass Transportation Administration, the Federal Highway Administration, and the State of California's Division of Highways.

The new, high-speed transit operation will offer a truly competitive alternative to congestion in the areas of speed, comfort and convenience, transit officials noted.

The Busway will consist of in-bound and out-bound exclusive express lanes for high-speed bus travel along the San Bernardino Freeway between Mission Road in Los Angeles and the El Monte terminal at Santa Anita Avenue. For the most part, the lanes will occupy part of the Southern Pacific right-of-way.
