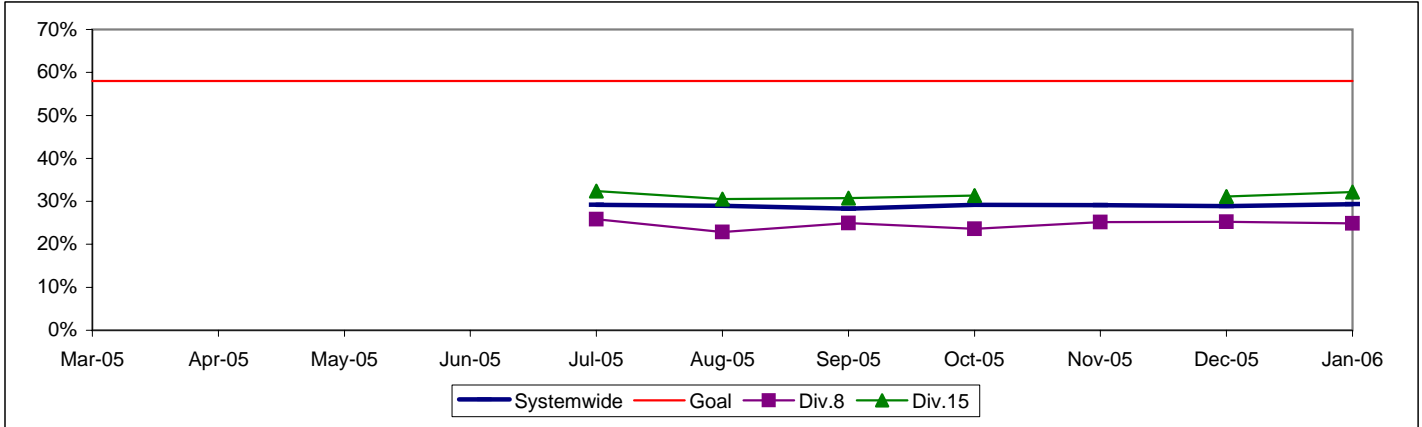

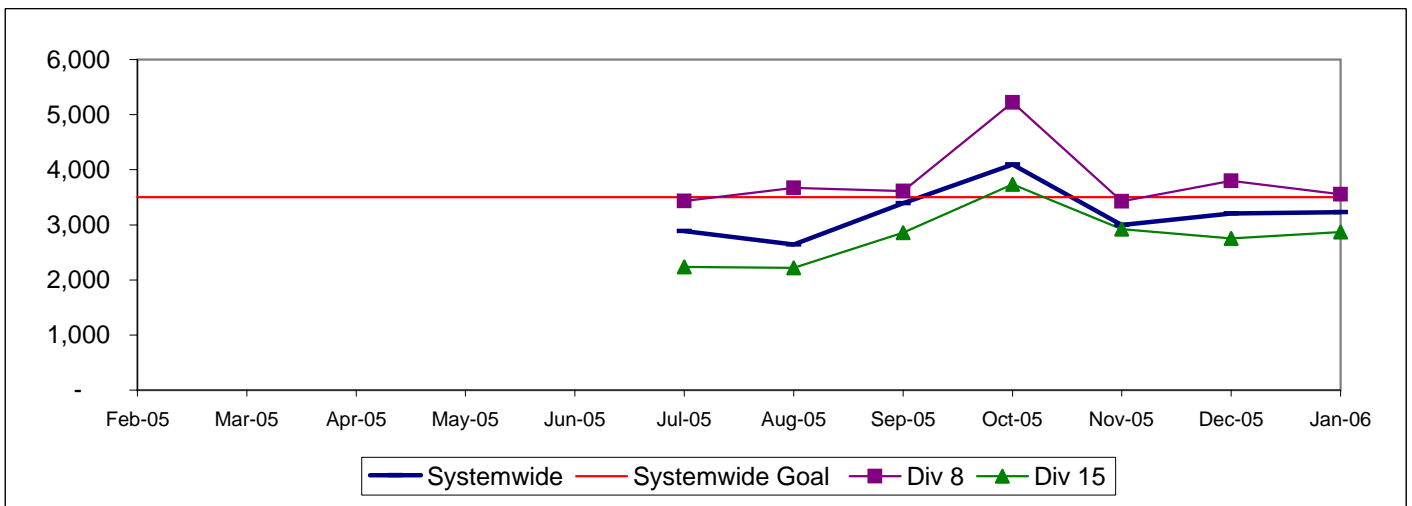

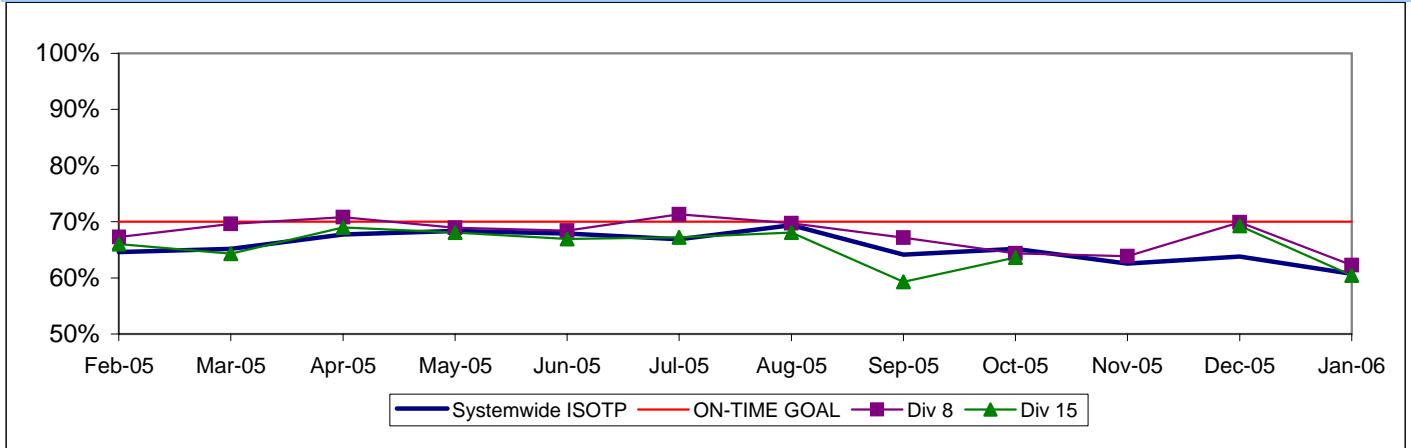

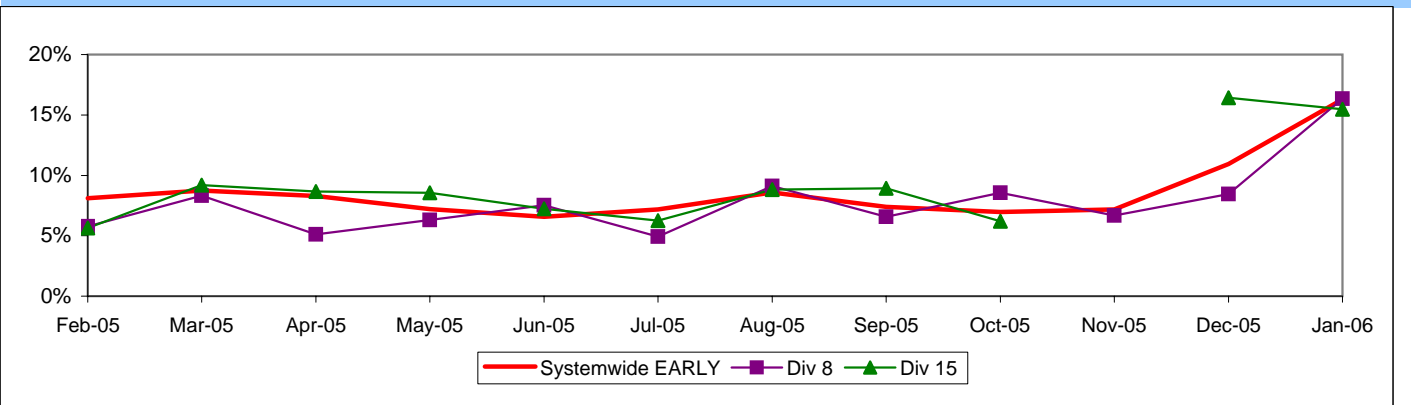

ISOTP - 1 Minute Tolerance for Running Hot**



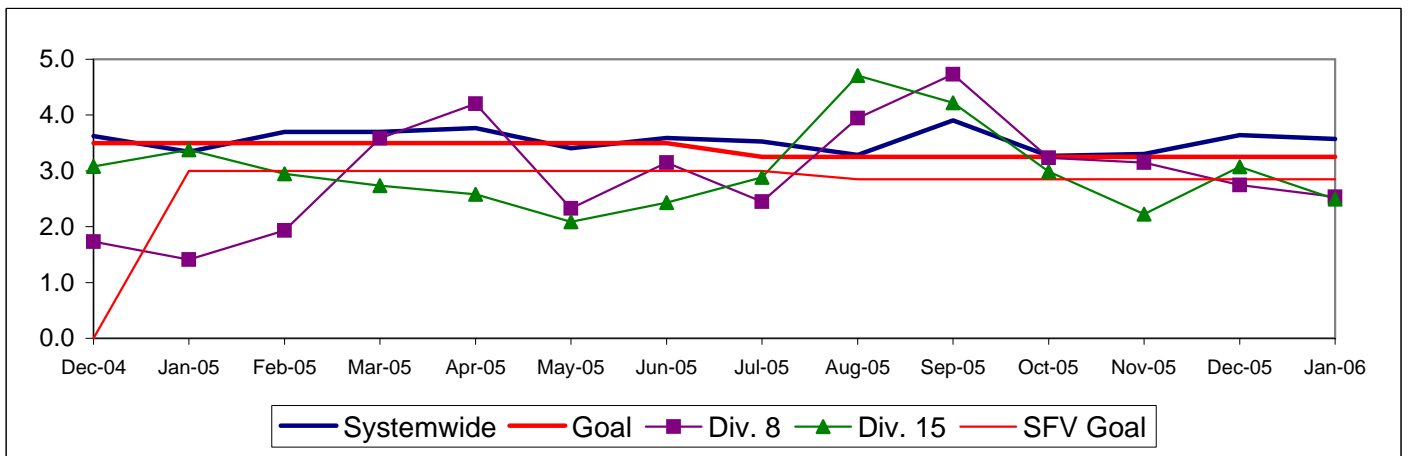

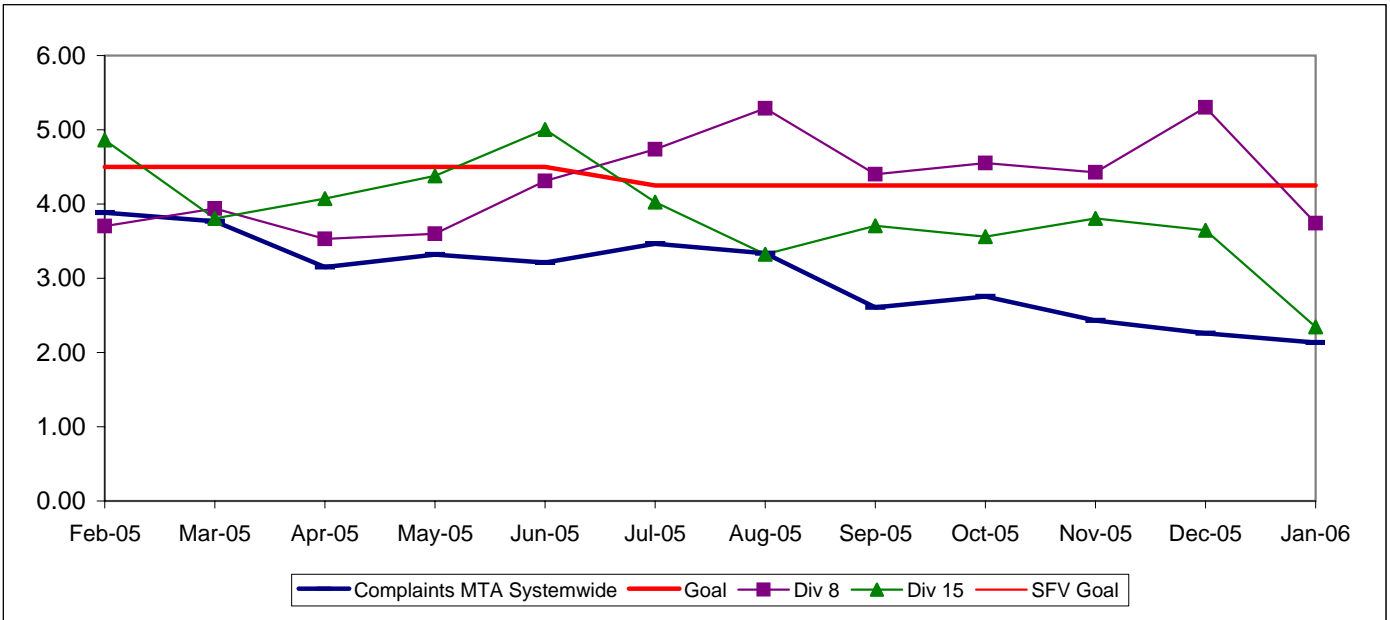

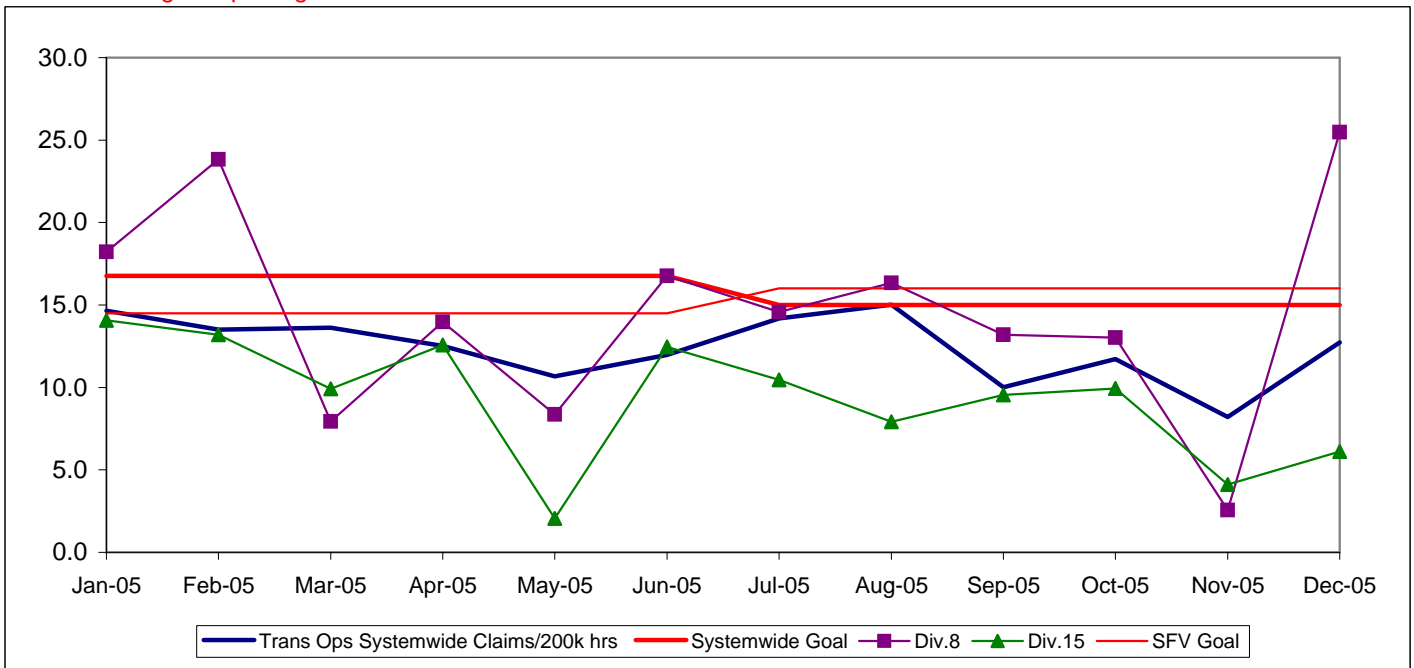

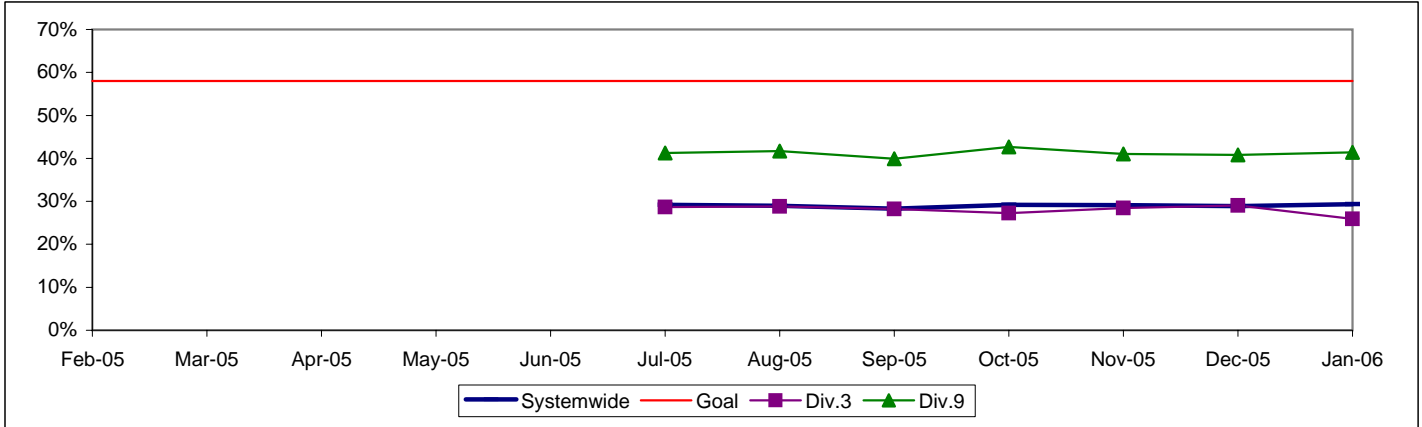

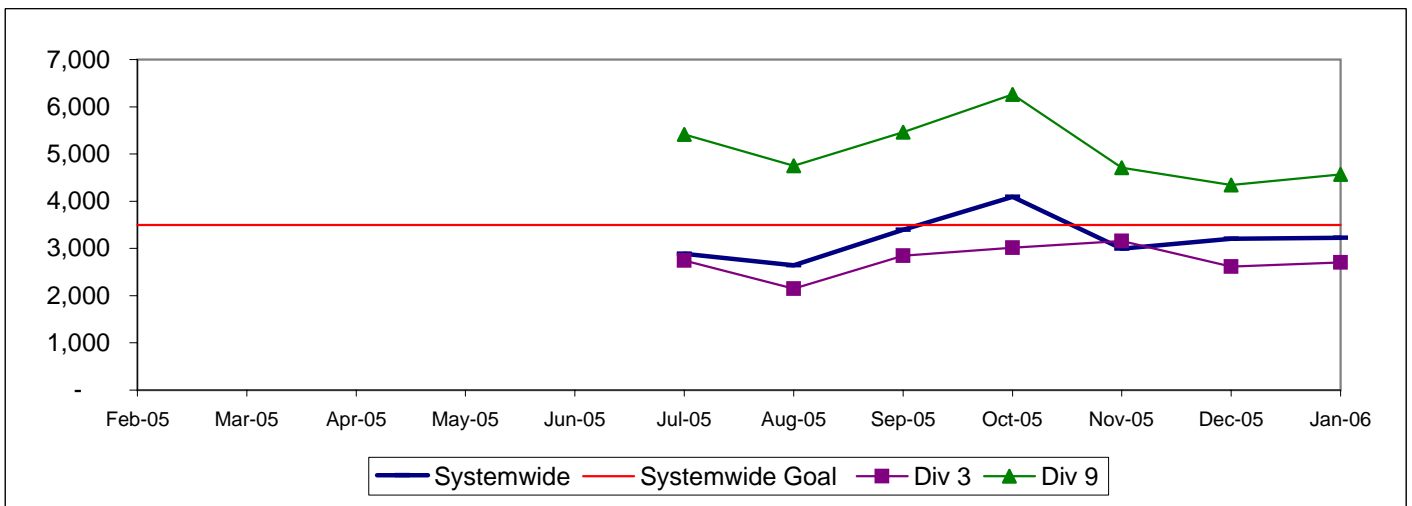

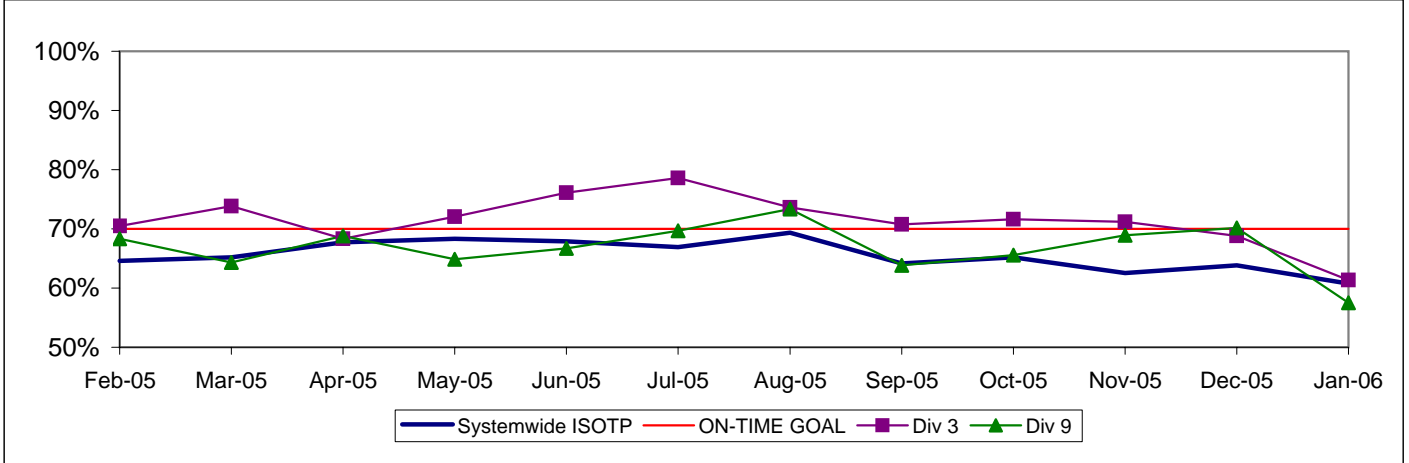

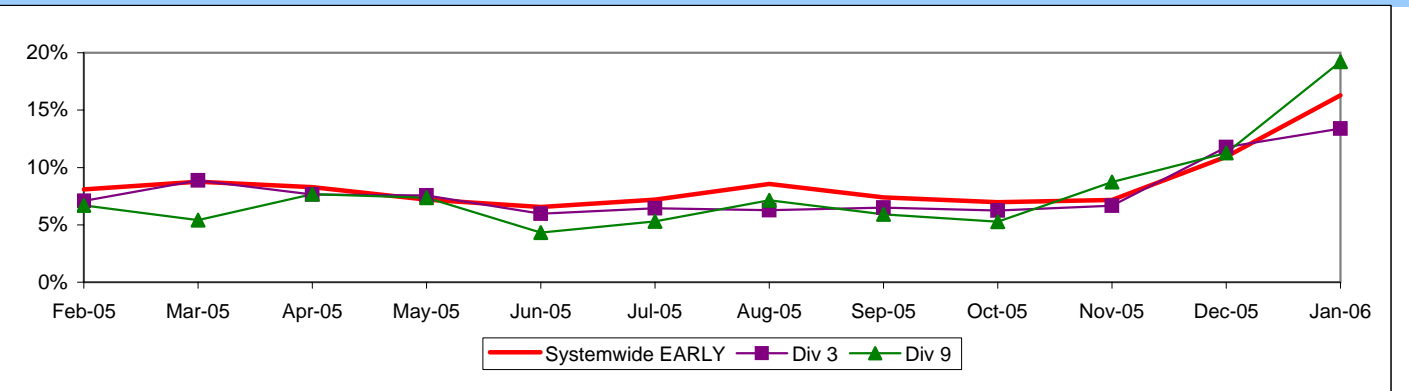

ISOTP - 1 Minute Tolerance for Running Hot**



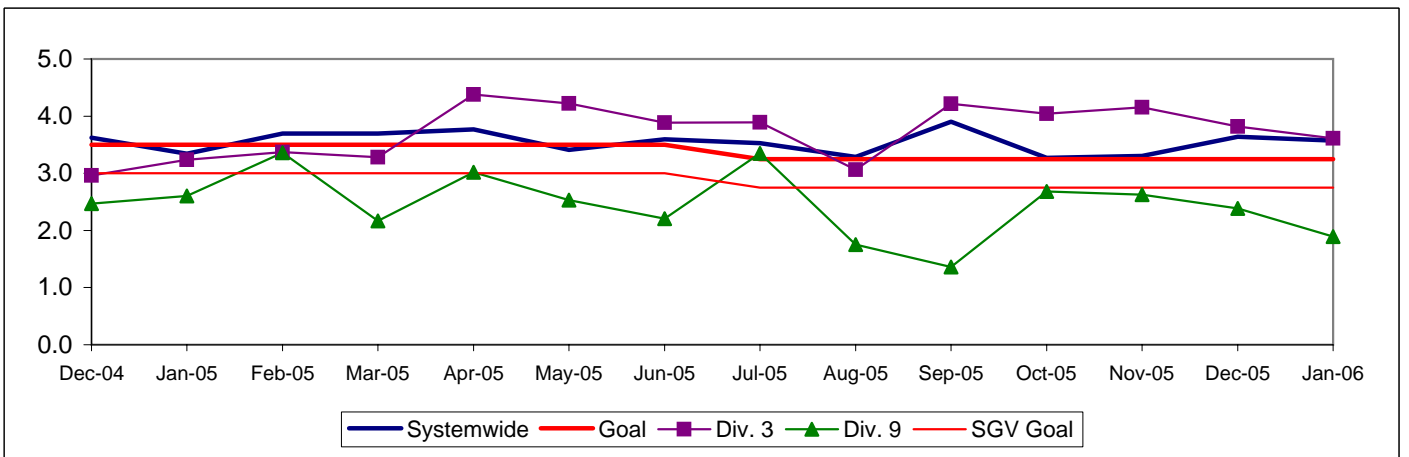

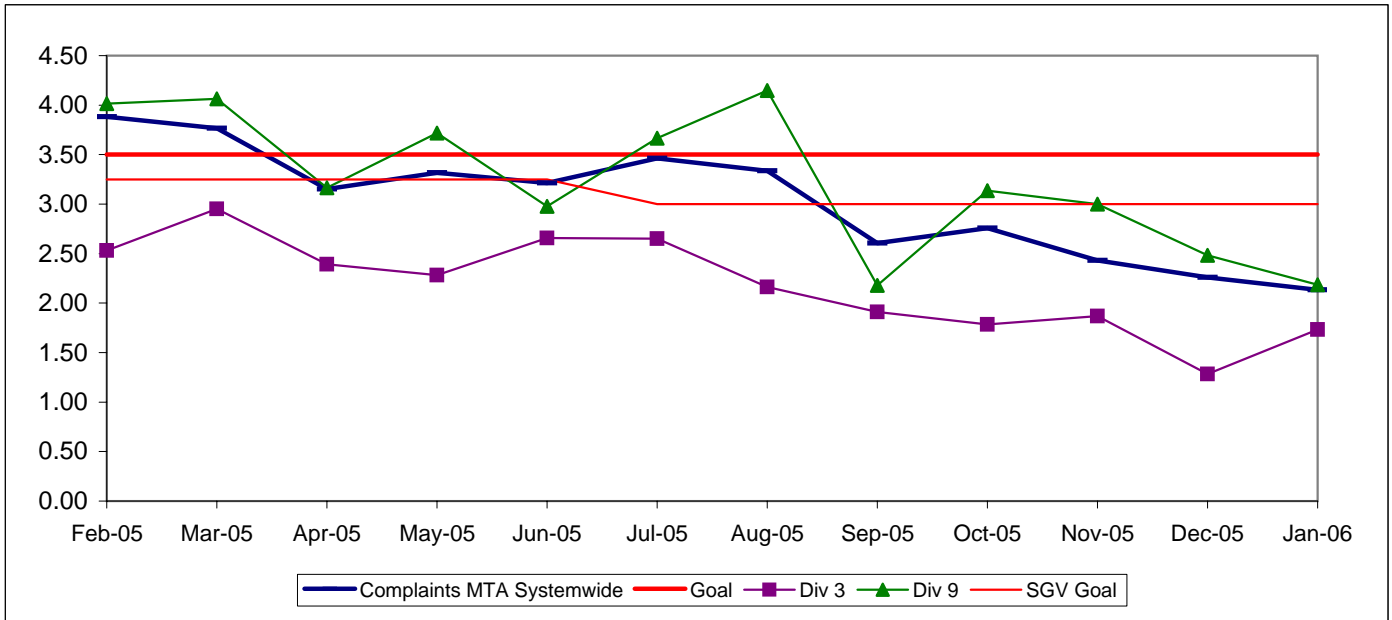

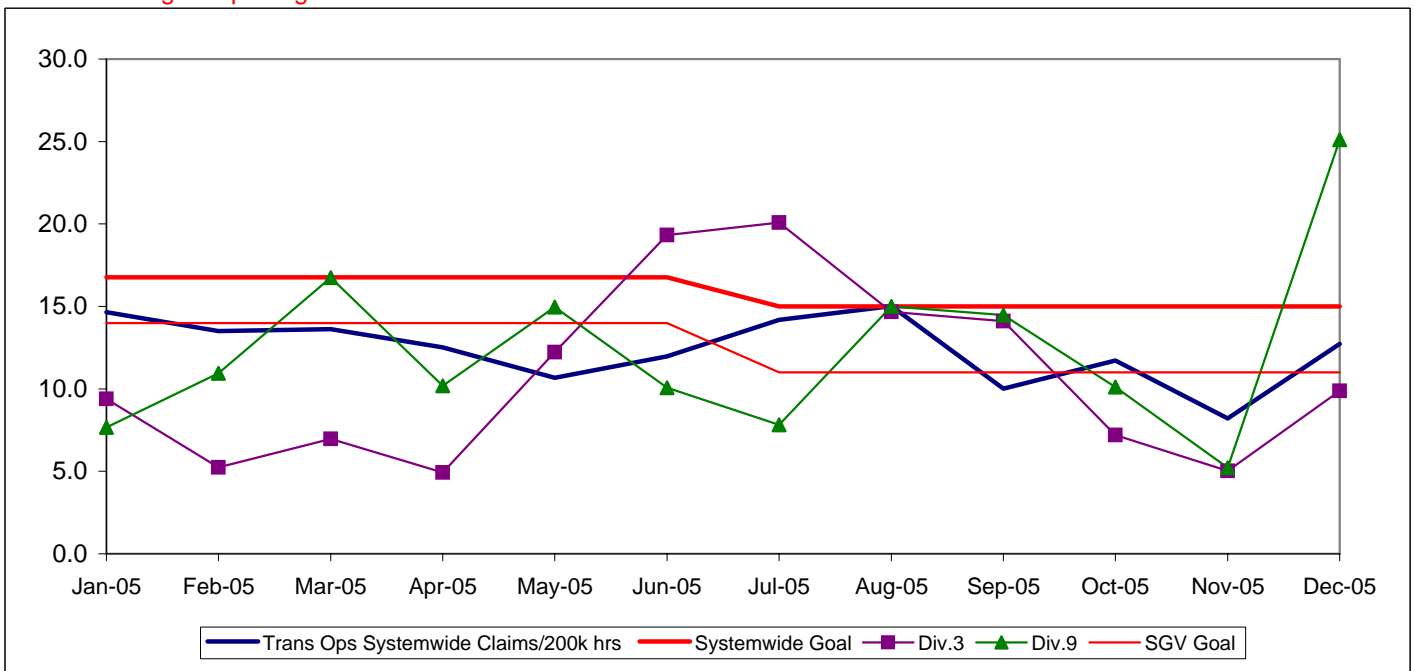

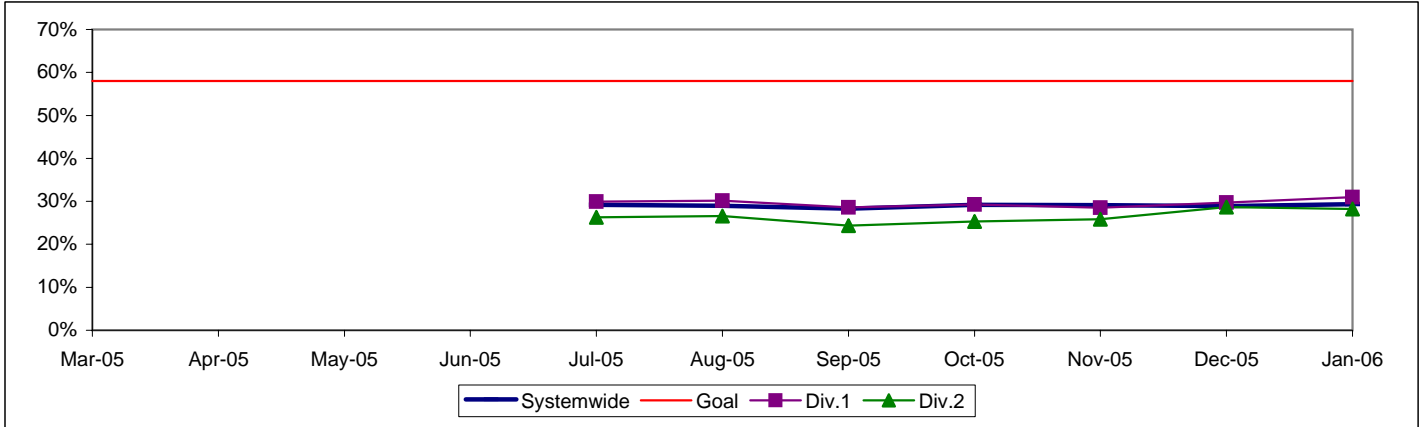

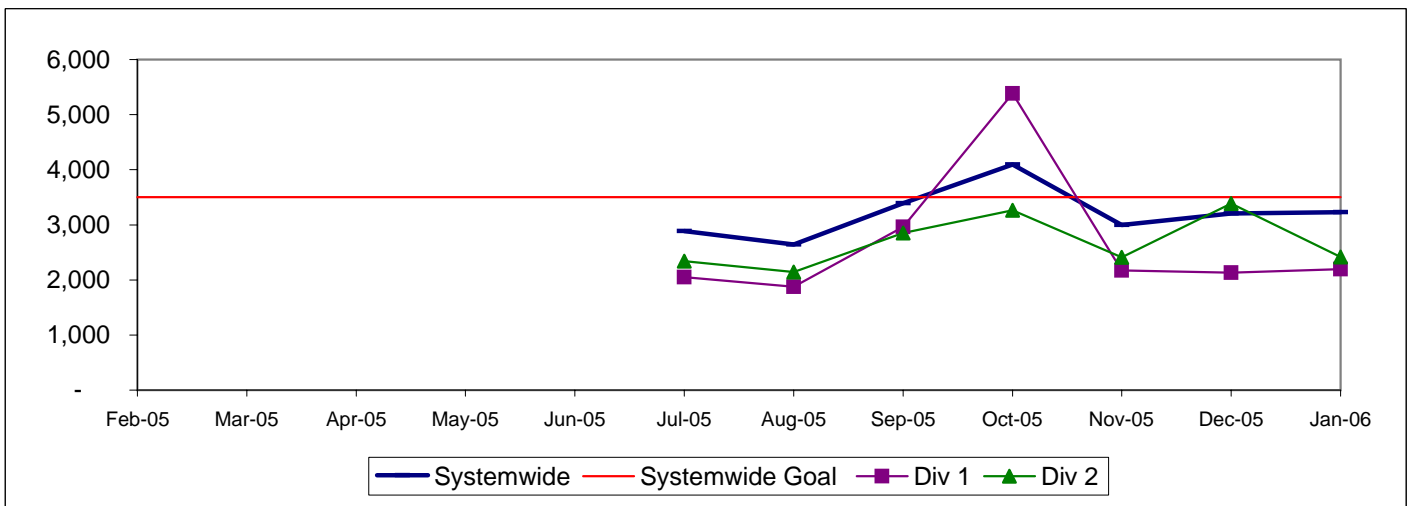

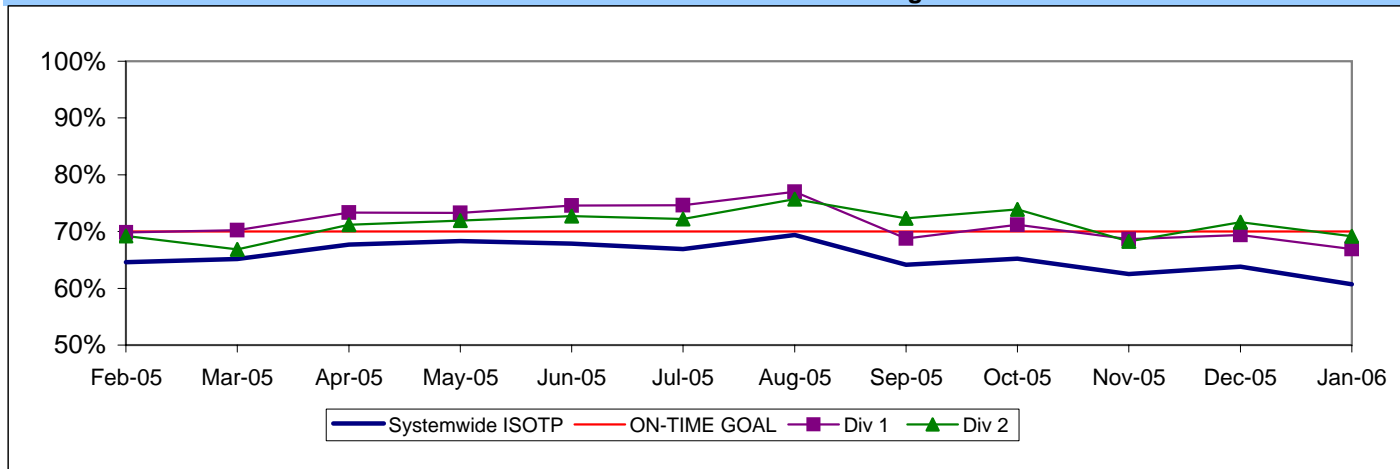

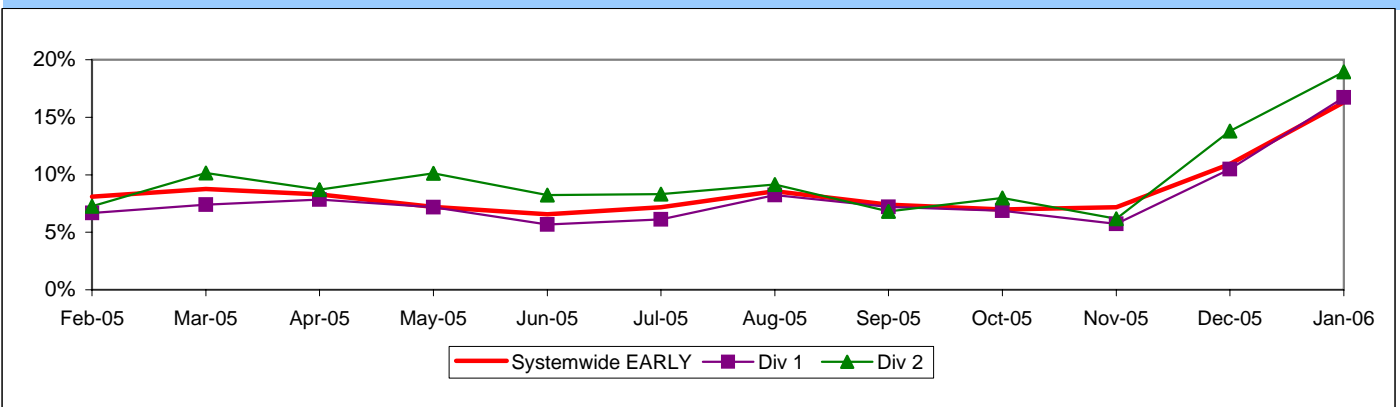

ISOTP - 1 Minute Tolerance for Running Hot**



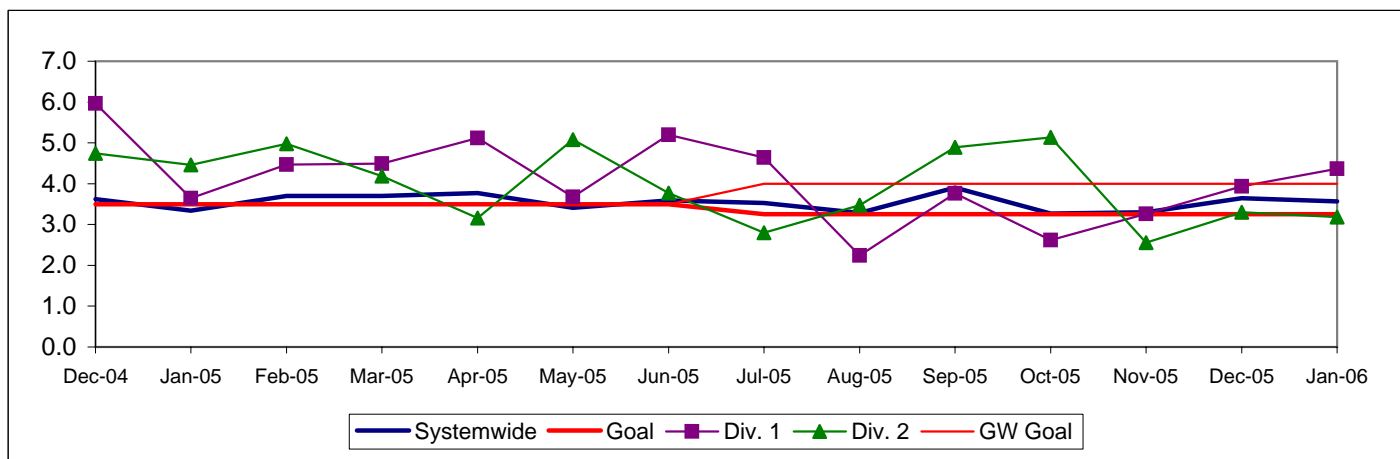

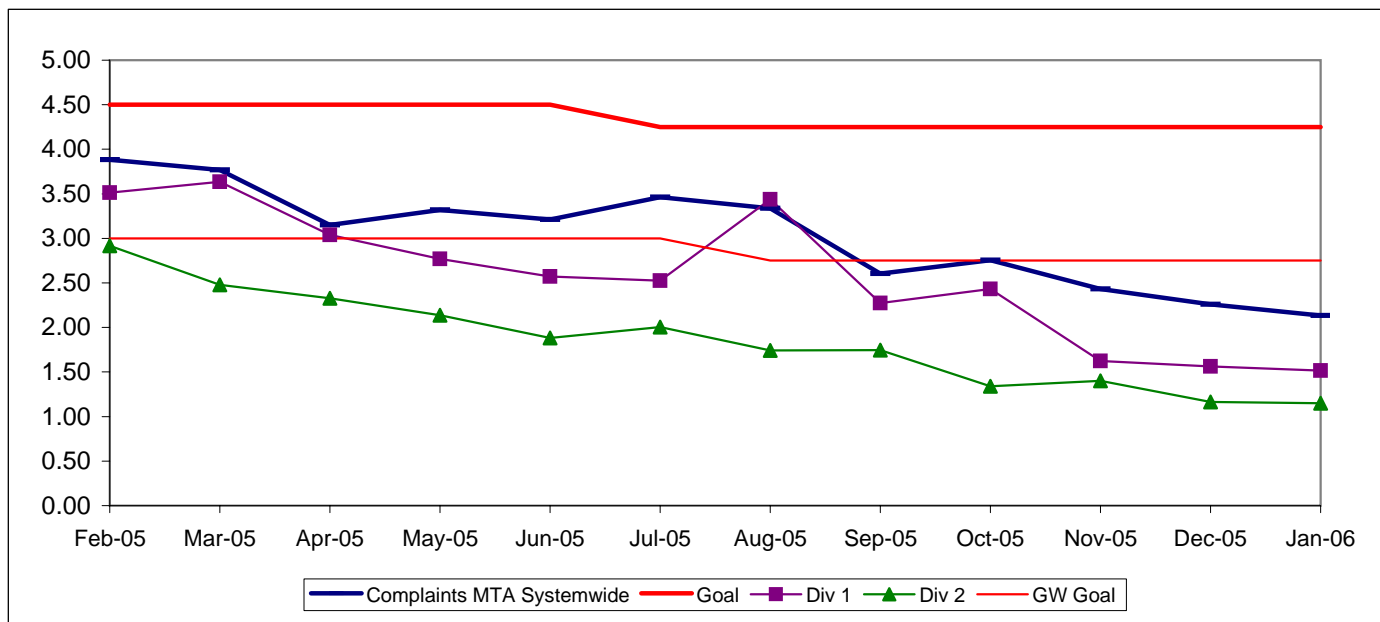

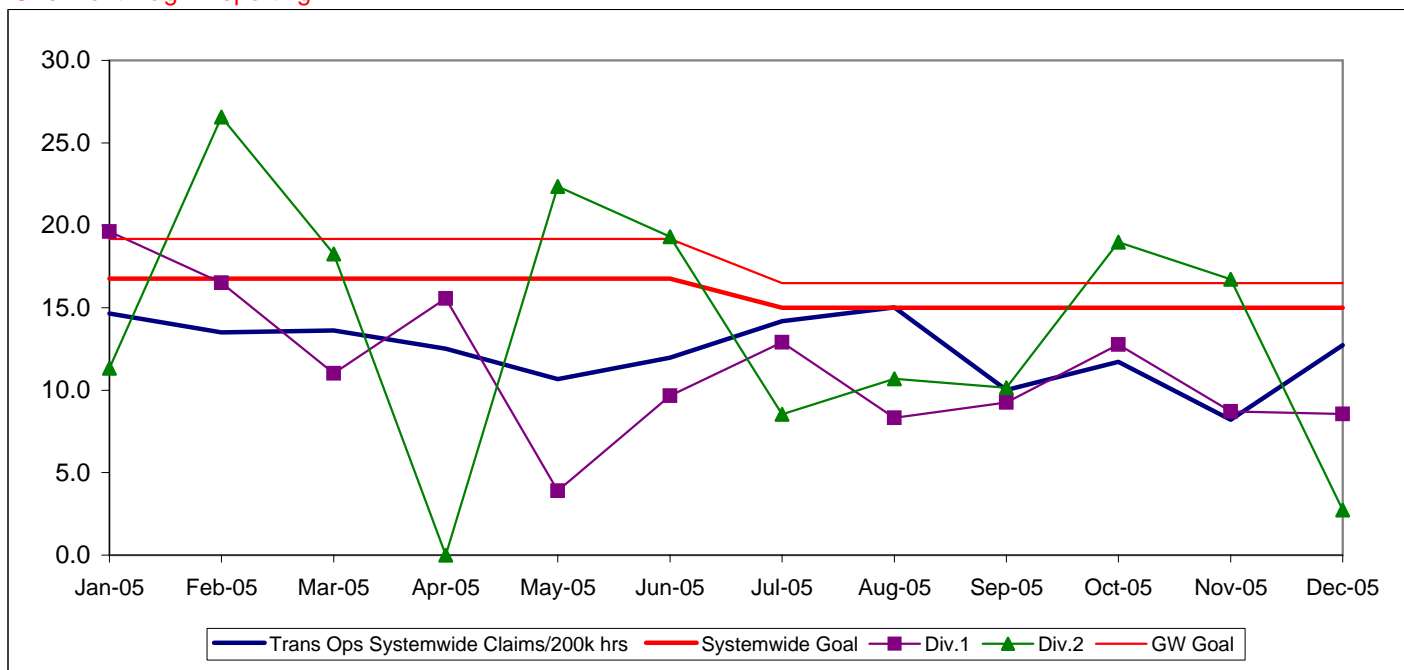

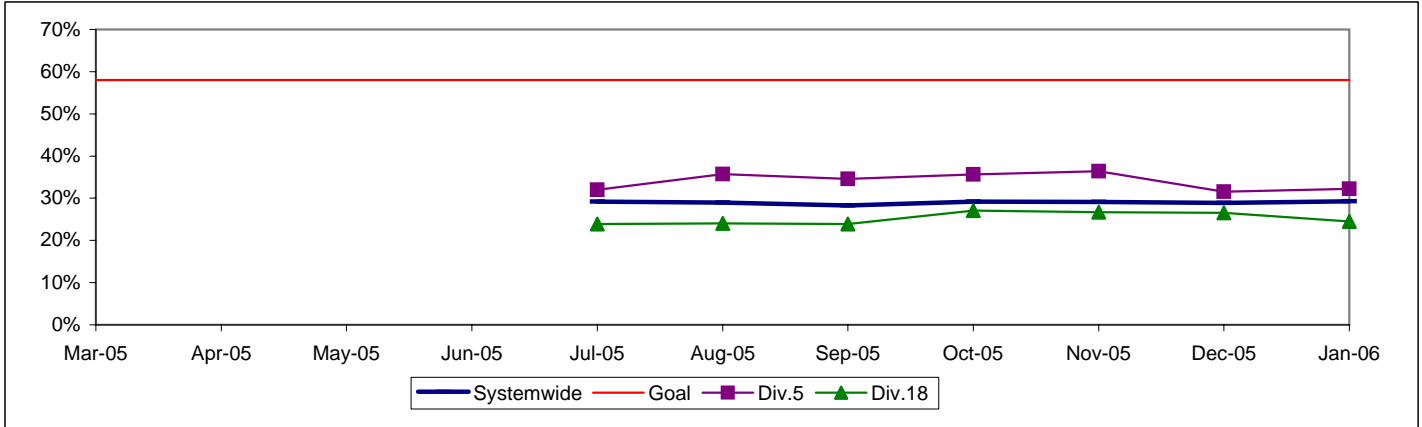

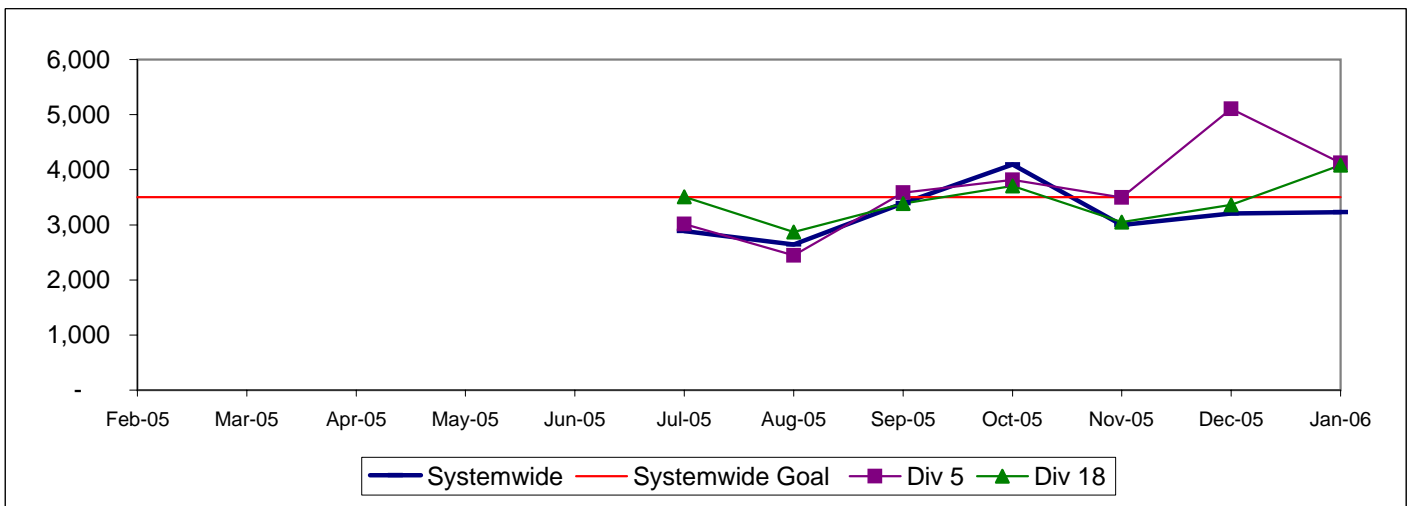

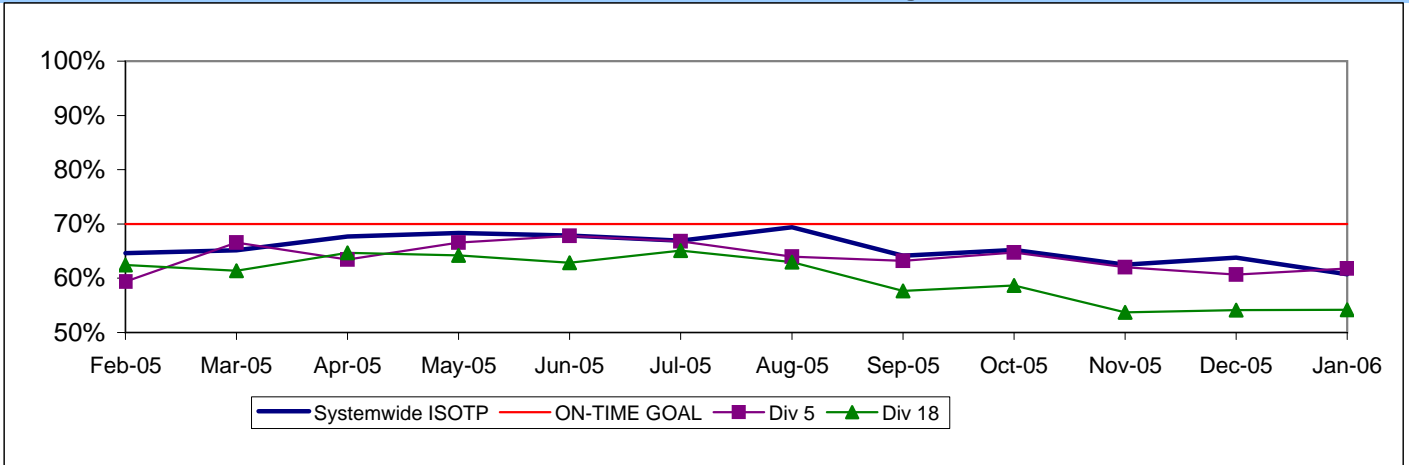

ISOTP - 1 Minute Tolerance for Running Hot**



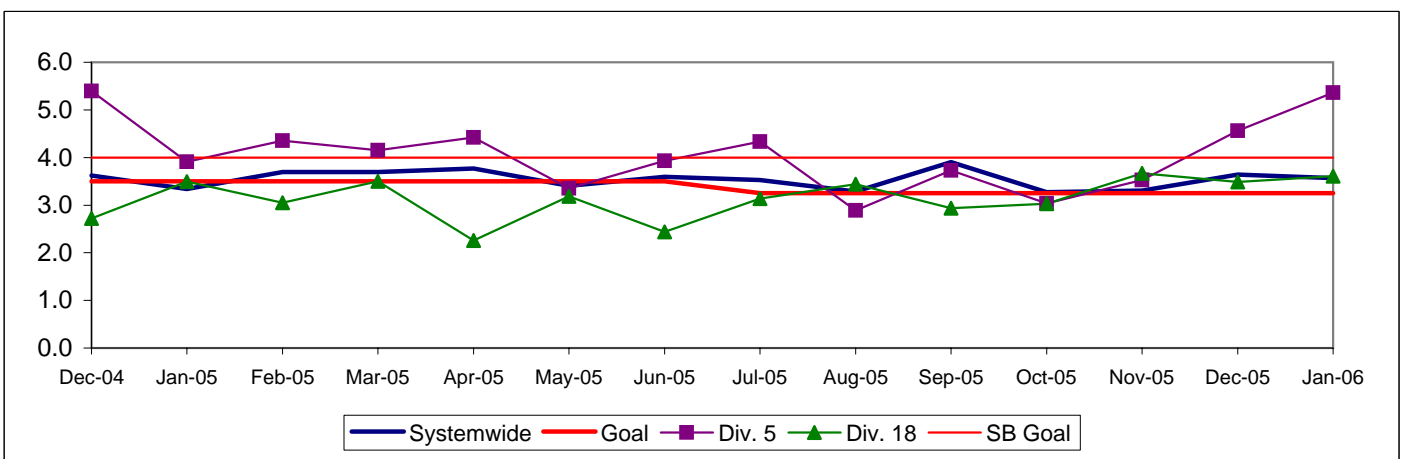

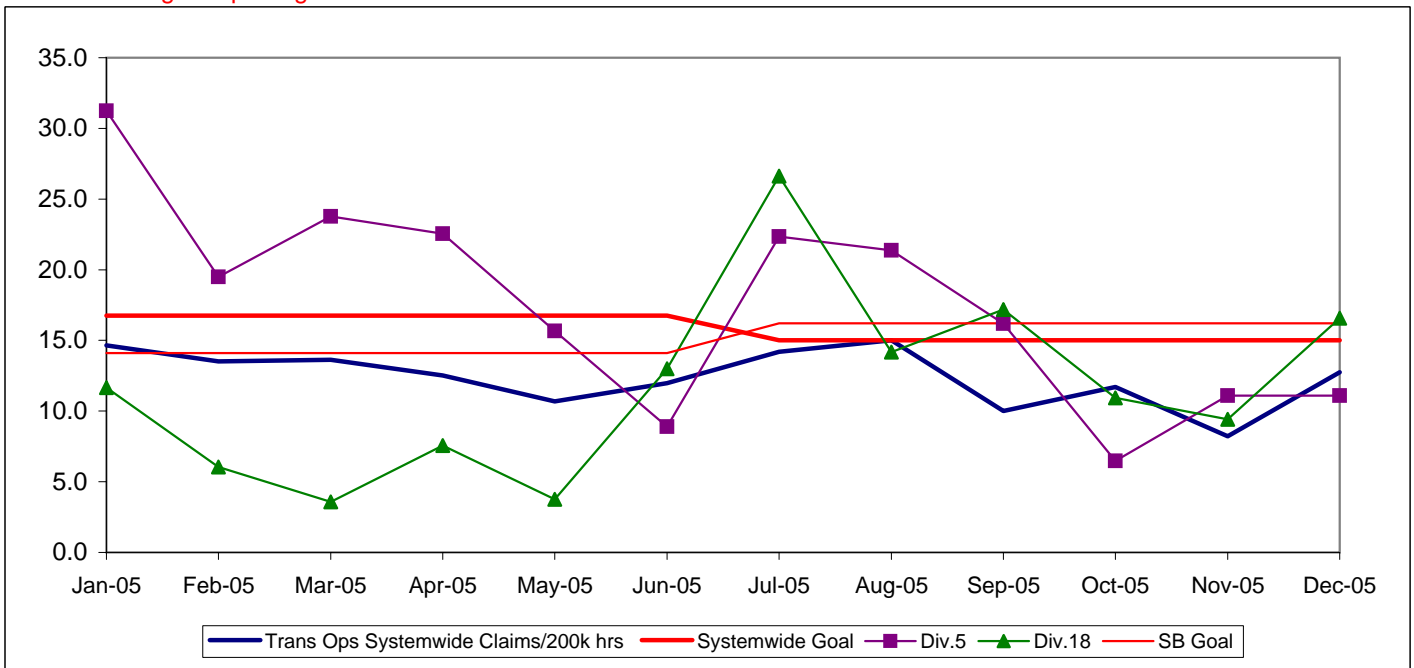

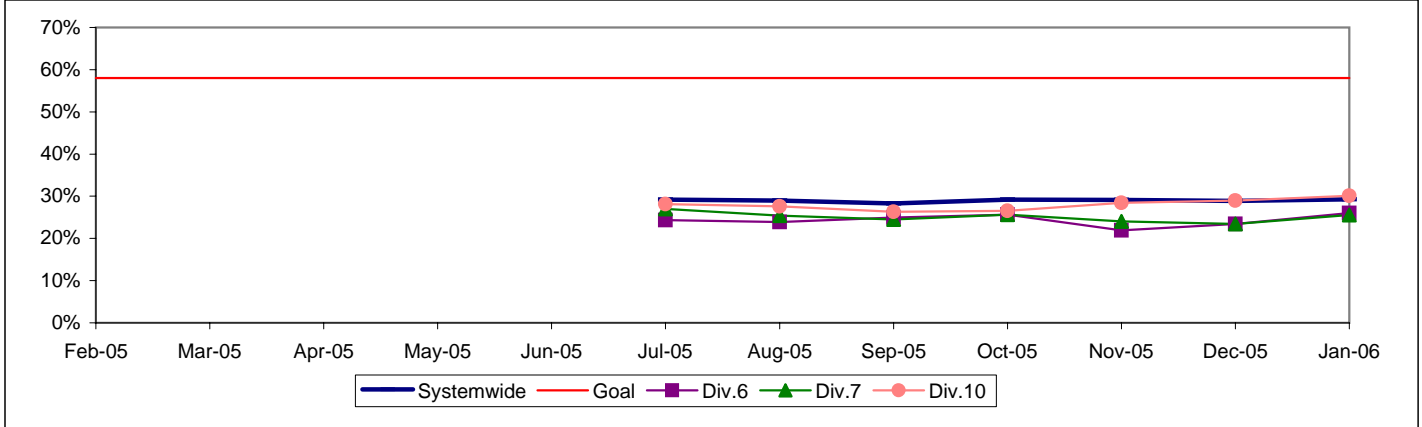

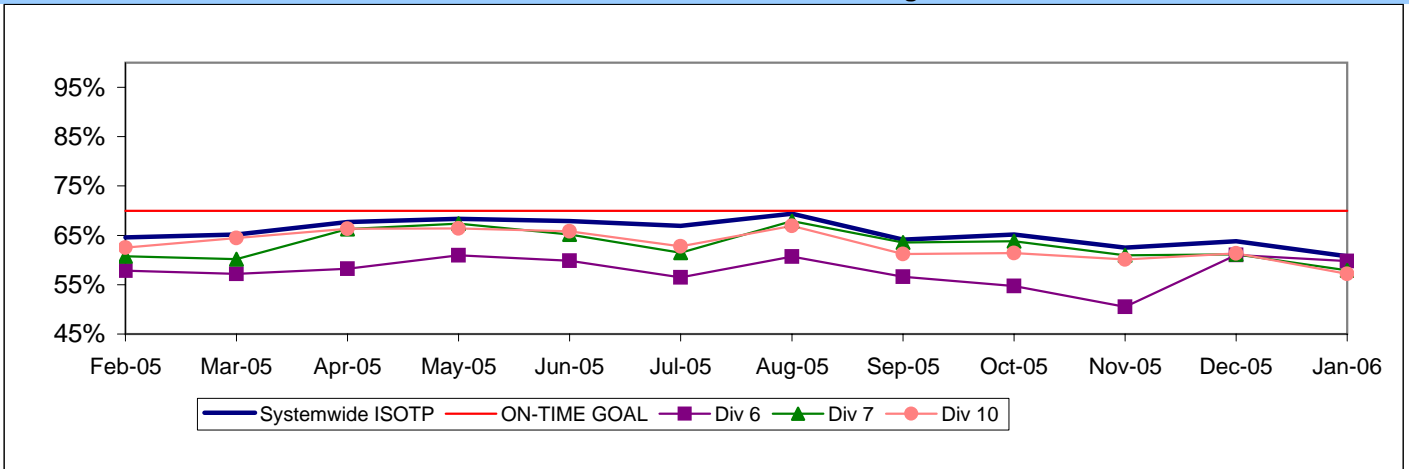

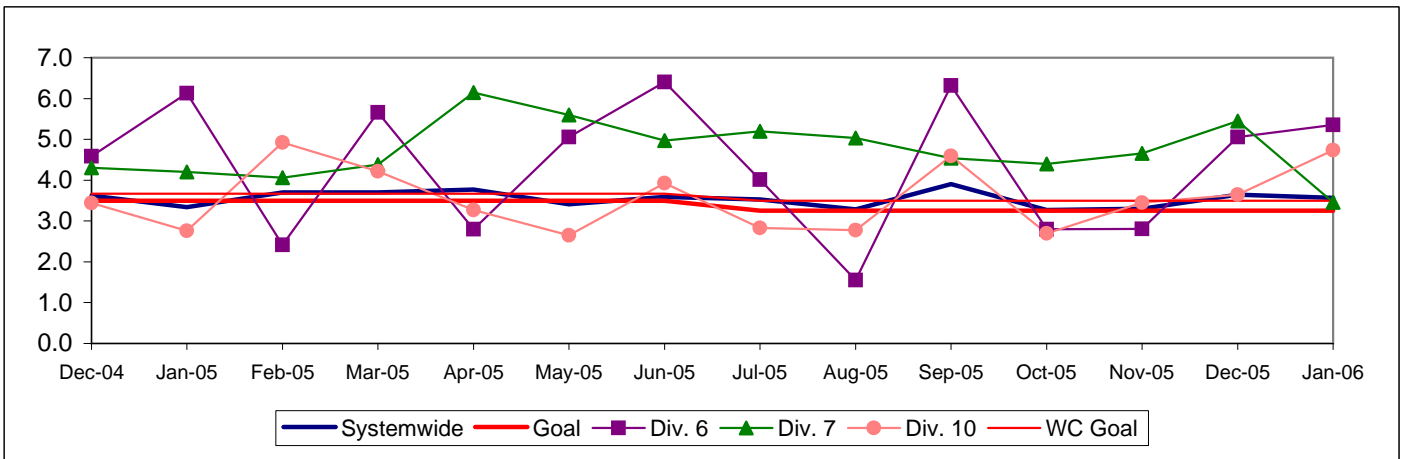

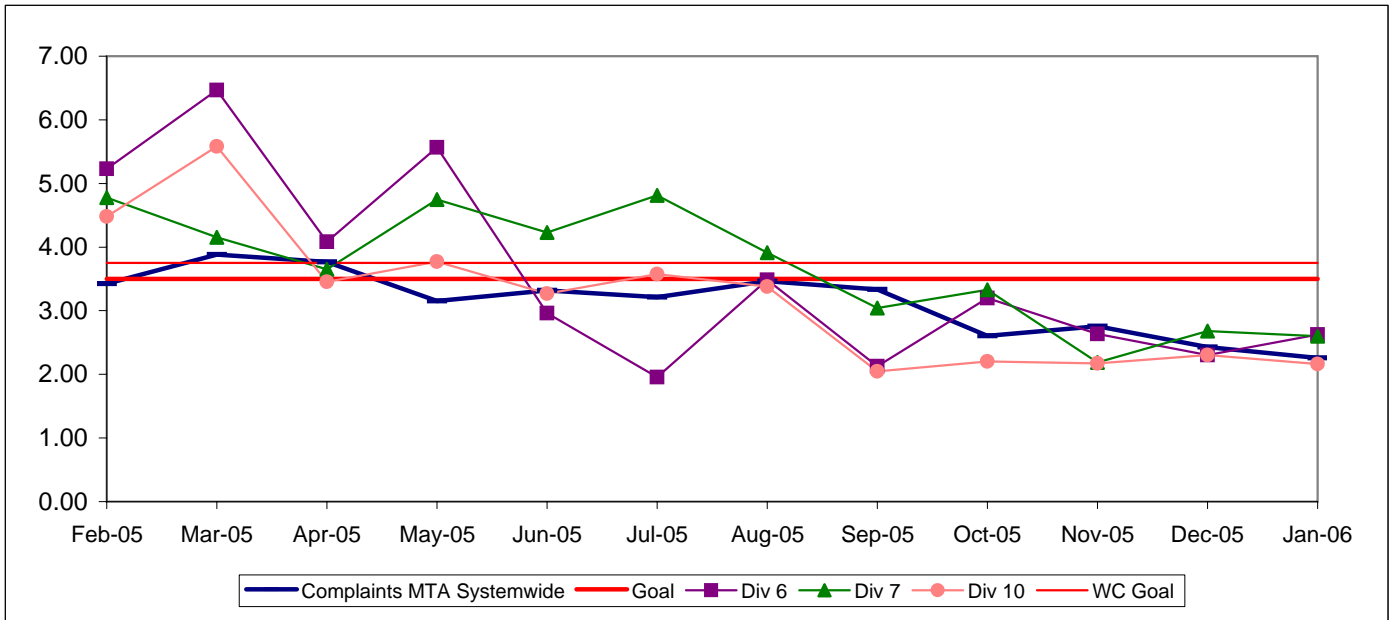

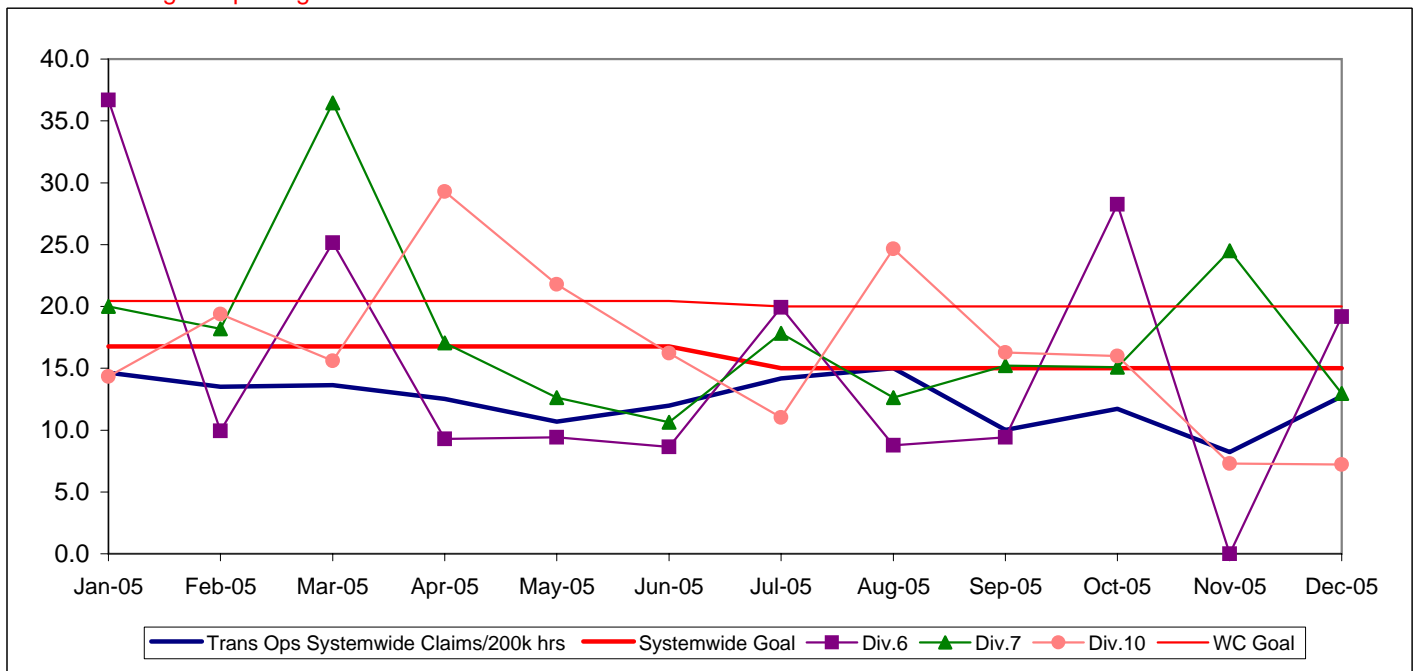

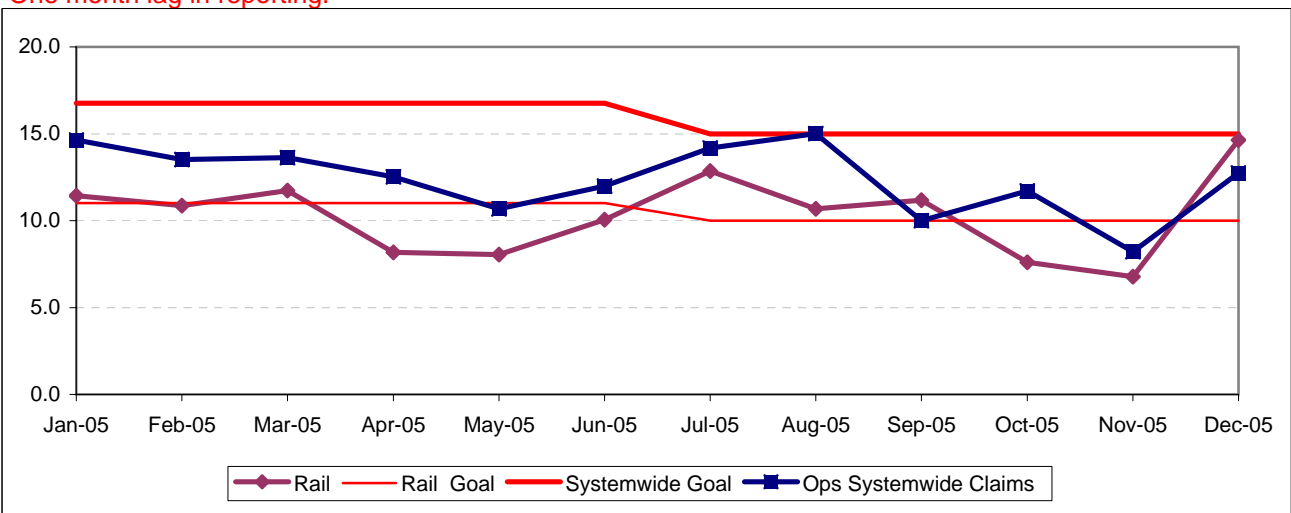

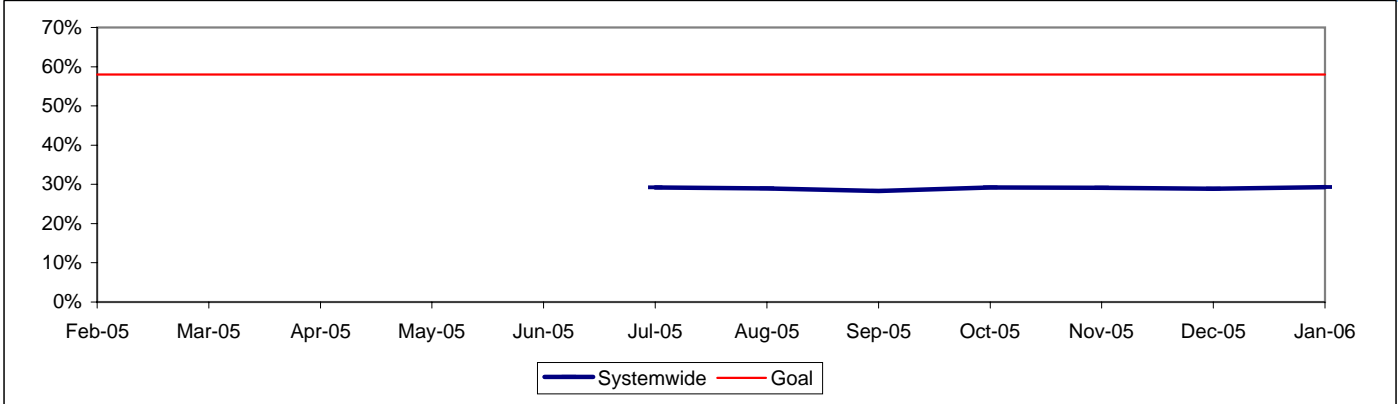

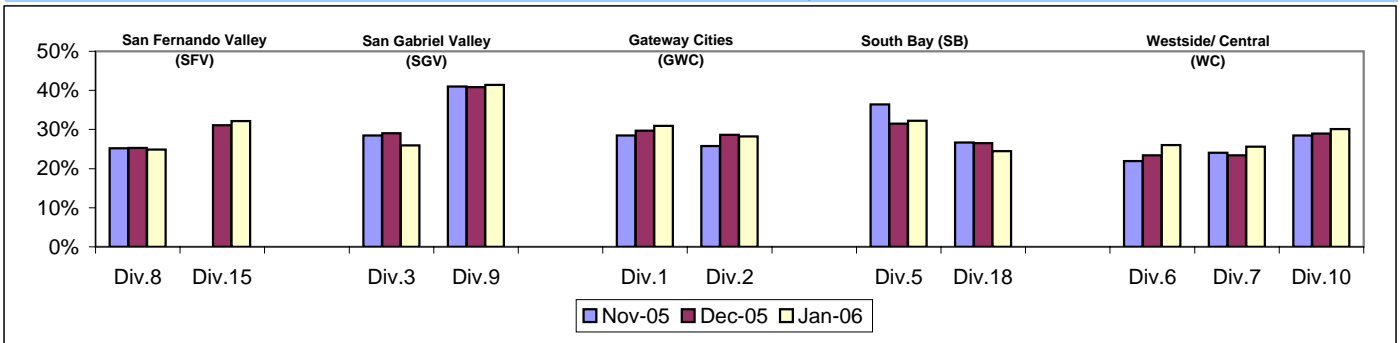

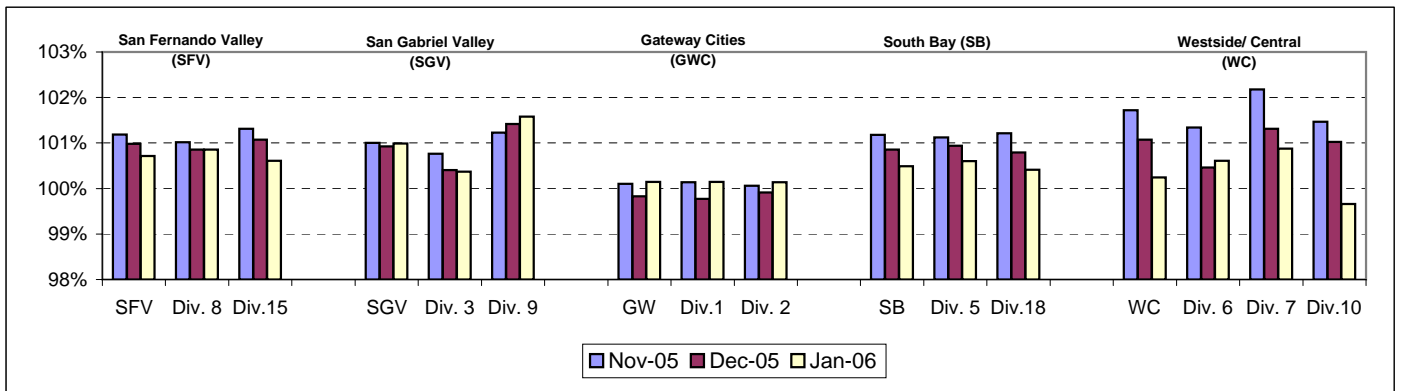

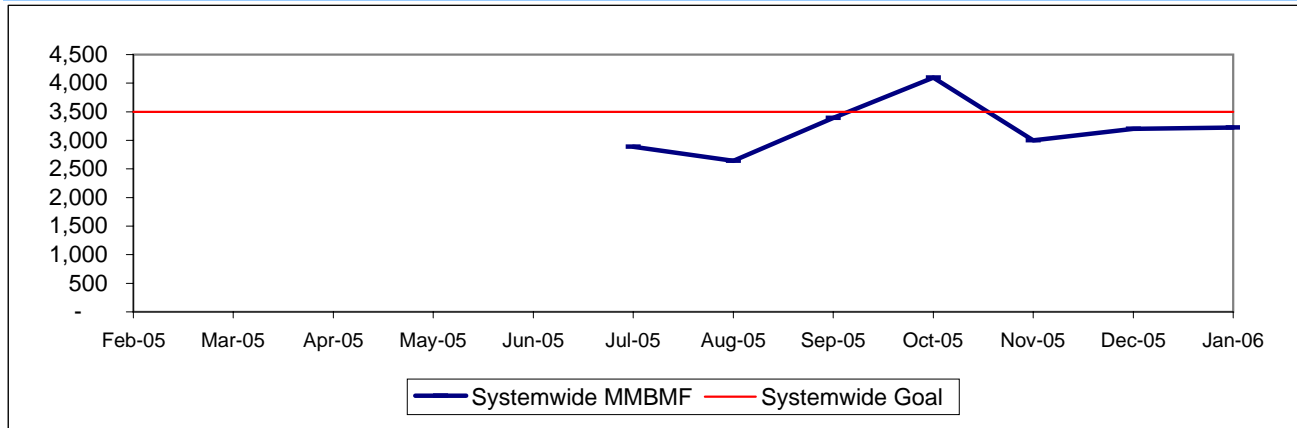

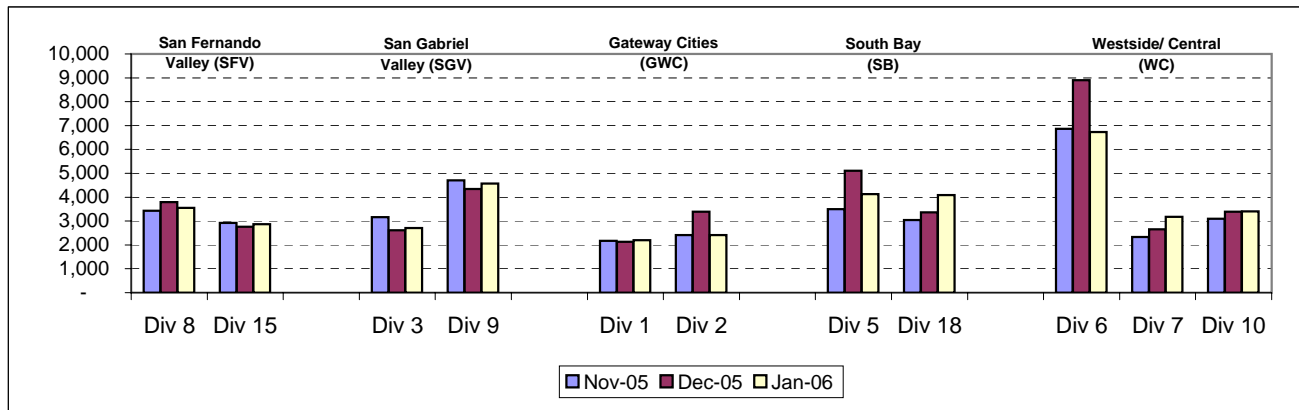

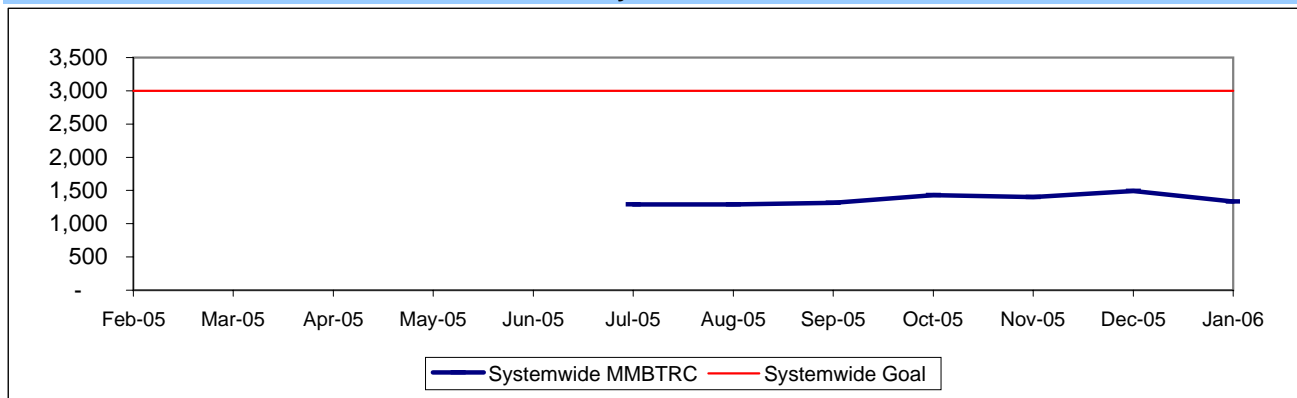

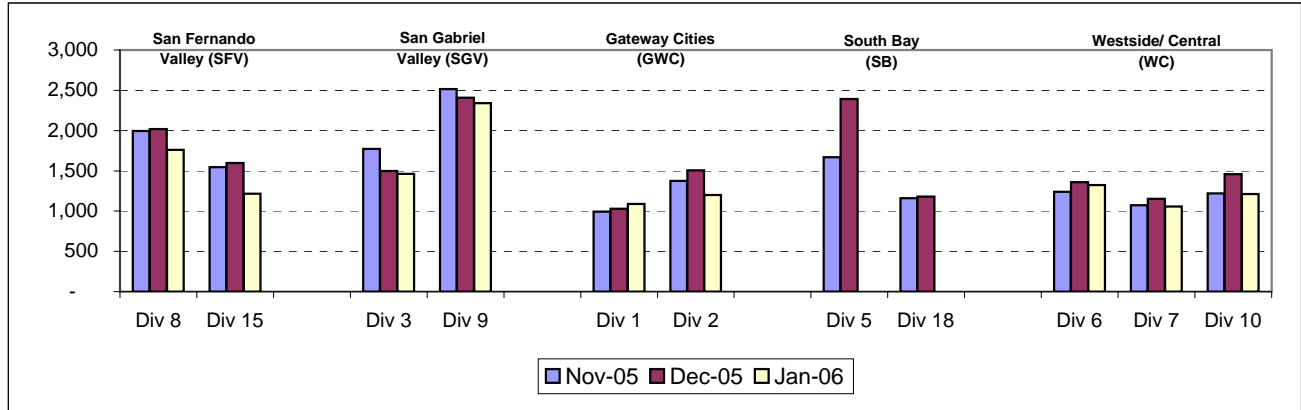

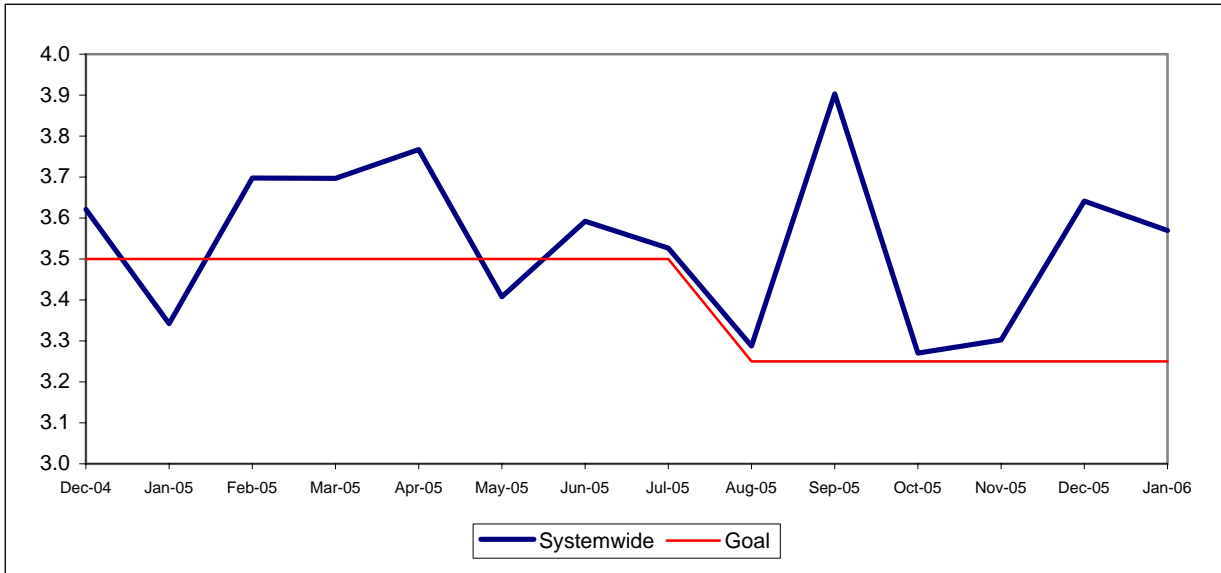

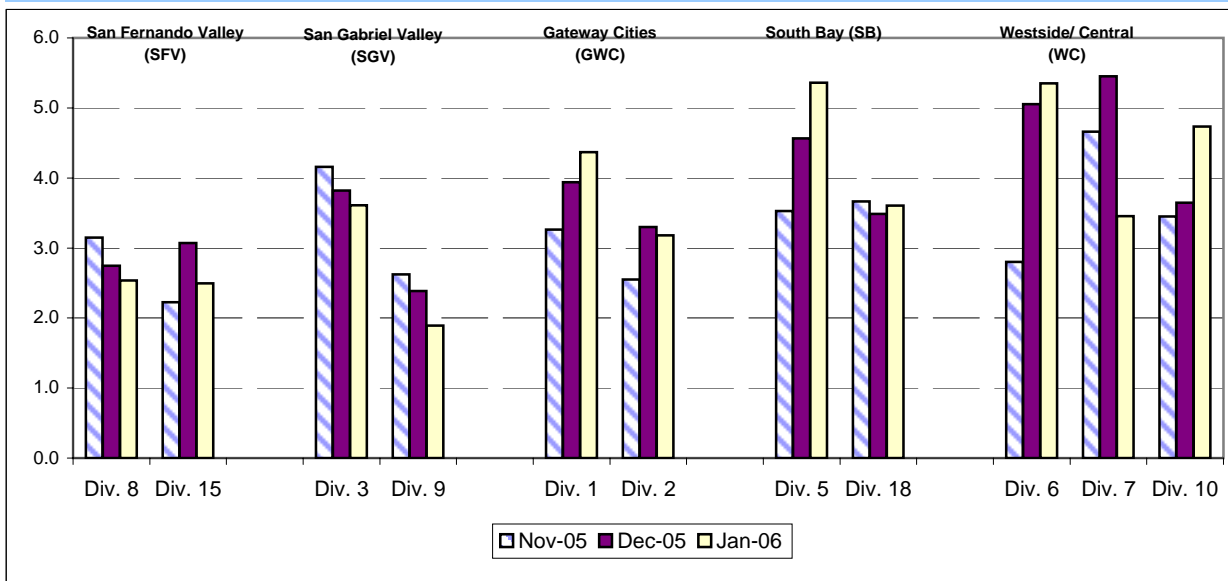

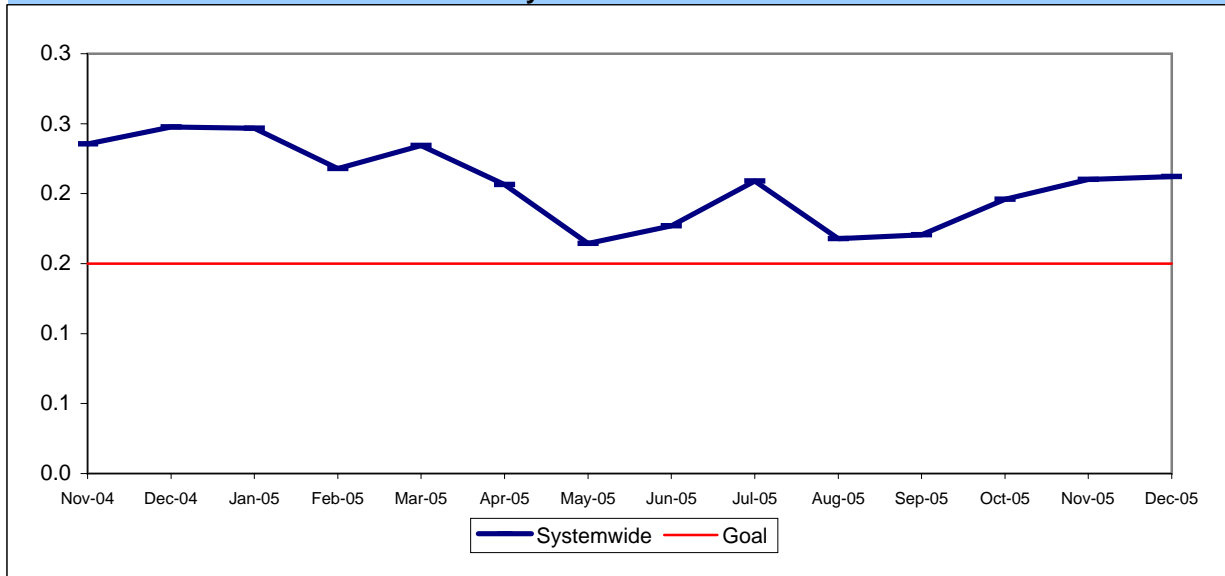
Bus Operating Divisions - by Sectors' Divisions November 2005 - January 2006

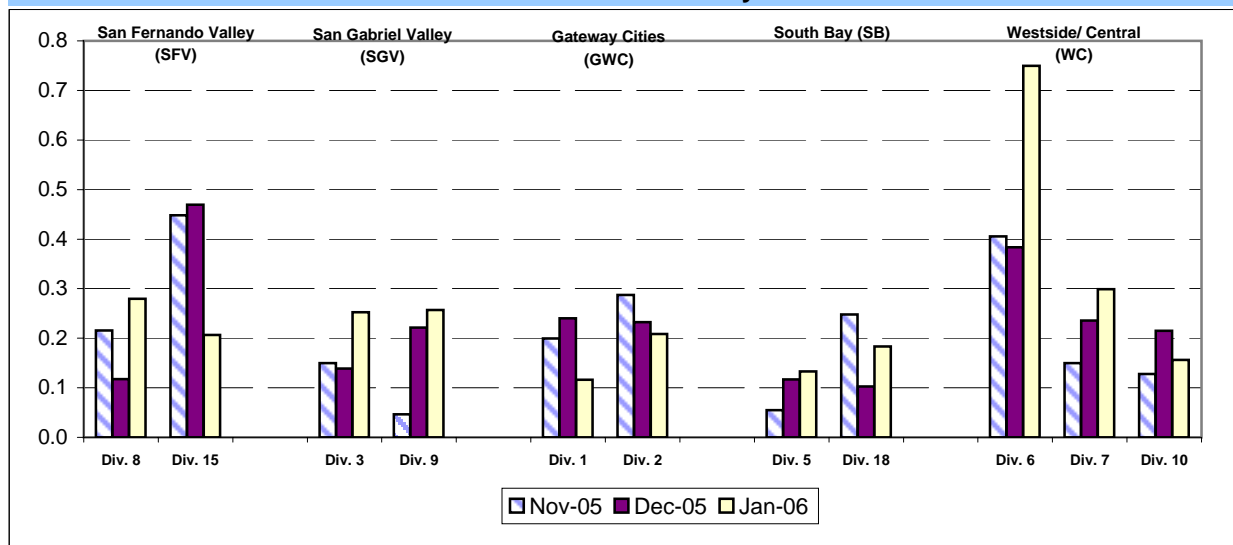

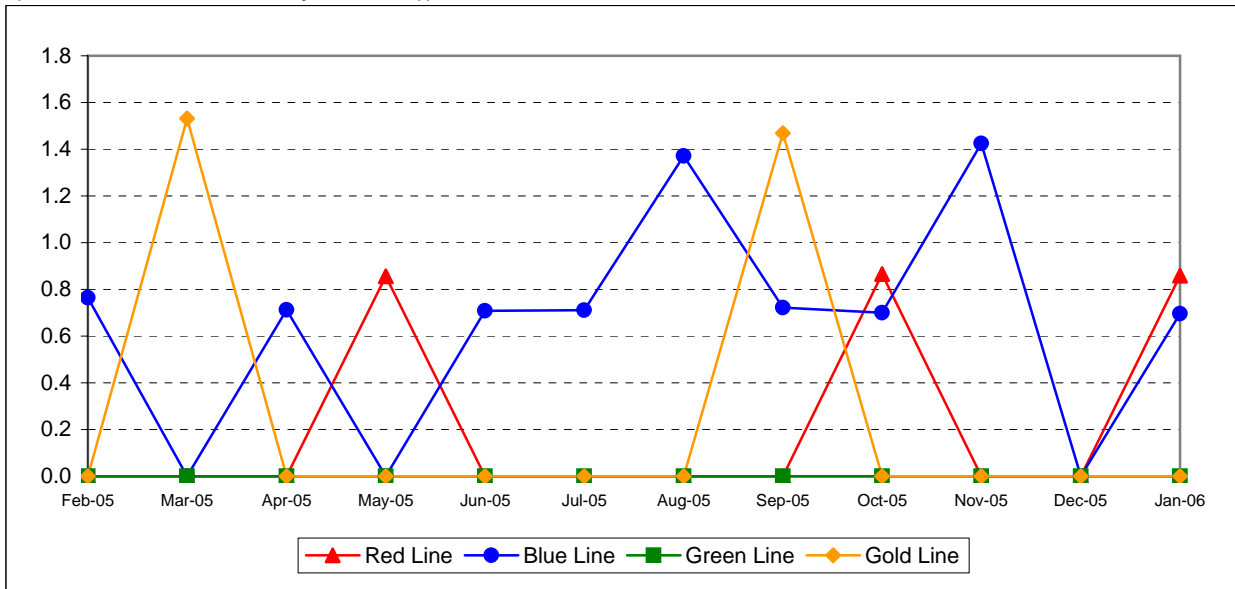

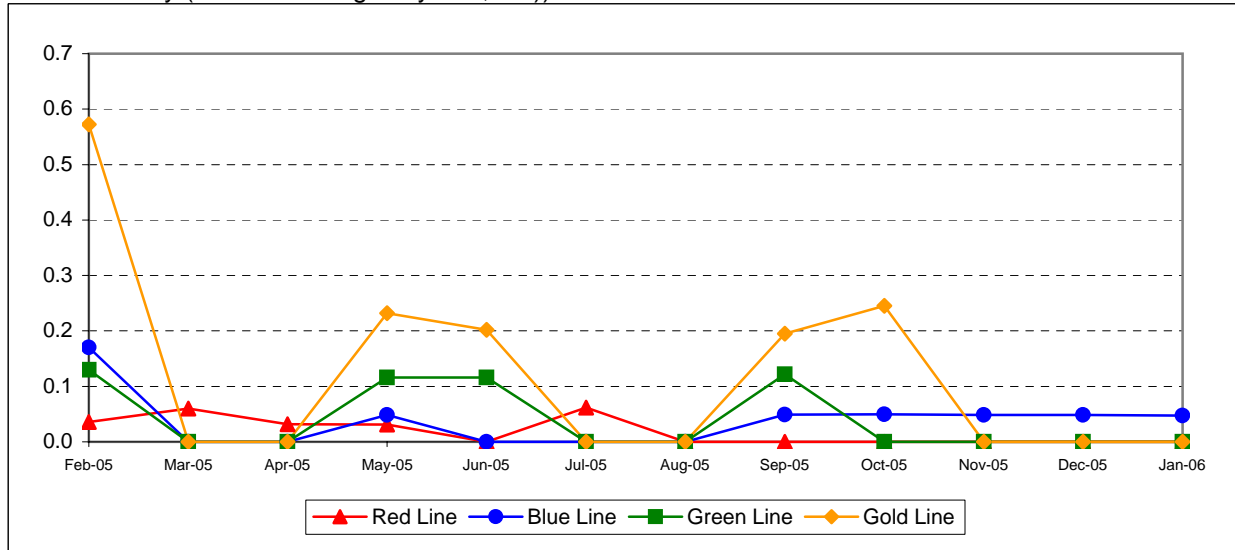

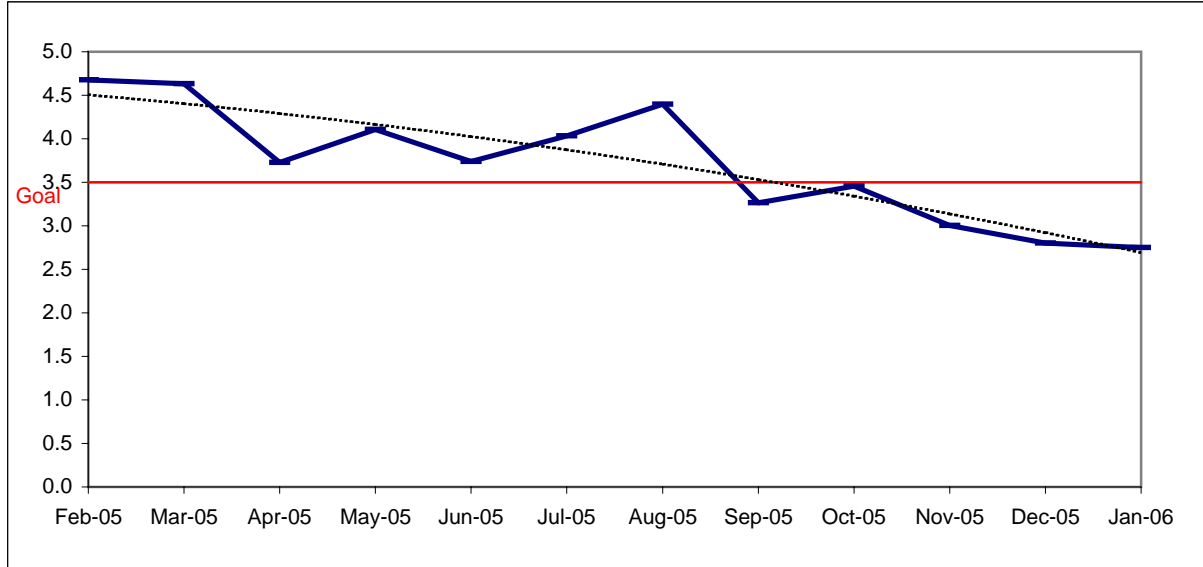

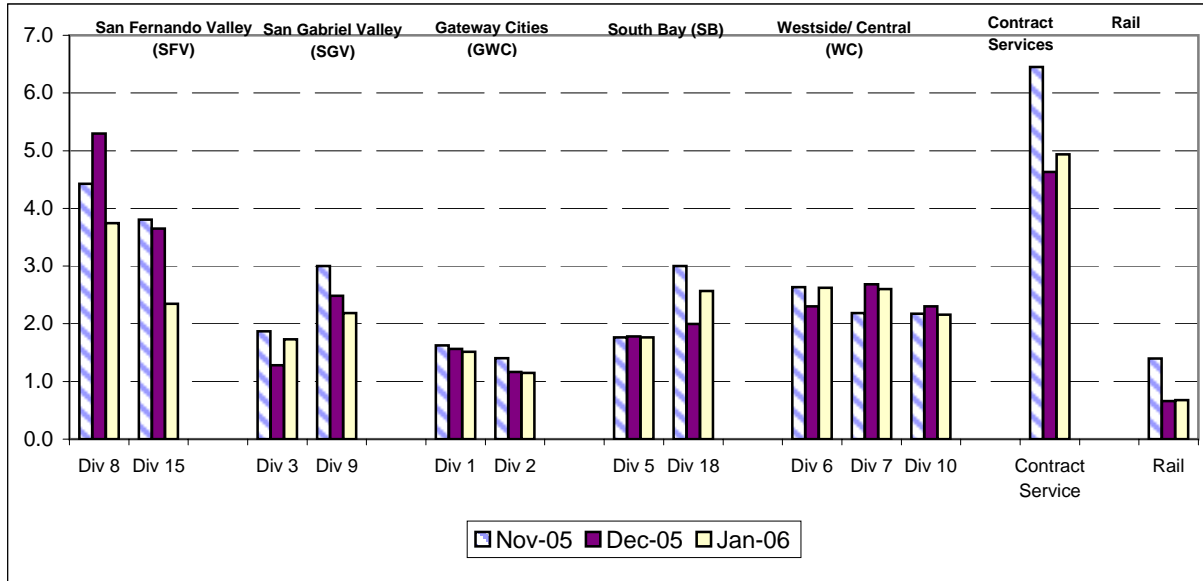

Bus Operating Divisions - by Sectors' Divisions November 2005 - January 2006



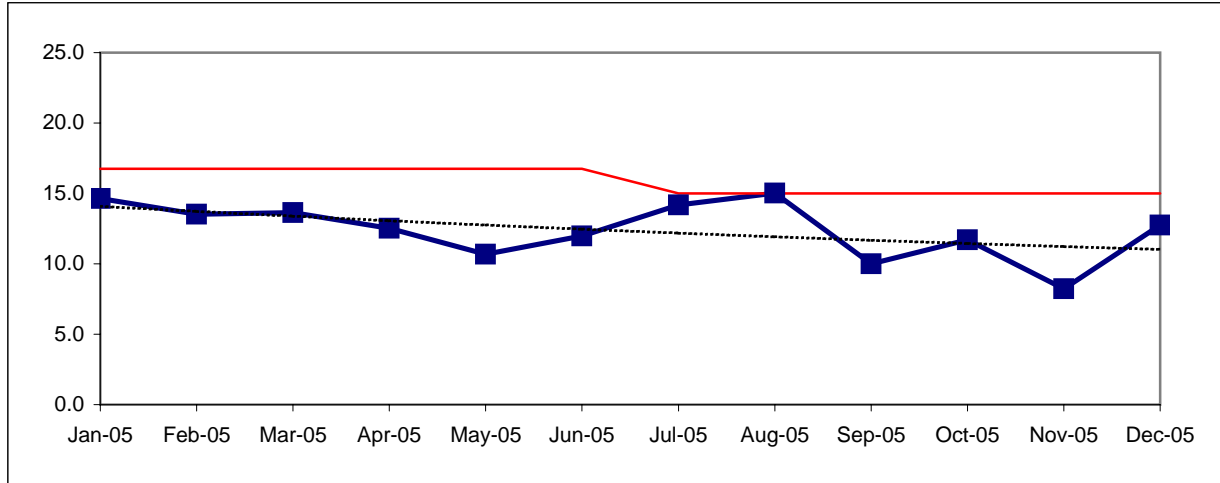

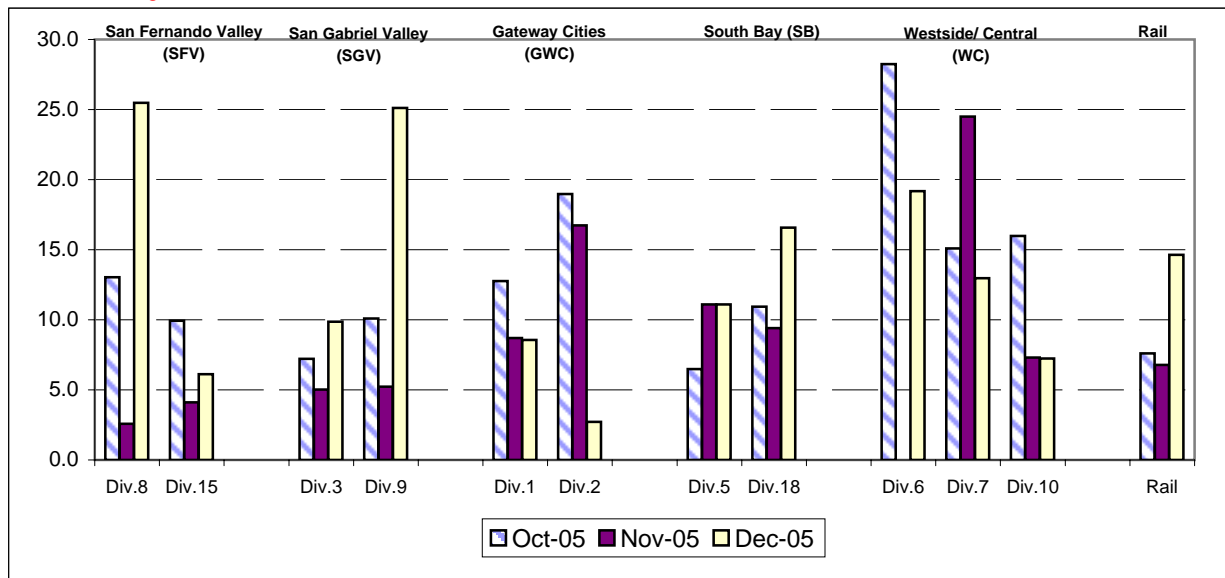
