The Metro South Bay Service Sector will hold a public hearing on Tuesday, February 22, 2005 from 6 PM to 8 PM at the Carson Community Center, 801 East Carson St., Adult Activity Room, Carson, CA 90745. The purpose of the upcoming public hearing is to receive public comments on proposed changes to Metro bus services operating in the South Bay and other portions of Los Angeles County. Approved changes will be in effect June 26, 2005 or later. The hearing will be held in conformance with federal public hearing requirements outlined in Section 5307 (d) 1 of Title 49 U.S.C., and public hearing guidelines adopted by the MTA's Board of Directors in 1993, as amended.

The affected bus lines and service proposals under consideration are listed below. These service changes are proposed to improve service quality, to use resources wisely, and to consider new services.

225/226	Palos Verdes Peninsula	Consider transfer of service to the Palos Verdes Peninsula Transit Authority for community-based operation.
305	Crosstown Bus from Rosa Parks Station to Westwood	Cancel weekend and Holiday service and reduce weekday service frequency to approximately every 40 minutes in peak hours and every 60 minutes in the midday.
357	Western Av. Limited	Cancel all service in December 2005 with implementation of Western Av. Metro Rapid Line 757
439	LA – LAX – Redondo Beach Express	Cancel all service south of Los Angeles International Airport (LAX) Transit Center.
