SUBJECT: MULTI-COUNTY GOODS MOVEMENT ACTION PLAN

ACTION: APPROVE RECOMMENDATION

RECOMMENDATION

Authorize the Chief Executive Officer to:

- A. ~~Negotiate and award~~ Award an eighteen-month, firm fixed price professional services contract, Contract No. PS 4310-1268-01-14-1 to Wilbur Smith Associates, for the Multi-County Goods Movement Action Plan in an amount not to exceed ~~\$1,064,250~~ **975,000**.
- B. Exercise Contract Option 1 for a not-to-exceed amount of \$200,000.
- C. Exercise Contract Option 2 for a not-to-exceed amount of \$500,000, for a total contract value of ~~\$1,764,250~~ **1,675,000**, contingent upon securing additional funds through State grants or other non-Metro sources.

RATIONALE

At its December 2004 meeting, the Board directed staff to utilize the Transportation Planning Bench to advertise and procure a contract(s) for specialized consultant expertise in the development of a Multi-County Goods Movement Action Plan (MCGMAP) for a not-to-exceed amount of \$1,275,000, with the understanding that a combination of Metro, Orange County Transportation Authority (OCTA), San Bernardino Associated Governments (SANBAG), Riverside County Transportation Commission (RCTC), Southern California Association of Governments (SCAG) and Caltrans funding will be used for the contract. Staff for these agencies, as well as Ventura County Transportation Commission will also be used in addition to the consultant effort. Metro expects to have fully executed funding agreements with the above funding partners prior to this board action.

This effort will provide a forum for public and private sector stakeholders representing the shipping, freight and transportation industries to discuss issues and reach consensus regarding short, mid and long-term solutions and funding strategies. Public and private sector stakeholder involvement in the development and implementation of the MCGMAP will be crucial. As such, staff, in conjunction with the county transportation commissions, SCAG and Caltrans, has already begun to meet with representatives from appropriate public

and private sectors. This joint effort will result in a comprehensive evaluation of a full range of strategies (i.e. corridor improvements, operational improvements, capital improvements, institutional arrangements) that will address the goods movement challenges in the region while not disproportionately impacting local communities, the environment or the existing transportation infrastructure.

DISCUSSION

As a result of the cooperative effort between the county transportation commissions, Caltrans and SCAG, additional tasks beyond the original scope of work for this procurement were identified. Due to lack of funding, these tasks are identified as contract options that will be exercised if funding becomes available. The tasks described in Contract Option 1 will result in a more detailed analysis of the movement of goods from Los Angeles County to Imperial and Kern Counties, and to the California border. The tasks described in Contract Option 2 will include developing conceptual engineering plans and estimates as well as additional outreach and consulting with key stakeholders regarding specific improvements and/or strategies.

FINANCIAL IMPACT

As illustrated in the table below, the total contribution from the county transportation commissions, SCAG and Caltrans for the MCGMAP is \$1,075,000, excluding Contract Options 1 and 2. It is anticipated that a \$200,000 grant from Caltrans will be awarded during the first quarter of FY 06 for Contract Option 1. It is estimated that the work described in contract Option 2 will not exceed \$500,000. Contract Option 2 will be exercised, contingent upon securing additional funds through State grants or other non-Metro sources.

The Metro FY 06 budget for Cost Center 4360, San Gabriel Valley Area Team includes \$800,000 under Project No. 405522-05.01 for the MCGMAP. Since this is a multi-year contract, the cost center manager and Executive Officer will be responsible for budgeting the cost in future years.

ALTERNATIVES CONSIDERED

Staff considered not entering into a funding agreement with regional agencies to develop the Multi-County Goods Movement Action Plan but concluded a coordinated effort among the agencies would reduce the potential for duplicating efforts and prove to be more efficient. Staff also considered conducting the entire work in-house but rejected this alternative due to the need for specialized expertise as discussed at the November Planning and Programming Committee meeting.

PROCUREMENT HISTORY**

Multi County Goods Movement Action Plan

A. Background on Contractor

Wilbur Smith Associates, Los Angeles, CA, has been in business 52 years. Their major business areas are transportation planning, engineering, and economics. The prime contractor has no record of previous prime contracts with MTA, but has an extensive list of projects performed in the LA area. Subcontractors Gill Hicks Associates, Arellano Associates, Sharon Greene Associates, and Jones and Stokes all have a satisfactory record with MTA projects.

Wilbur Smith Associates completed the LAC Truck Logistics Study for the LA County Sanitation District, California Freight Rail Plan for Caltrans, Orange County Commuter Rail Strategic Assessment, 2003-04, and is currently performing the Metrolink Commuter Rail Strategic Assessment. Wilbur Smith has done at least eight other national and international multi-jurisdictional goods movement plans.

B. Procurement Background

This procurement is a firm-fixed-price competitive award under the MTA A&E Bench contract. The Board authorized accomplishing this study under the A&E Bench under Agenda Item 7 of the 17 November 2004 Planning and Programming Committee meeting.

This is a joint collaboration of six funding partners in the development of the SOW. The contract will be awarded as a Task Order under the A&E Bench.

Two options are under consideration for additional efforts depending on availability of funding from partner agencies. The requirement is for the contractor to subcontract 16.21% to Disadvantaged Business Firms.

C. Evaluation of Proposals

The solicitation is in accordance with the Procurement Policy Manual. The Source Selection Committee conducted a comprehensive technical evaluation of the proposals. Wilbur Smith Associates proposal and the two other proposals were found responsive to the project and submittal requirements.

D. Cost/Price Analysis Explanation of Variances

The recommended price has been determined to be fair and reasonable based upon cost analysis, independent cost estimates, negotiations with Wilbur Smith Associates, and the MASD audit of the contractor's proposal.
