

# **Gateway Cities Governance Council**

1) The Governance Council is responsible for bus service operated by the Gateway Cities Service Sector. Service Operated by division 1 and 2 includes the following Lines:

**4)** The Governance Council is responsible for: studying and planning service to improve efficiency with the Metro Gateway Cities Sector; making recommendations to the MTA board regarding service issues; working with transit planners and local authorities and transit operators to ensure coordination of service, and; holding public hearings to gain input on proposed changes. The Governance Council is not responsible for fare and pass structures, new project construction, or Metro Rail.

- 4. **APPROVED Minutes** of December 8, 2005 Council Meeting.
- 5. **RECEIVED Report** from General Manager
  - Budget & Performance General Manager Clifford expressed that agency wide there is still a shortage of Bus Operators. Requiring divisions to juggle schedules and offer overtime. The cost per revenue service hour is doing well compared to other sectors. Workers' Compensation costs are a bit over on the YTD target. This service sector is lowest in customer complaints and is down in accidents. Both divisions have received commendations.

General Manager Clifford stated that there will not be a ride-a-long tomorrow; it will be rescheduled for next week.

- 6. **RECEIVED Oral Report (Summary)** on Special Master's Order Re: New Service Implementation Plan Alex Clifford. Mr. Clifford reported that the Special Master provided the agency with a report including a number of concerns. This sector's main issue is to develop a mitigation plan to address security concerns caused by the cancellation of Line 107, which forces people to walk farther in an unsafe neighborhood. The order also requires improved service on Line 611 to add a connection between Line 611 and Line 105.
- 7. **RECEIVED Oral Report** on recently implemented December '05 Service Changes. Mike Sieckert reported that the changes were in effect Sunday, December 18<sup>th</sup>. These changes were designed to improve service by adding more running time where it was needed to improve schedule performance. Eight lines were re-routed, Line 681 was cancelled and the new Line 577X was added. All changes were approved by the Board. Rider brochures were placed on buses to make customers aware of the changes, and the information was also on the website and in the newspapers. There will be a full report next month on the special shuttle service operating along Franklin Avenue and Sunset.

On December 19, 2005 Directors Knabe and Lowenthal attended the ribbon cutting for Line 577X. It was a tremendous success.

Council Member Shidler stated that Line 577X is a great line but the extra fare needs to be eliminated. Mr. Shidler asked what additional revenue MTA is making with the express line zone fee.

- 8. Chairperson's Remarks Council Chair Nelson sought permission and consensus from the council in order for him to speak to Director Lowenthal regarding Dave Hershenson's divided time and the zone fare fees.
- 9. Council Member's Remarks Council Member Shidler requested that someone from Human Resources attend the next meeting and give an overview of the wage and hiring structures of the agency. Mr. Shidler reminded the council that it needs to give a report to the Board before July 2006 on all the accomplishments the Gateway Cities Service Sector has made over the past year.

Council Member Eros-Delgado reminded the Council that on January 21, 2006 Whittier will be launching a new shuttle and holding a transit fair. She encouraged everyone to attend.

#### METROPOLITAN TRANSPORTATION AUTHORITY SERVICE SECTOR COUNCIL RULES

### **PUBLIC INPUT**

The Service Sector Council meetings are open to the public. A member of the public may address the Council on agenda items, before or during the Council's consideration of the item for up to 5 minutes per item, or at the discretion of the Chair. A request to address the Council should be submitted in person at the meeting to the Council Secretary prior to the start of the meeting.

The public may also address the Council on non-agenda items within the subject matter jurisdiction of the MTA Service Sector during the public comment period, which will be held at the end of each meeting. Each person will be allowed to speak for one minute and may speak no more than once during the Public Comment period. Public Comment will last a maximum of 30 minutes, or as otherwise indicated by the Chair. Speakers will be called according to the order in which the speaker request forms are received until the Public Comment period has expired. Elected officials, not their staff or deputies, may be called out of order and prior to the Council's consideration of the relevant item.

At the discretion of the Chair, the Council may limit public input on any item, based on the number of people requesting to speak and the business of the Council.

In the interest of hearing from as many members of the public as possible, if at the time your name is called, your issue has been addressed or your opinion expressed by a previous speaker, please simply state that fact and your name for the record.

In accordance with State Law (Brown Act), all matters to be acted on by the Council must be posted at least 72 hours prior to the meeting. In case of emergency, or when a subject matter arises subsequent to the posting of the agenda, upon making certain findings, the Council may act on an item that is not on the posted agenda.

**CONDUCT IN THE MEETING ROOM** - The following rules pertain to conduct at Service Sector Council meetings:

**REMOVAL FROM THE MEETING ROOM** The Chair shall order removed from the Meeting Room any person who commits the following acts with respect to any meeting of the Council:

- a. Disorderly behavior tending to interrupt the due and orderly course of said meeting.
- b. A breach of the peace, boisterous conduct or violent disturbance, tending to interrupt the due and orderly course of said meeting.
- c. Disobedience of any lawful order of the Chair, which shall include an order to be seated or to refrain from addressing the Council; and
- d. Any other unlawful interference with the due and orderly course of said meeting.

## **DISCLOSURE OF CONTRIBUTIONS**

The State Political Reform Act (Government Code Section 84308) requires that a party to a proceeding before an agency involving a license, permit, or other entitlement for use, including all contracts (other than competitively bid, labor, or personal employment contracts), shall disclose on the record of the proceeding any contributions in an amount of more than \$250 made within the preceding 12 months by the party, or his or her agent, to any officer of the agency, additionally PUC Code Sec. 130051.20 requires that no member accept a contribution of over ten dollars (\$10) in value or amount from a construction company, engineering firm, consultant, legal firm, or any company, vendor, or business entity that has contracted with the authority in the preceding four years. Persons required to make this disclosure shall do so by filling out a "Disclosure of Contribution" form which is available at the Board Secretary's Office. Failure to comply with this requirement may result in the assessment of civil or criminal penalties.
