SUBJECT: METRO SAN GABRIEL VALLEY GOVERNANCE COUNCIL CITY CLUSTERS

ACTION: APPROVE

BACKGROUND

The Metro Board of Directors established five regional governance councils to provide guidance to Metro Bus Operations staff within each respective sector in 2003. This was undertaken to monitor and improve safety and performance of all bus service operated within the respective sectors. In addition, the Councils are to review and approve changes designed to improve service quality, ridership and operational efficiencies.

The Metro San Gabriel Valley Governance Council is comprised of appointees from LA County Supervisors Gloria Molina and Michael Antonovich, two regular transit users, four representatives from clusters of cities established by the San Gabriel Valley COG, and an at large representative from the San Gabriel Valley COG.

The existing city clusters are as follows:

DISCUSSION

The modification of the city clusters to include three important cities in the sector's core service area is being considered. These are the cities of Arcadia, El Monte and Temple City. Two possibilities for modified clusters are:

Rosemead (54k), San Gabriel (40k), San Marino (13k), S Pas (24k)	131k
Pasadena (134k), La Canada (20k), Sierra Madre (11k)	165k
El Monte (116k), Temple City (33k), Arcadia (53k)	<u>202k</u>

<i>Option 2</i>	<i>Cluster Population</i>
Rosemead (54k), Montebello (64k), Monterey Park (60k)	178k
Alhambra (86k), San Gabriel (40k), S Pas (24k), San Marino (13k)	163k
Pasadena (134k), La Canada (20k), Sierra Madre (11k)	165k
El Monte (116k), Temple City (33k), Arcadia (53k)	<u>202k</u>

Bold-represents City currently serving on Governance Council

Option 2 appears preferable since it more evenly distributes population among each other.

RECOMMENDATION

Approve Option 2 as the recommended city cluster restructuring and forward the recommendation to the San Gabriel Valley Council of Governments for approval.
