ACTION: AUTHORIZE A TRANSFER OF FY07 FUNDS BETWEEN BUDGET CATEGORIES AND APPROVE THE ANNUAL WORK PLAN FOR THE CITY OF LOS ANGELES

RECOMMENDATION

- 1. Approve the FY07 Annual Work Plan (AWP) for an initial amount not-toexceed \$1,001,413 with the City of Los Angeles;
- 2. Authorize the Chief Executive Officer to execute the AWP or substantially the same, on behalf of the Authority; and
- 3. Authorize the Chief Executive Officer (CEO) to return to the Board at a future date with a full report describing the forecast cost of Third Party/Master Cooperative Agreements and the associated impact on the project budget.

SUMMARY

This action, when added to the Interim Work Order approved at the July, 2006 Board meeting, provides for funding up to the Authority's FY07 Budget for the City of Los Angeles' review and input into the project design and construction processes. The FY07 budget for this work is \$1.3 million.

The FY07 Budget was approved at the May, 2006 Board meeting. Since that time, Authority staff has been negotiating specific work agreements with each of approximately 30 agencies, departments, utilities and other third parties who will review or have oversight responsibilities on various elements of the project. This process of negotiation has resulted in a determination that the original budgeted amount for FY07 for Third Party/Master Cooperative Agreements will be inadequate to fulfill the project's needs. Authority staff is presently undertaking a

comprehensive evaluation of the Third Party/Master Cooperative Agreements budget category and will return to the Board with that evaluation at a future meeting.

DISCUSSION

During the course of rail transit projects such as the Expo LRT project, significant support from several departments of local jurisdictions is required. This support has been typically obtained via Annual Work Programs authorized and funded by the Agency responsible for the project design and construction. Through FY06, several Annual Work Programs have been implemented with the City of Los Angeles. It is the intent of the Authority to continue this practice for the duration of the Project. The action contained herein provides funding for City participation in the project up to the limit of the current approved FY07 Budget for this category.

Authority staff has been conducting extensive negotiations with City of Los Angeles departments over the past several months. It has become clear that both the approved FY07 budget and life of project budget for City of Los Angeles input to the design and construction are not sufficient to meet the needs of the project. Accordingly, Authority staff are undertaking a comprehensive review of all Third Party/Master Cooperative Agreements budgets, both FY07 and life of project, and will return to the Board with a full analysis and recommendations at a future meeting.

Authority staff's efforts to proactively manage these costs include controlling the design review process by conducting pre-reviews and early coordination of design efforts to establish/clarify standards and requirements, reviewing submittals for completeness, ensuring that third party requirements are identified and addressed prior to sending to the third party, reviewing timesheets and work activities with each Third Party organization on a weekly or bi-weekly basis to ensure that hours charged are appropriate, and conducting executive and staff level partnering with third parties.

FINANCIAL IMPACT

The recommended action is within the FY07 project budget.

NEXT STEPS

The CEO will execute the AWP which partially funds the City of Los Angeles' FY07 requirements in order to continue progress on the project.

Authority staff will complete the comprehensive Third Party/Master Cooperative Agreements budget analysis and present the results and recommendations for action at a future meeting.
