SUBJECT: REVISED SERVICE CHANGE PROGRAM

ACTION: APPROVE FINDINGS OF AUGUST 2006 PUBLIC HEARINGS AND

ADOPT REVISED SERVICE PROGRAM FOR DECEMBER 2006

RECOMMENDATION

- A. Approve findings of Public Hearings conducted Tuesday, August 8th for service changes proposed to become effective December 2006 or later (Attachment B); and
- B. Adopt Revised Service Program as outlined in this report (Attachment C);

ISSUE

The service changes under consideration are considered to be major modifications based on federal public hearing guidelines and MTA policy. As such, the governance council is required to conduct a public hearing, and to solicit and consider public input before these changes can be implemented. The Council is also required to consider the possible impacts from these proposals before approving them. Staff has prepared the necessary documentation in the report to satisfy this regulatory requirement.

ALTERNATIVES CONSIDERED

The basic alternative to the staff proposal is to maintain the status quo. This option is not recommended as the proposed service plan is designed to provide improved service for most riders, and can be implemented within the current operating budget. In addition, this does not advance the service concepts of the adopted Metro Connections Program.

FINANCIAL IMPACT

The Revised Service Plan can be implemented at no increase in operating cost. Resources saved from the restructuring of existing local services will be fully reinvested to establish the new limited-stop lines and to make other schedule related improvements to the locals.

BACKGROUND

Last month four of Metro's Sector Governance Councils conducted public hearings within their respective jurisdictions to receive input from the community on proposed major changes to Metro's bus service starting in December 2006 or later. A total of 20 existing bus lines are

potentially affected by having their routes, schedules and/or stops modified to make them more effective. In addition, seven new services are proposed to be established, and a few existing lines or segments of lines are proposed to be cancelled. Collectively, the specific lines, and the proposed changes to them, are shown in the attached public hearing notice (Attachment A).

The four sector governance councils holding public hearings in August included Metro's Gateway Service Sector, South Bay Service Sector, San Fernando Valley Service Sector and the San Gabriel Valley Service Sector. At these hearings the public was invited to comment on any proposal under consideration regardless of the service sector that proposed the change. All were informed that comments received at these hearings would be forwarded to the respective sector governance council that manages the line, and that it would be taken into consideration by them as part of their final deliberations.

The San Gabriel Valley Governance Council conducted its public hearing on Tuesday, August 8. Six bus lines were proposed to be modified to improve on-time performance, reduce service duplication, or improve service levels to make them more effective. This are Lines 85, 201, 255, 268, 487 and 751.

Legal notice of these hearings was first published in the Los Angeles Times on Sunday, July 2, 2006. Additional notice was subsequently published in other local, regional and foreign language newspapers system-wide. About 60,000 rider notices were distributed on the buses, trains and at customer service outlets informing riders about the changes under consideration. This information was also posted on MTA's main website and service sector websites.

The following sections of this report summarize the written and verbal testimony received by the public on these matters through the close of the public record, August 12, 2006. Staff has responded to each issue, and has recommended modifications to several proposals based on public input and other considerations. Summary of the public comment along with staff's response are included in Attachment B.

Attachment C outlines the Revised Service Plan that resulted from the public review process. It also summarizes the potential impact riders may experience from the service modifications recommended in the Revised Service Plan.

RESULTS OF AUGUST, 2006 PUBLIC HEARINGS

Summary of Public Comment

About 45 members of the public attended the August 8 public hearing and 22 individuals provided comments. In addition, 42 individuals communicated their comments via phone, letter, e-mail and fax. A few of these provided both written comments and oral comments at the public hearing.

In total, 93 comments were received that dealt with the proposed service changes. 90% of the comments received were opposed to the proposed changes. 3% voice support and 9% proposed modifications to the public hearing proposals.

The City of Glendale requested that the Governance Council take no action on the proposed change to Line 201. Glendale is in the process of conducting a transit study of its Beeline service and is asking that this be completed prior to Line 201 being shortened.

REVISED SERVICE PLAN

Staff proposes to modify elements of the original service change program to address issues raised during the public review process, as well as other considerations. The Revised Service Plan is outlined in Attachment C.

REVISED SERVICE PALN

Line **85**Original Proposal: Create a shuttle route by converting Line 85 service along Verdugo Rd. from Glendale College to Eagle Rock Bl. and number as Line 685.

Provided Proposal: Approve as originally proposed.

Revised Proposal: Approve as originally proposed.

Line **201** *Original Proposal:* Shorten this line by ending service at Glendale Adventist Hospital. This would remove about one mile of route from this line in Glenoaks Canyon.

Revised Proposal: Approve as originally proposed.

Line **255** *Original Proposal:* Cancel this low performing bus route. Revised Proposal: **Approve as originally proposed**.

Line 268 Sierra Madre

Original Proposal: Simplify this regional route by keeping it on Foothill Bl. and removing it from the City of Sierra Madre

Revised Proposal: Approve as originally proposed.

Line **268 JPL**

Original Proposal: Shorten this regional route by ending it at Lincoln Av. and Woodbury in Altadena and removing it from JPL *Revised Proposal*: Remove from the plan

Line 487 Sierra Madre

Original Proposal: Shorten this 30-mile long regional route by breaking it into two segments. One segment remaining as an express from downtown LA rerouted to the Sierra Madre Villa Gold Line Station. The other, renumbered Line 287 as a local line from El Monte Station ending at San Gabriel and Colorado Bls. connecting to Line 487.

Revised Proposal: Approve the breaking of this line, but reroute both lines to end at Sierra Madre Villa Station via Sierra Madre Bl. and Sierra Madre Villa Av. to the station.

Line 487 San Gabriel

Original Proposal: Simplify the route in the City of San Gabriel *Revised Proposal*: **Remove from the plan.** Coordinate with the City of San Gabriel in the identification of a new park and ride location.

Line **751** *Original Proposal:* Shorten route in conjunction with implementation of new Rapid Line 760.

Revised Proposal: Remove from plan as the Gateway Sector Governance Council has deferred a decision on implementing new Rapid Line 760 (Long Beach Bl. Rapid Bus) until Spring 2007 To be reconsidered by San Gabriel Valley Governance Council in Spring 2007, due to the delay in implementing new Rapid Line 760.

IMPACT STATEMENT FOR THE REVISED SERVICE PLAN

Line 85 – This line is a branch of Line 28/83/84/85/328. Service on Line 85 operates weekdays only. Of the total of 32,800 riders that board this combination line, about 730 board Line 85 buses on Verdugo Rd. It is estimated that about 200 of these riders would need to transfer from Line 84 buses to complete their trip.

Line 201 – This 11.5 mile long line operates from the Vermont/Wilshire Metro Red Line Station to Glendale. The line operates about every 45 minutes on weekdays and hourly on weekends. On average, about 1,000 riders board a Line 201 bus on weekday, 500 on Saturdays and 350 on Sundays. The ridership on the impacted one mile route segment is approximately 32 on weekdays, 13 on Saturdays and 19 on Sundays. On average there are about 1.5 passengers on each bus trip on the impacted route segment in Glenoaks Canyon. If the City of Glendale does not provide replacement service, these riders would need to find alternative transportation.

Line 255 – This shuttle route is 4.4 miles in length. The Los Angeles City Boyle Heights DASH duplicates the northern 3 miles of this route from County/USC Hospital to Rowan Av. and Chavez Av. Line 255 provides hourly service seven days per week. On average about 425 riders board this line on weekdays, 320 on Saturdays and 260 on Sundays. The DASH service operates every 25 minutes with Weekday and Saturday service. No Sunday service is provided. This City of LA in cooperation with the County is planning on extending this DASH route in December 2006 to replace Line 255 service in its entirety. There is a significant amount of bus service in the areas that Line 255 operates on Sundays. But riders would need to walk an average of ½ mile and possible transfer to complete their trips.

Line 268 Sierra Madre – This line is 20.3 miles long and operates a variable service level that averages about every 40 minutes during weekday peaks and hourly in mid-day and weekend service periods. In addition, this line operates a significant amount of school trippers, almost exclusively in the Pasadena-Altadena area. On weekdays this line attracts an average of 2,400 riders, with 1,200 passengers on Saturdays and 900 on Sundays.

The proposal is to straighten this route by removing service from Sierra Madre. This would save about 1.5 miles and 7 – 8 minutes per one-way bus trip. There are eight bus stops that would be impacted. On average about 95 people on weekdays, 42 on Saturdays, and 31 on Sundays would no longer have direct access to Line 268 service. These impacted riders would need to catch an alternative bus line on Sierra Madre Bl. and possible transfer to complete their trips. On the positive side the through passengers on Line 268 would save travel time. About 230 weekday, 175 Saturday and 130 Sunday riders would save about 7 minutes in travel time in each direction of their trips.

Line 268 JPL – The second proposed change was to remove all service offered by this line to JPL. This proposal is not longer in the revised service plan.

Line 487 Sierra Madre – This is a 30-mile long route that operates from Wilshire Bl. and Alvarado St. on the westside down town LA to El Monte Station via San Gabriel and Sierra Madre. This line operates 15 – 20 minutes frequencies of service during weekday peak periods, 45 minutes during weekday mid-days and Saturdays and hourly service on Sundays. Ridership levels average about 2,900 on weekdays, 1,400 on Saturdays and 925 on Sundays.

The public hearing proposal was to cut this line into two routes with the express service from LA ending at the Sierra Madre Villa Gold Line Station. The portion of route from El Monte Station, to be renumbered Line 287, was to end at San Gabriel and Colorado Bl. The revised proposal is to end both routes at the SMV Station. There are an average of about 4.5 riders on board each Line 487 bus at Sierra Madre Bl. and Sierra Madre Villa Av., the location where these two routes would meet. If adopted, about 250 passenger on Weekdays, 130 on Saturdays, and 100 on Sundays would need to transfer. Service levels on the revised Line 487 and new Line 287 are proposed to be either maintained or improved.

Line 487 San Gabriel – Staff is recommending that this proposal be withdrawn. Sector staff will coordinate with the City of San Gabriel relative to the relocation of their park and ride lot. When the new facility is identified, staff will return with a new proposal to modify the route of Line 487 to not only simplify it but to service the new lot.

Line 751 – The proposed shortening of this Rapid Bus route was predicated on the implementation of the new Long Beach Bl. Rapid Bus Line 760. The Gateway Cities Governance Council, the sector that will operate Line 760, has deferred action until Spring 2007. This would move the implementation date back to June 2007. As the result of this action, staff has removed the modification of Line 751 from the revised service plan.

NEXT STEPS

With approval from the Governance Council, staff will begin preparations to implement the recommended service changes on Sunday, December 17, 2006.

NOTICE OF PUBLIC HEARING

Los Angeles County Metropolitan Transportation Authority

The Los Angeles County Metropolitan Transportation Authority will hold four public hearings in August 2006 to receive community input on proposed modifications to Metro's bus services. Approved changes will become effective December 17, 2006 or later. Details of the hearing dates, times, and locations are listed at the end of this notice.

The upcoming public hearings are being held in conformance with federal public hearing requirements outlined in Section 5307 (d) 1 of Title 49 U.S.C., and public hearing guidelines adopted by the MTA's Board of Directors in 1993, as amended.

Listed below are the service proposals to be considered at the hearings, and the respective service sectors that will host the public hearings. In general, the proposed modifications will improve the efficiency and effectiveness of the public transportation system through a better use of resources. The public can attend any of these hearings and comment on proposals of interest to them.







