# USDOT Approves 2006 Regional Transportation Improvement Program (TIP Funds)

- October 2<sup>nd</sup>, US Department of Transportation (USDOT) approved 2006 Regional Transportation Improvement Program (TIP)
- Includes \$9.4 billion Los Angeles County TIP (Metro Board approved in December 2005)
- Includes over 1,000 transit and highway projects, as well as transit services grants.

### **Upcoming SCRRA Strategic Work Session and Board Retreat**

- October 27-28, 2006, two-day SCRRA strategic work session and board retreat
  - Agency goals and objectives; operating and capital needs; service, safety and security issues; legislative and advocacy activities; and funding
- CP&D staff will be participating

   Movement Bond Measure
- Two-hour public presentation of goods movement projects

#### **Congestion Mitigation Fee**

- October 3<sup>rd</sup>, first meeting of Policy Advisory
   Committee; 35 Committee members attended; next meeting scheduled for October 31, 2006 at 9:00 a.m.
- Meeting with COGs, local governments, and the Policy Advisory Committee to get input into the development of proposed Congestion Mitigation Fee

# 2007 Supplemental Call for Projects (Cost Increases)

- Received 56 applications totaling approximately \$107.9 million
- Staff currently ranking applications
- Board adoption scheduled for January 2007

#### **2007 New Call for Projects**

- Staff completed draft application package
- Application reviewed by TAC, BOS, Streets & Freeways
- Staff will mail out Draft Application on October 27<sup>th</sup>
- Board will review application package in November/December
- Staff will mail supplemental application instructions if needed
- Staff will be holding workshops

#### **Regional Transportation Demand Model**

- Updating performance modeling and financial forecasts for Long Range Transportation Plan update by mid-November
- Continuing work on refinements to travel demand model for Exposition LRT Phase II Corridor Analysis.
   Revisions to be completed by January 2007
- Initiating origin-destination survey of Metro Orange
   Line and Metro Rapid Bus patrons in November that
   will assist in updates to the travel demand model

#### **Multi-County Goods Movement Action Plan**

- Staff has been convening Stakeholder Advisory Group meetings on a bi-monthly basis
- Developing scenarios to model
- Staff will hold workshops to share recommendations with communities
- Staff will provide the Board with dates of these workshops in advance

#### **Route 710 Tunnel Feasibility Assessment**

- Assessment completed in June
- Staff convened two workshops to share findings with the community
- Attended 10 City Council & San Gabriel Valley COG
   Meeting
- Board review in December

## State Route 2 Glendale Freeway Environmental Clearance

- Completed Community Scoping meetings
- Currently working through a few focused meetings with Community stakeholders to make sure Metro and stakeholders understand the comments provided at Community Scoping meetings
- A fewer number of alternatives will be taken into the final DEIR/DEIS, which include a Community alternative that has been further refined and has incorporated broader community input
