ACTION:

APPROVE THE FY07 CITY OF LOS ANGELES ANNUAL WORK

PLAN

RECOMMENDATION

A. Approve the attached FY07 Annual Work Plan (AWP) in an amount not-to-exceed \$2,713,297 (inclusive of \$1,300,000 previously authorized by the Board) with the City of Los Angeles (City), contingent upon Board approval of the Phase 1 FY07 Mid-Year Budget Adjustment (Item 6b); and

B. Authorize the Chief Executive Officer (CEO) to execute the AWP (Attachment A), or substantially the same, on behalf of the Authority, contingent upon Board approval of the Phase 1 FY07 Mid-Year Budget Adjustment (Item 6b).

SUMMARY

This action, when added to the interim work authorizations approved during the July and September 2006 Board meetings, provides full funding for the City's review and input into the project design and construction for FY07 in the amount not-to-exceed \$2,713,297.

The FY07 budget was approved at the May 2006 Board meeting. Since that time, Authority staff has been negotiating specific work agreements with each of the agencies, departments, utilities and other third parties who will review and/or have oversight responsibilities on various elements of the project. As a result of these negotiations, it was determined that funding for certain Third Party agencies was insufficient and a comprehensive evaluation of the Third Party budget category was necessary. This evaluation has been completed and the

recommended budgetary adjustments are further described in the Phase 1 Project Budget Revision Board Item (6a) and Phase 1 FY07 Mid-Year Budget Adjustment Item (6b).

DISCUSSION

During the design and construction of rail transit projects such as the Exposition Light Rail Transit Project (Project), significant support from local jurisdictions is required. This support has been typically obtained via AWPs authorized and funded by the agency responsible for the project's design and construction.

In July 2006, the Board authorized an interim work authorization in the amount of \$298,600, to ensure that critical project support by the City continued while negotiation of the FY07 AWP was completed. During the extensive negotiations with the city departments, it became clear that both the approved FY07 budget and life of project budget for the City third party review, was not sufficient to meet the needs of the project. Accordingly, during the September 2006 Board meeting, Authority staff requested and received approval of an additional work authorization in the amount of \$1,001,400 to continue work until staff completed a comprehensive evaluation of the Third Party budget category. This evaluation of the Third Party budget category has been completed and is summarized in Board items 6a and 6b. During this evaluation process, it was determined that the original FY07 budgeted amount of \$1,300,000 for the City's third party review, should be increased to \$2,713,297, which is the final amount negotiated for the City's AWP.

Authority staff's efforts to proactively manage these costs will include: controlling the design review process by conducting pre-reviews and early coordination of design efforts to establish/clarify standards and requirements; reviewing submittals for completeness; ensuring that third party requirements are identified and addressed prior to sending to the third party; reviewing timesheets with each third party organization on a weekly or bi-weekly basis to ensure that hours charged are appropriate, and conducting executive and staff level partnering with third parties.

FINANCIAL IMPACT

Contingent upon approval of Board Item 6b, the recommended action is within the FY07 budget.

NEXT STEPS

The CEO will execute the AWP which fully funds the City's FY07 requirements associated with the project.
