SUBJECT: TRADE CORRIDOR IMPROVEMENT FUND (TCIF) PROJECT

RECOMMENDATIONS

ACTION: APPROVE TCIF PROJECT LIST

RECOMMENDATION

Adopt the Southern California Consensus Trade Corridor Improvement Fund Working Group Project List (Attachment A).

ISSUE

At the February 2008 meeting, a motion was approved requesting staff to bring the TCIF project list to the Board for approval at their March meeting.

In November 2006, California voters passed Proposition 1B, a \$19.9 billion transportation bond initiative. Proposition 1B authorizes \$2 billion to the TCIF with focus on funding goods movement infrastructure projects. Los Angeles County falls within the Los Angeles/Inland Empire Corridor, as designated by the TCIF program. Staff has been working with other partners within the corridor area to develop the attached list of projects.

Staff initially provided the project list to the Board through a Board Box item on October 5, 2007.

POLICY IMPLICATIONS

If the projects submitted receive funding through the TCIF program, it will support our policy of pursuing all funding alternatives and working collaboratively with regional partners and the State to address goods movement issues as adopted at the Board's January 29, 2007 Goods Movement workshop.

OPTIONS

The alternative to forgo submittal of a list was not considered because the State bond funds will fill a critical funding gap in the region's efforts to address goods movement issues and will ensure that Southern California receives its share of the bond funding.

The alternative to submit other projects was also rejected because the projects submitted were deemed to be the most crucial in improving the region's goods movement network and the most competitive in meeting TCIF guidelines criteria.

FINANCIAL IMPACT

There is no impact to our budget as a result of this action. In all cases, the commitment to provide the 50 percent match has been made by project sponsors. We will act as project sponsor for the I-5 Truck Lanes project. However, we will assure that a funding agreement is in place stipulating that the Golden State Gateway Coalition will be responsible for providing the match and any additional funding required for potential cost overruns.

BACKGROUND

As part of the passage of Proposition 1B, the voters approved \$2 billion statewide to fund infrastructure projects to address goods movement issues. Since late June of last year, staff along with agency staffs of the Ports of Los Angeles and Long Beach, Alameda Corridor Transportation Authority, Alameda Corridor East Construction Authority, San Bernardino Associated Governments, Orange County Transportation Authority, Riverside County Transportation Commission, and the Southern California Regional Rail Authority have convened the Southern California Consensus Working Group in order to develop a consensus on a recommended process and project list for allocating the \$2 billion. These entities are likely recipients of TCIF and can best identify and deliver the required program of projects within our region. The Southern California Consensus Working Group also includes representatives from Caltrans Districts 7, 8, and 12 as well as from South Coast Air Quality Management District (SCAQMD), and the Southern California Association of Governments (SCAG) who serve in an advisory capacity. Staff also contacted Councils of Governments (COG) in order to ensure that all potential projects are considered for the TCIF program.

The following criteria were used to develop the project list and determine the placement of projects in each Tier:

- Deliverability projects recommended will be ready to go to construction by 2013.
- Matching Funds projects must have a 1:1 non-Prop 1B bond match.
- Performance simultaneous and continuous improvement requires a solution set that reduces freight movement emissions, reduces freight delays, increases freight reliability and decreases the congestion impact on communities.

The Tier 1 projects for the region recommend \$1.7 billion in TCIF programming reflecting a request of 85 percent of the total statewide TCIF funding based on the fact that 85 percent of the State's containerized cargo travels through the Los Angeles/Inland Empire region. These nominations represent those projects that will demonstrate the most significant benefits and alleviate the most pressing limitations in the region's goods movement network. The Tier 2 total requested is based upon a potential over-programming of TCIF up to \$3 billion. These projects complement the goods movement network by filling pivotal gaps within the system.

Los Angeles County has 10 projects in the Tier 1 list and five projects in the Tier 2 list with a TCIF request of \$1.04 billion and \$238 million respectively (Attachment B).

Staff submitted applications for all projects on Attachment A to the California Transportation Commission (CTC) on January 17, 2008 and met with CTC staff on February 19, 2008 to respond to project-related questions. TCIF funding must be budgeted in the state budget by the legislature and will be programmed by the CTC.

NEXT STEPS

It is anticipated that the CTC will make its initial recommendations regarding the TCIF program at its March 12, 2008 meeting and will take formal action on April 10, 2008.


