

NOTICE OF PUBLIC HEARING Los Angeles County Metropolitan Transportation Authority Metro Westside/Central Sector

The Westside/Central Service Sector will hold a public hearing on August, 13 2008. The purpose of the public hearing is to receive community input on proposed modifications to Metro's bus services. Approved changes will become effective December 14, 2008 or later. Details of the hearing date, time, and location are listed below.

The upcoming public hearing is being held in conformance with federal public hearing requirements outlined in Section 5307 (d) 1 of Title 49 U.S.C., and public hearing guidelines adopted by the MTA's Board of Directors in 1993, as amended.

The proposed changes are illustrated on the attached map.


If approved by the Metro Governance Councils and Board of Directors, these changes will be implemented as early as December 2008 or later.

SUMMARY OF SERVICE CHANGE PROPOSAL


