SUBJECT: PROPOSED CHANGES TO METRO BUS SERVICE

ACTION: APPROVE PROPOSED CHANGES TO TIER 1 BUS SERVICE

### RECOMMENDATION

Approve service changes to Tier 1 bus lines scheduled to be implemented in June 2009.

# **ISSUE**

The existing Service Sector Governance Council Policy states that service changes to Tier 1 bus lines must be reviewed and approved by the Board of Directors prior to implementation. The Sector Governance Councils have reviewed and approved the proposed service changes for June 2009, and staff is now seeking board approval to implement the changes as scheduled.

# **POLICY IMPLICATIONS**

The review process was conducted in accordance with the Service Sector Governance Council Policy, and ensures that the proposed service changes are consistent with Metro's Operating Budget, agency plans, agency policy and federal requirements.

### OPTIONS

The Board may decide to approve a subset of the recommended changes or not to approve the recommended service changes. However, this is not recommended as the proposals have been reviewed and approved by the Sector Governance Councils, and lack of approval would have a negative impact on the FY 10 Operating Budget.

# FINANCIAL IMPACT

The proposed changes have been included in the FY10 proposed budget and are consistent with the FY08 Ten-Year Forecast. If not implemented as presented, service enhancements proposed would either not be implemented, or would require additional resources to be implemented. The impact would vary according to the specific proposals that were not approved.

# **DISCUSSION**

In preparation for the June 2009 Service Change, our Service Sectors developed proposed modifications to bus lines operating within their service area. The goal of the program is to implement the new Metro Silver Line 910, restructure service on three local lines and one Metro Rapid Line for the Eastside Gold Line Extension Bus Rail interface, restructure service in the North East San Fernando area, and perform maintenance to underperforming lines. Implementation of the new Metro Silver Line 910 was also considered for implementation in June 2009. However, due to the issues described below we proposed to defer approval of this change until December 2009 service changes. The changes being proposed for June 2009 include modifications to 21 of our Tier 1 bus routes, and14 Tier 2 & 3 the lines as listed in Attachment A. A summary of changes for Tier 1 Lines is as follows:

# Metro Silver Line 910:

The South Bay and San Gabriel Valley Service sectors approved implementing the Implement new Bus Rapid Transit (BRT) Silver Line 910, along the I-10 and I-110 connecting the El Monte Transit Center and Artesia Transit Center. Metro Silver Line 910 would replaces existing Line 444 and Line 446/447 from Artesia Transit Center to downtown Los Angeles via Harbor Transitway and Lines 484 and 490 from El Monte Transit Center to downtown Los Angeles via El Monte Busway. The local segments of Lines 444, 446/447 and 484, 490 would will-continue to operate along the same routing, but will be renumbered as 344, 246 and 184 and 190 respectively.

While this service change has been approved through public hearings by the South Bay and San Gabriel Valley Governance Councils, we propose to delay Board approval until December 2009 service changes given the following reasons:

- Concerns about our fare policy related to the Metro Silver Line and implications to other similar services
- Opportunities to achieve revenue hour savings from the restructure to address the FY10 Structural deficit
- Review integration with Foothill and Metrolink

# Gold Line Extension Bus Rail Interface:

Restructure service on Line 30 Pico/Rimpau, Metro Rapid Line 730 Downtown LA-Pico/Rimpau, Line 68 Downtown LA via Cesar Chavez, and Line 287 Montebello Town Center-Sierra Madre Villa to reduce duplication with the Gold Line Eastside Extension on 1st St and to provide direct bus connections at new rail stations. Additional Tier 2 & 3 service changes will be made to better connect bus and rail services.

Service Restructuring in the North East San Fernando Area:
 Combine northern segment of Metro Rapid Line 724 Sylmar Station-North Hollywood Station with Metro Rapid 794 Downtown LA-Burbank to extend line to Sylmar Station. Shorten Line 94 Downtown LA-Sylmar Station to terminate in Sun Valley and reallocate resources to Metro Rapid Line 794. Remaining segment of Metro Rapid 724 south of Sun Valley will be reallocated to improve service on Metro Local Line 224.

- Other Service Changes:
  - 1) Reallocate Service Based on Demand:
    - a. Improve service on Line 14 Downtown LA-Beverly Hills with resources from Metro Rapid Line 714.
    - b. Implement two-way Owl service on Avalon Bl on Line 51 Avalon/San Pedro St. and discontinue one-way Owl service on Central Ave on Line 53 Downtown LA-CSU Dominguez Hills via Central Ave.
    - c. Reallocate weekend service from Metro Rapid Line 711 Inglewood Transit Center-Bell Gardens to Line 111.
    - d. Adjust service levels on Metro Rapid Line 704 Downtown LA-Santa Monica and consider short line terminal at Santa Monica/Sepulveda.
    - e. Adjust service levels on Metro Rapid Line 920 Vermont/Wilshire Red Line Station-Santa Monica and consider short line terminal at Wilshire/Westwood.
  - 2) Service Restructure:
    - a. Shorten Line 207 Hollywood/Western Station to new north terminal at Sunset & Western.
    - b. Discontinue route segment east of Santa Fe Ave on Line 105 West Hollywood-Vernon. Line 611 will provide alternative service along the affected corridor.
    - c. Extend Line 487 Sierra Madre Villa Station-Downtown LA from the Sierra Madre Gold Line Station via the Line 287 route segment to El Monte Station.

Consistent with Federal requirements and agency policy, the proposals have been reviewed by the public during hearings held the week of February 09, 2009 and have subsequently been approved by their respective Governance Councils.

# **NEXT STEPS**

With Board approval, the service changes will be effective June 28, 2009. Staff will notify customers with on-board brochures describing service changes. Also, new timetables with schedule and route modifications will be available on Metro buses in early June.
