ACE Construction Authority Groundbreaking of Fullerton Road Grade Separation

This morning, Metro Chair John Fasana and I joined LA County Supervisors and Metro Board Members Hilda Solis and Michael D. Antonovich, to celebrate the groundbreaking of the Fullerton Road Grade Separation by the Alameda Corridor East (ACE) Construction Authority. Presenting the LA County Traffic Improvement Plan to the Los Angeles City Council

On Wednesday, I attended the Los Angeles City Council Meeting to give a presentation to the City Council on Measure M, the Los Angeles County Traffic Improvement Plan. I reminded them that LA County is projected to grow by 2.3 million people in the next 40 years and that Metro's Plan is the way to prepare for this growth and raise the funding to meet current and future transportation needs. All 13 of the Los Angeles City Council Members voted to approve a resolution supporting Measure M and the majority of public comment was positive.
