Opening of the Union Station Metro Bike Hub

Metro Board Member and City of Duarte Councilmember John Fasana joined Metro Chief Planning Officer Therese McMillan, project partners and community bike enthusiasts to celebrate the successful grand opening of a new Metro Bike Hub at Los Angeles Union Station. The well attended event introduced the newest secured bike hub which is the largest of three containing 192 bicycle spaces that are under closed-circuit TV surveillance and is operational 24/7. The facility will be staffed 7 days a week to provide cyclist with real-time transit information, a full suite of bicycle-related services such as same-day repairs and accessory sales. I am very excited to see this bike hub become a rendezvous point for our bicycle community as we continue to support and grow our transportation modes in downtown LA.

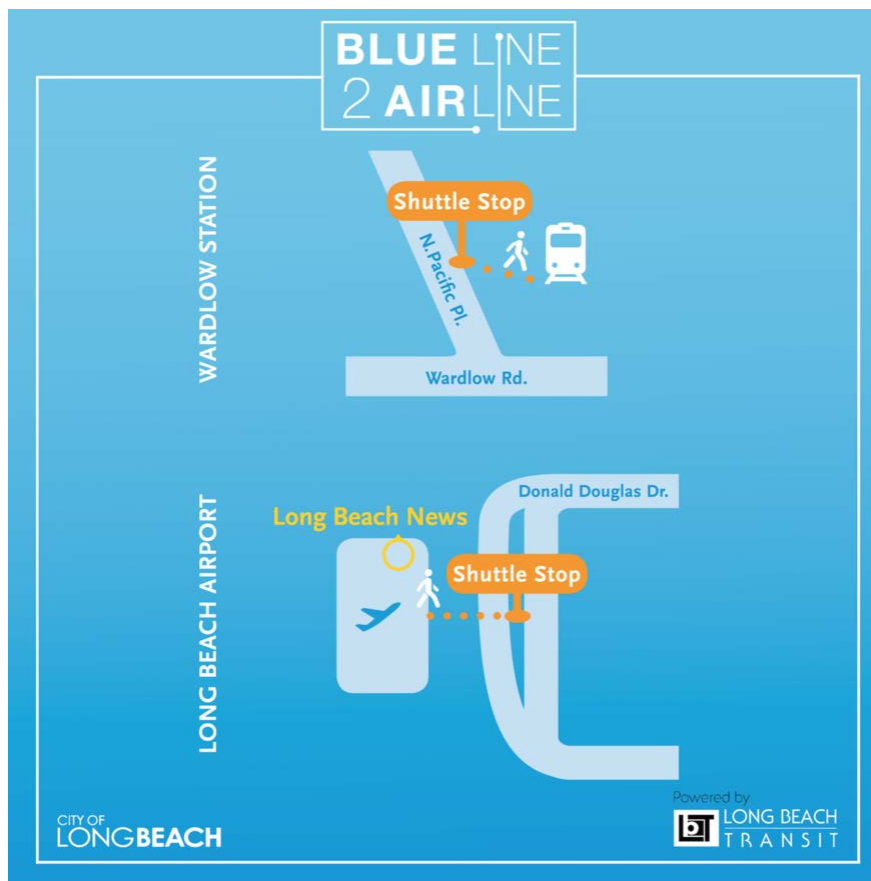
The Union Station Metro Bike Hub will provide a first mile/last mile connection to transit for our multi-modal customers. Our friendly staff will be available Monday through Friday from 8:00 a.m. to 6:00 p.m. and on weekends from 10:00 a.m. to 6:00 p.m. Memberships will be a low cost \$5 weekly, \$12 monthly and \$60 yearly which will provide access to this facility as well as our other bike hubs at El Monte Station and Hollywood/Vine Metro Red Line Station. Congratulations and thank you to Project Manager Anthony Jusay from our Active Transportation Planning department and his team for bringing this project to life.



Blue Line 2 Airline: More Mobility Options for Your Holiday Travels

This past Saturday, our transportation partners at Long Beach Transit began offering free express bus connection between the Metro Blue Line Wardlow station and the Long Beach Airport. This is the first time a direct connection has allowed travelers to board and depart at zones within the Long Beach Airport and directly at a Metro Blue Line station.

Service frequency will be every 30 minutes, from 5:45 a.m. to 8:15 p.m. daily continuing through the Holidays until Sunday, January 7, 2018. This is a great initiative to combat Holiday traffic, vehicle emissions and travel-stress, and I commend Long Beach Mayor and Metro Board Member Robert Garcia, Long Beach Transit and the airport for making this express shuttle to the Blue Line happen.



COMTO Reshaping Transportation Panel

The Southern California Regional Chapter of the Conference Of Minority Transportation Officials (COMTO) hosted a panel discussion “Improving and Reshaping Transportation in Southern California” last week, at the Port of Long Beach Administrative Offices. Metro Deputy CEO Stephanie Wiggins participated in the panel discussion along with other transportation leaders, and Long Beach City Councilmember Al Austin II delivered the keynote address. The audience had the opportunity to listen to discussions regarding transportation funding, innovative technology, community access and project acceleration.

Traction Gear Unit Overhaul (IFB)

Metro released an Invitation for Bid (IFB) to procure A650 Traction Gear Unit Overhauls including spare parts. The procurement process blackout period is expected to run from Wednesday, November 15, 2017 through Thursday, March 30, 2018.

The procurement is for the overhaul of 296 each A650 Traction Gear Units including spare parts, on the Red Line A650 (Option) Heavy Rail Vehicle (HRV) which is a part of the planned A650 overhaul program.

Semi-Permanent Drawbar Assembly Overhaul (IFB)

The procurement is for the overhaul of 37 each A650 Semi-Permanent Drawbar Assemblies including spare parts on the Red Line A650 Heavy Rail Vehicle (HRV) which is a part of the planned A650 overhaul program.

Power Sweeping Services (IFB)

The procurement process blackout period is expected to run from Wednesday, November 29, 2017 through Thursday, February 22, 2018.

This Statement of Work (SOW) involves, among other things, the replacement of large industrial batteries, removal and installation of large emergency fan motors and transformers.

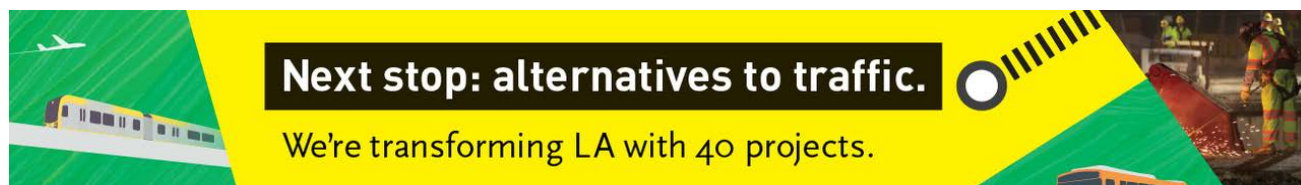
