ARRESTS

Due to an inconsistent tracking method of arrests utilized by Support Service personnel, accurate arrest information cannot be provided. As mentioned in last month's report, an individual arrested and then cited & released has been tracked as a citation. An "arrest" has been documented as an "arrest" only if the suspect was physically "booked" into a facility. Therefore, during the month of August only 24 arrests were documented for Blue Line, 12 for Red Line and 5 for Green Line. The tracking system has been corrected and accurate arrest information for September will be provided in next month's report.




