
























Running Hot - Systemwide and Bus Operating Divisions 6, 7 and 10

MEAN MILES BETWEEN TOTAL ROAD CALLS (MMBTRC)*



Maintenance Attendance - By Sectors' Divisions (By Current Month) September - November 2006






