




BUS TRAFFIC ACCIDENTS PER 100,000 HUB MILES Systemwide and Bus Operating Divisions 8 and 15































MEAN MILES BETWEEN TOTAL ROAD CALLS (MMBTRC)*







Past Due Critical PMs - by Sectors' Divisions August - October 2006





Maintenance Attendance - By Sectors' Divisions (By Current Month) August - October 2006








