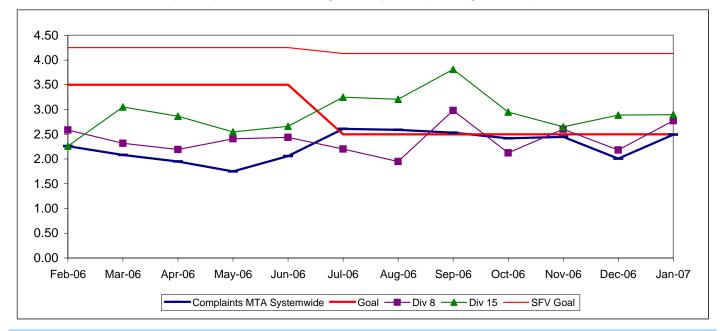

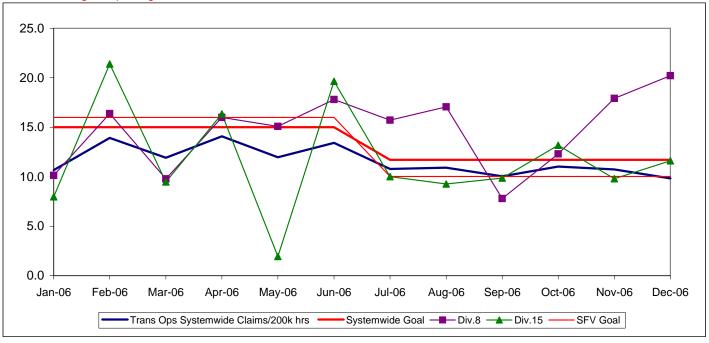

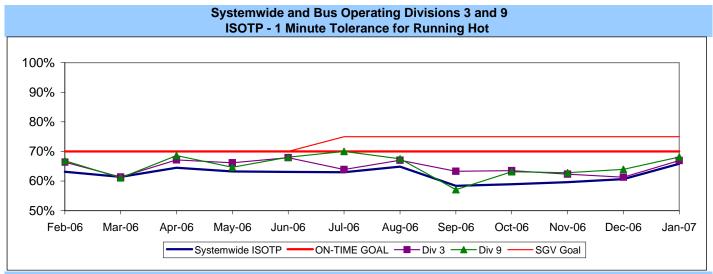

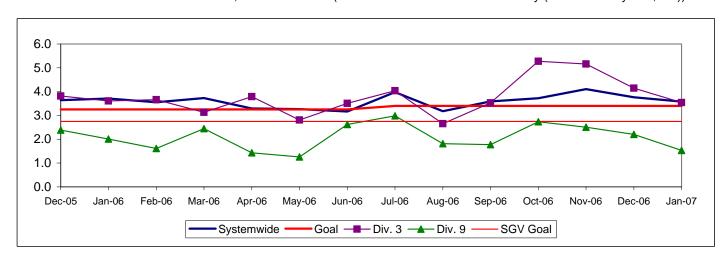

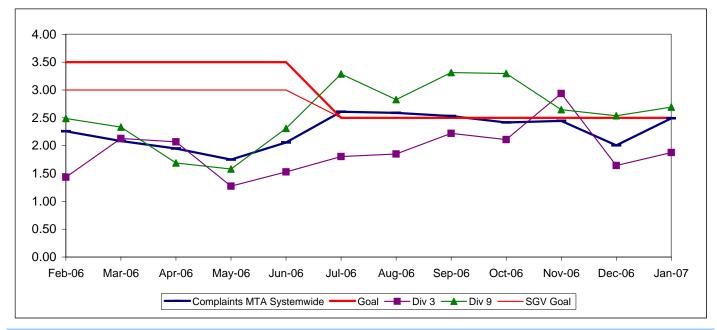

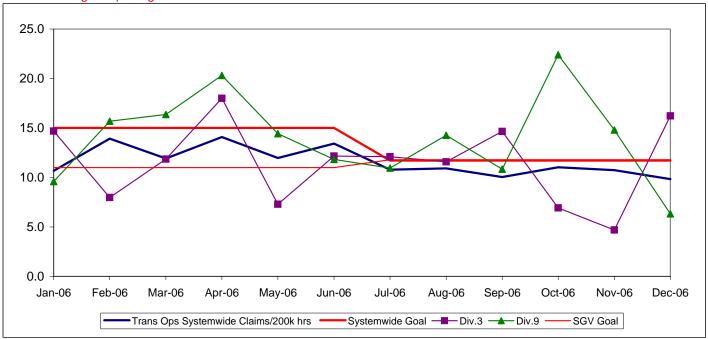

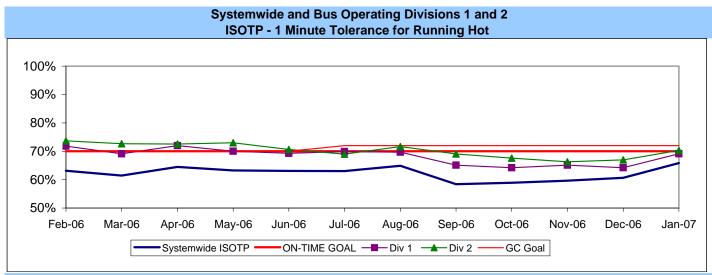

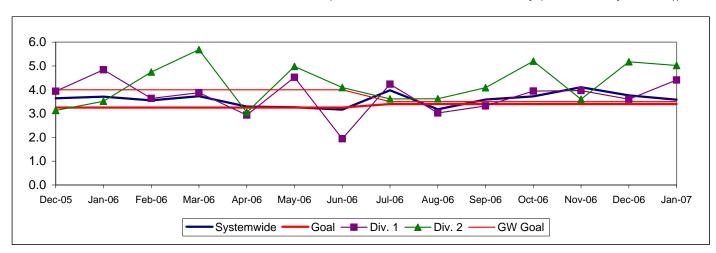
Running Hot - Systemwide and Bus Operating Divisions 1 and 2

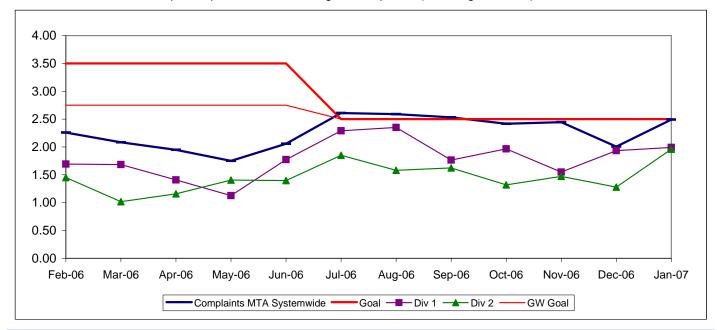

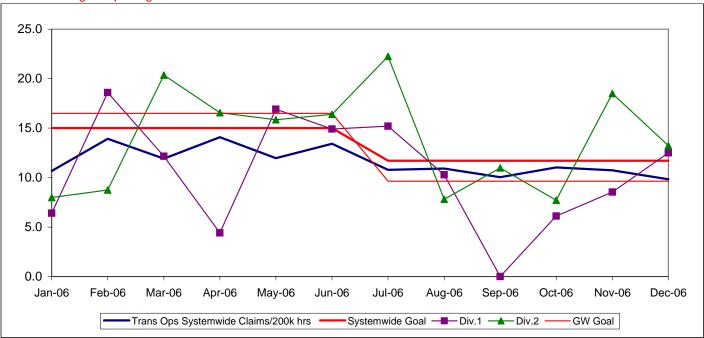

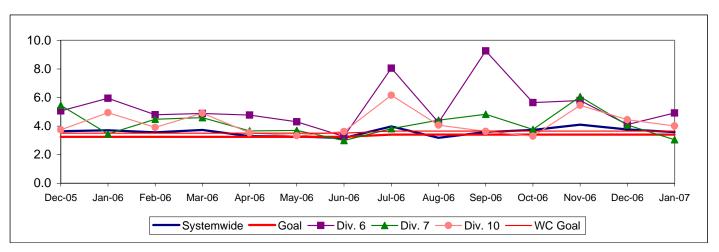

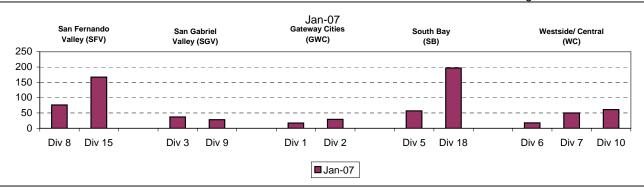
MMBMBF -- Bus Operating Sector Divisions November 2006-January 2007

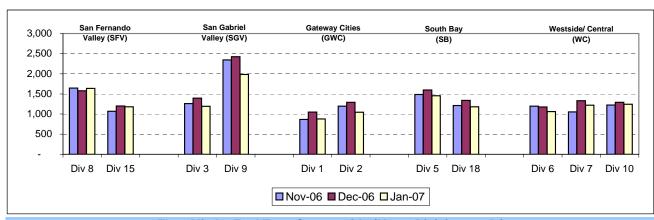

Maintenance Attendance - By Sectors' Divisions (By Current Month) November 2006 - January 2007

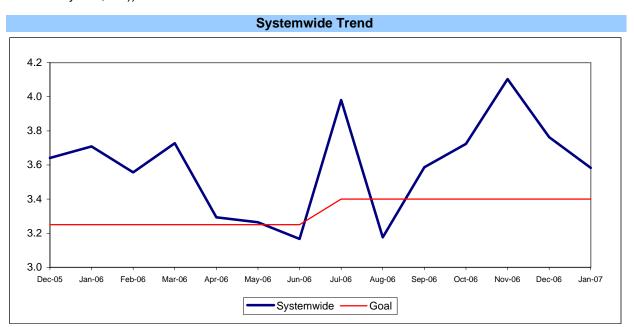
