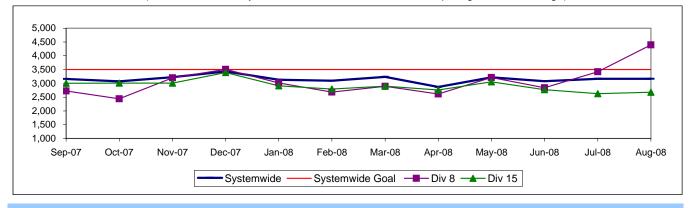

MEAN MILES BETWEEN MECHANICAL FAILURES REQUIRING BUS EXCHANGE Systemwide and Divisions 8 and 15

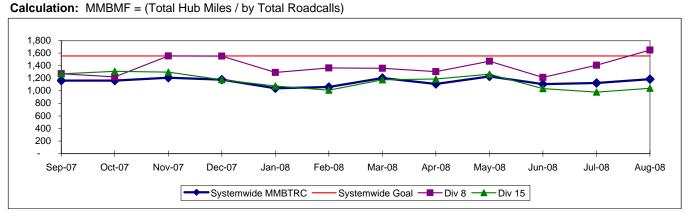

MEAN MILES BETWEEN TOTAL ROAD CALLS Systemwide and Divisions 8 and 15

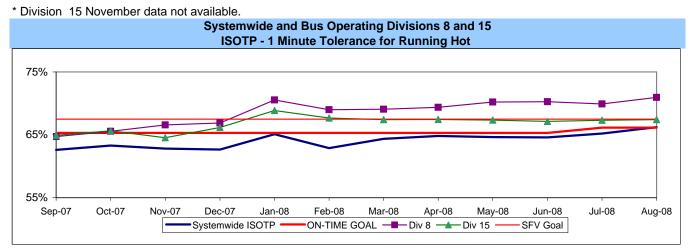

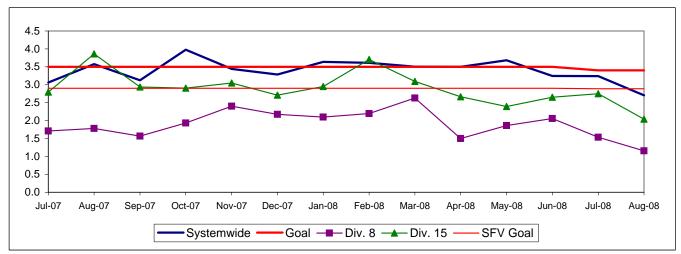

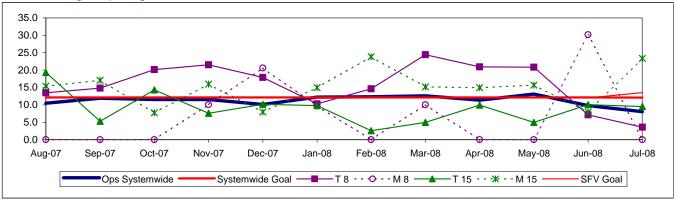

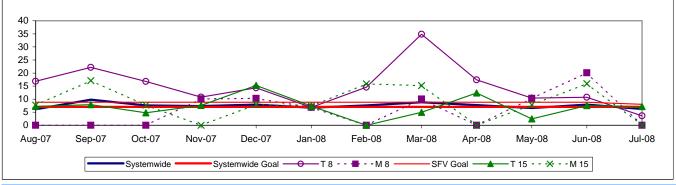

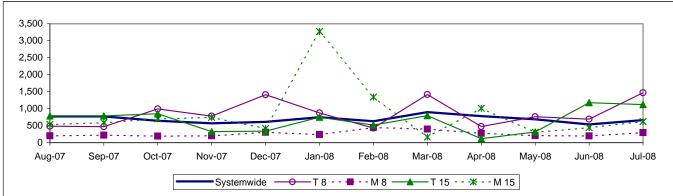

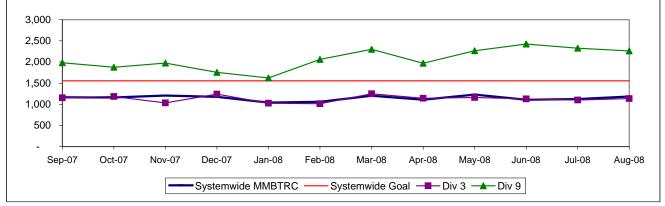

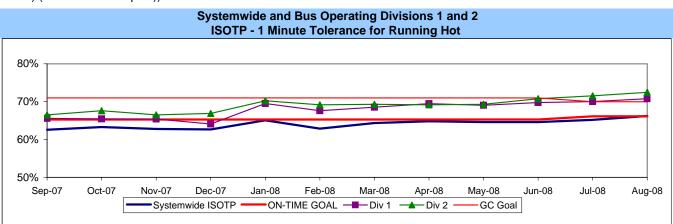

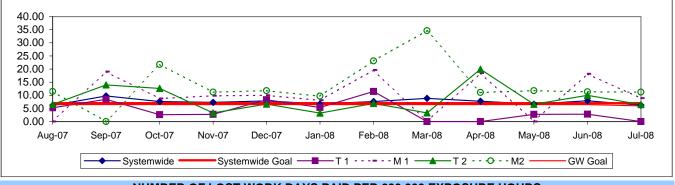

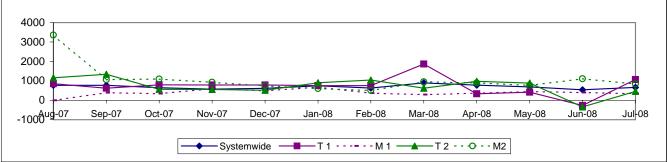

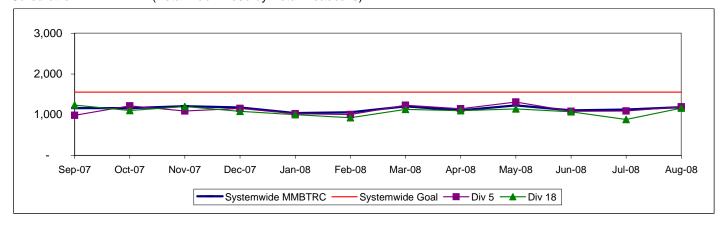

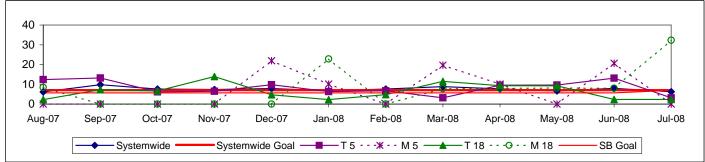

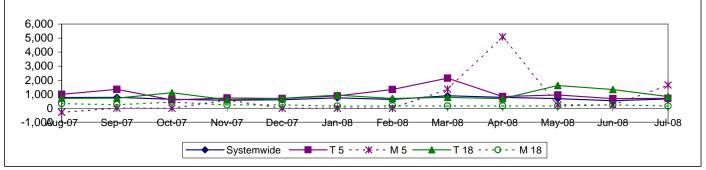

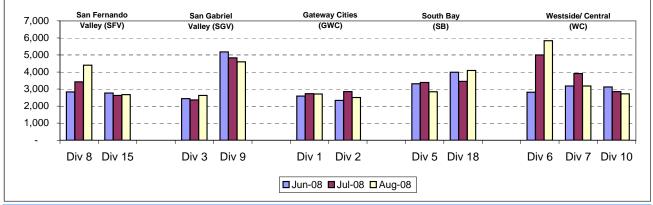

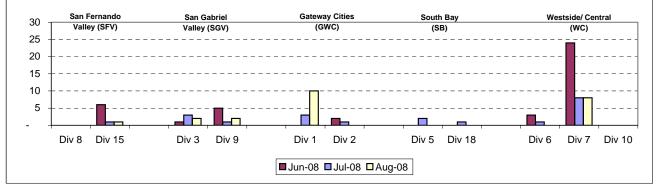
MMBMBF -- Bus Operating Sector Divisions June - August 2008

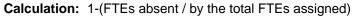


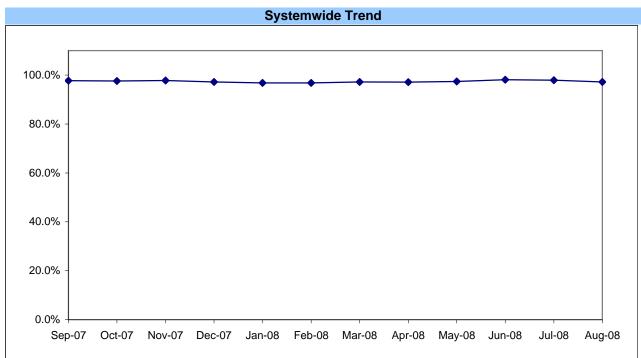
Past Due Critical PMs - by Sectors' Divisions

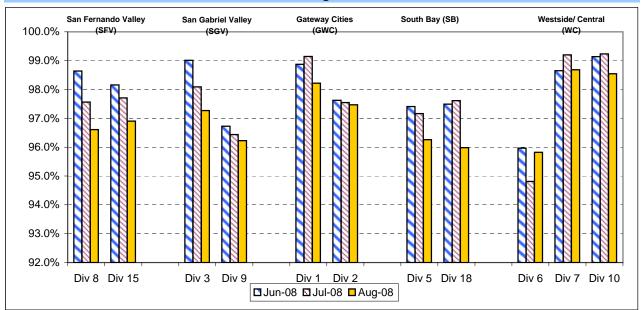

Maintenance Attendance - By Sectors' Divisions (By Current Month) June - August 2008



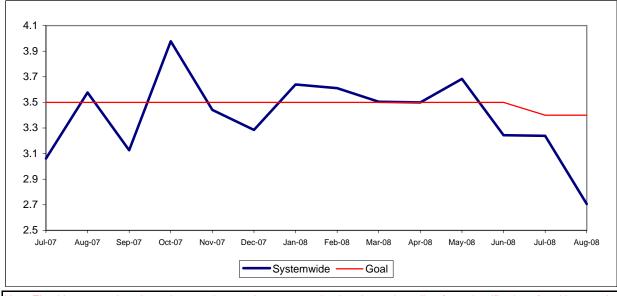

LWD/200,000 Exposure Hours per Operating Divisions - by Sectors' Divisions May - July 2008

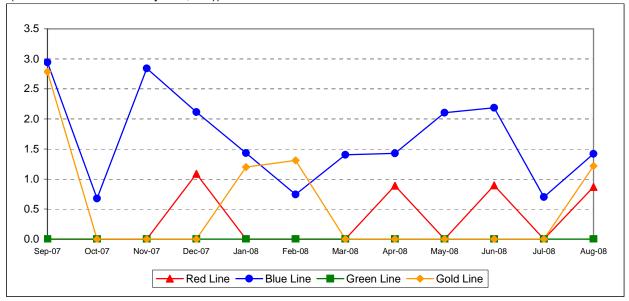

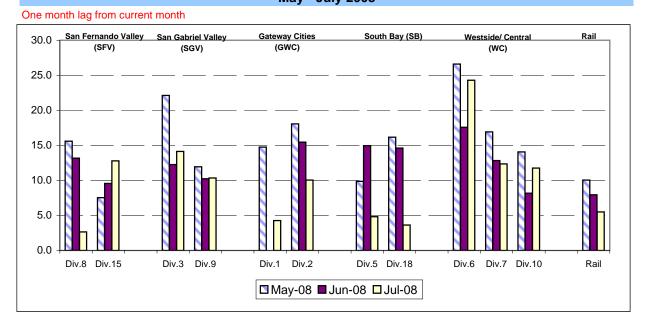

Bus & Rail - by Bus Sectors' Divisions and Rail May - July 2008

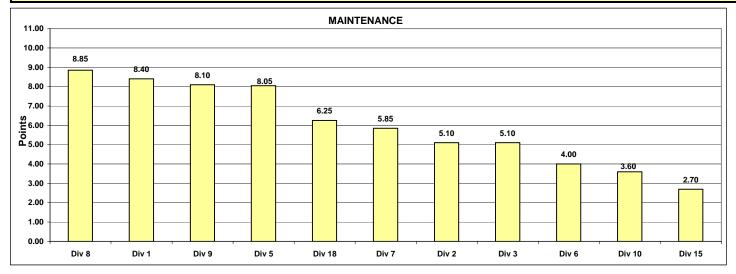

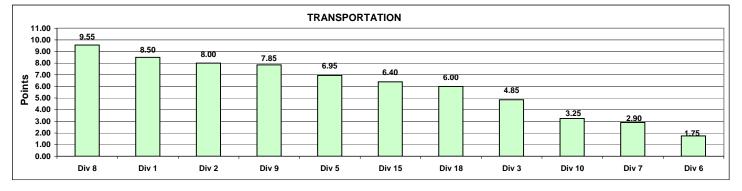
