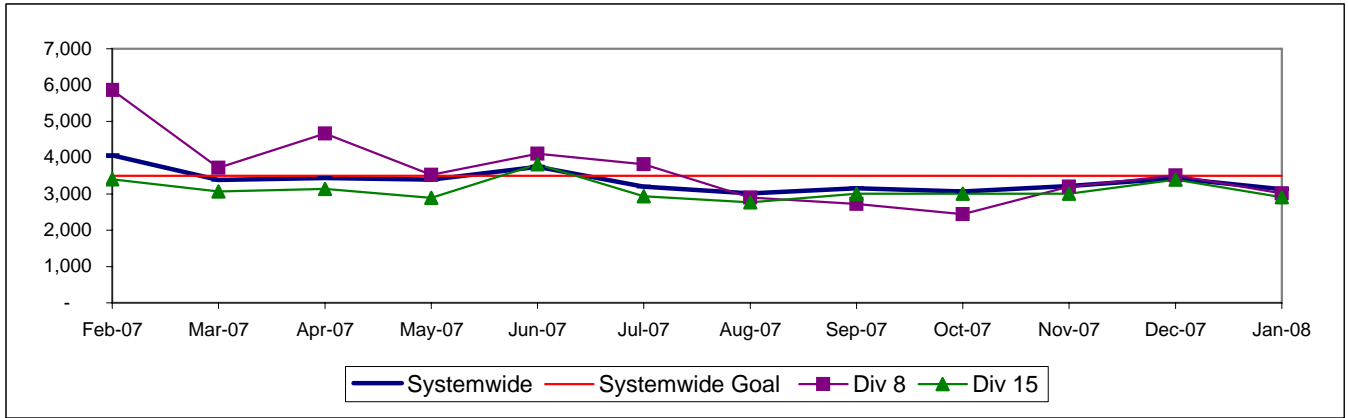

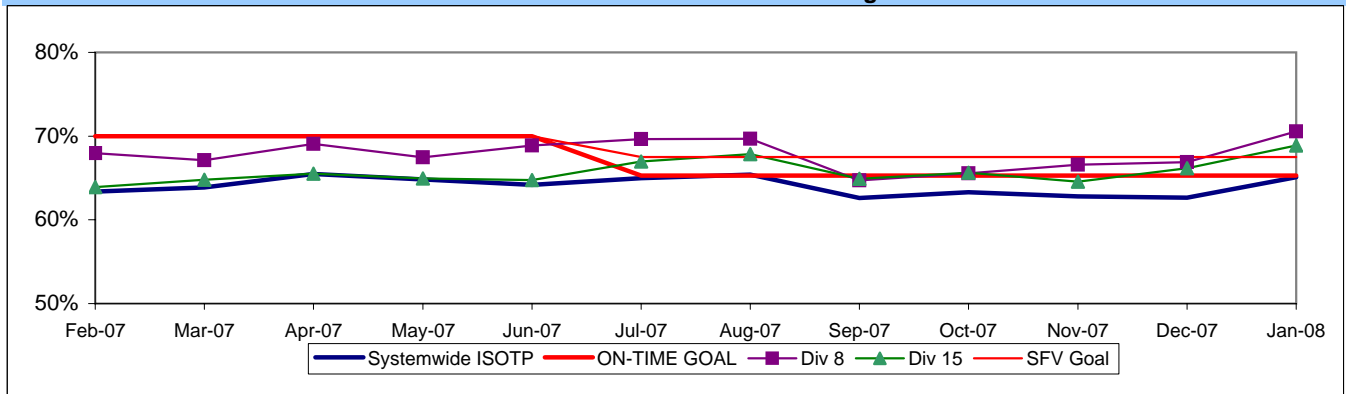

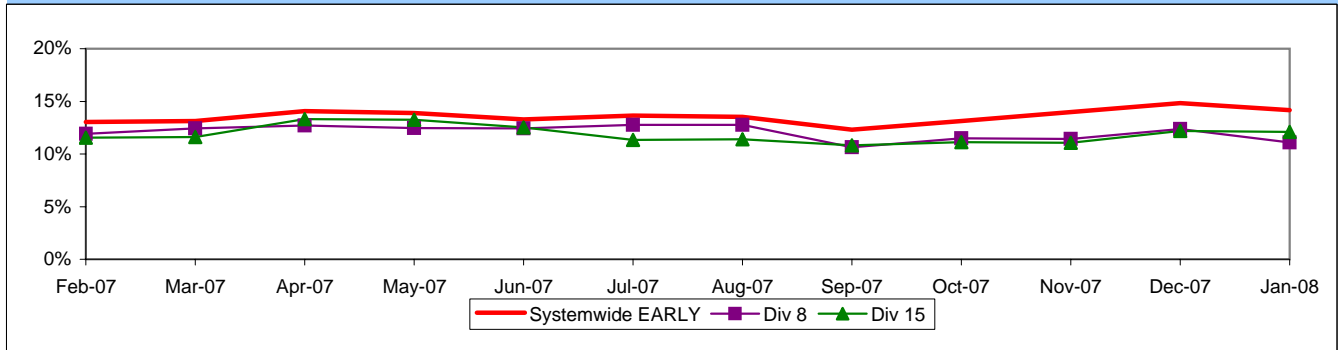

Systemwide and Bus Operating Divisions 8 and 15 ISOTP - 1 Minute Tolerance for Running Hot



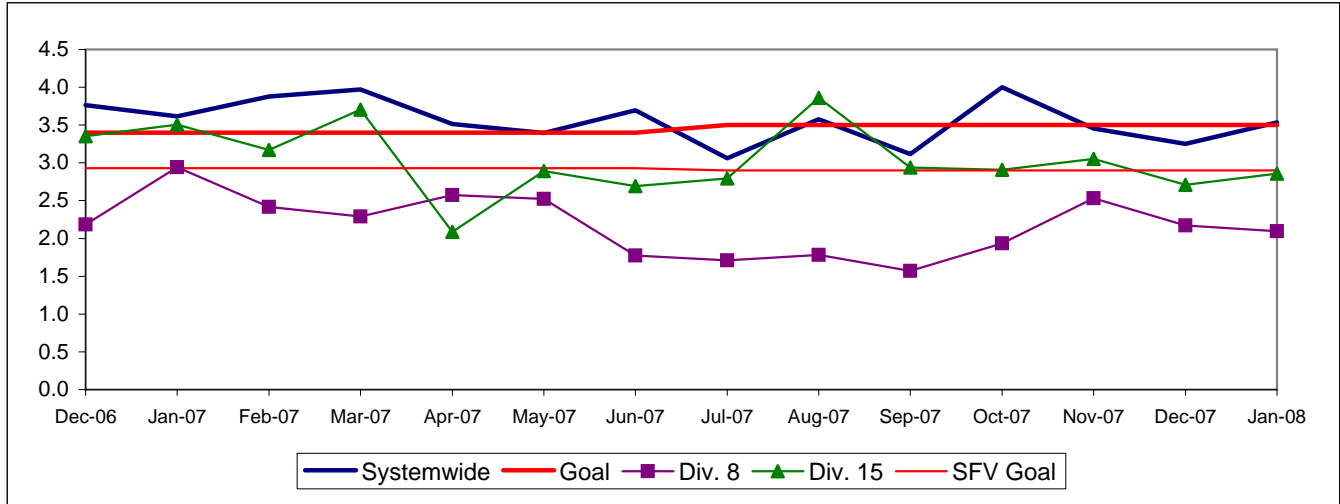
Running Hot - Systemwide and Bus Operating Divisions 8 and 15

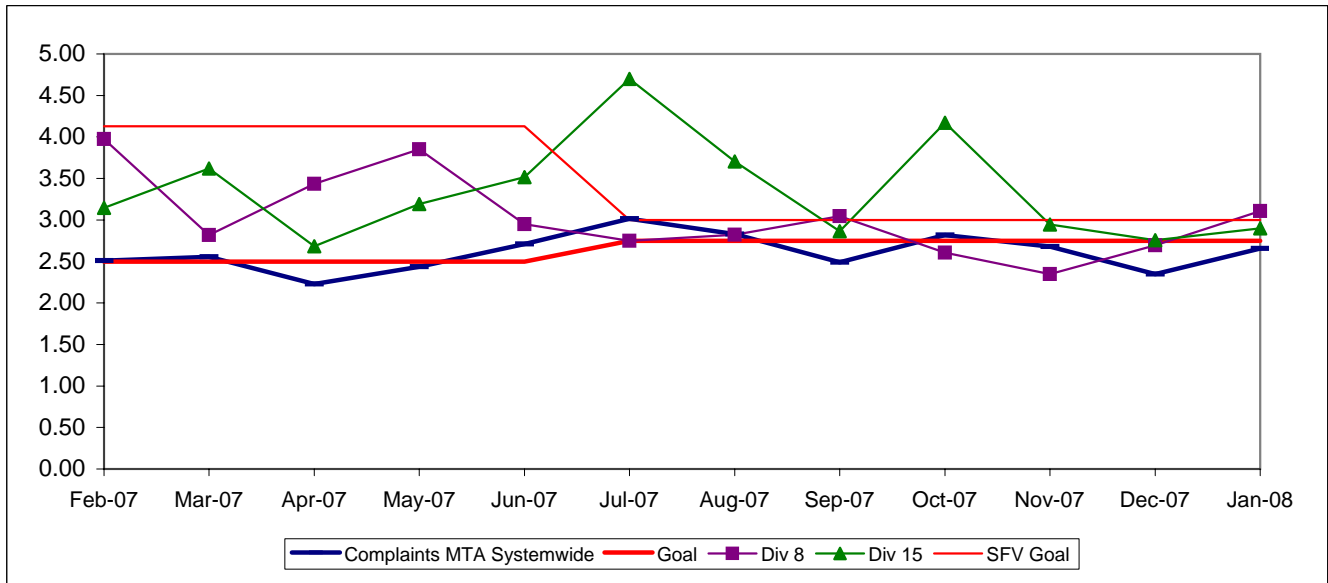

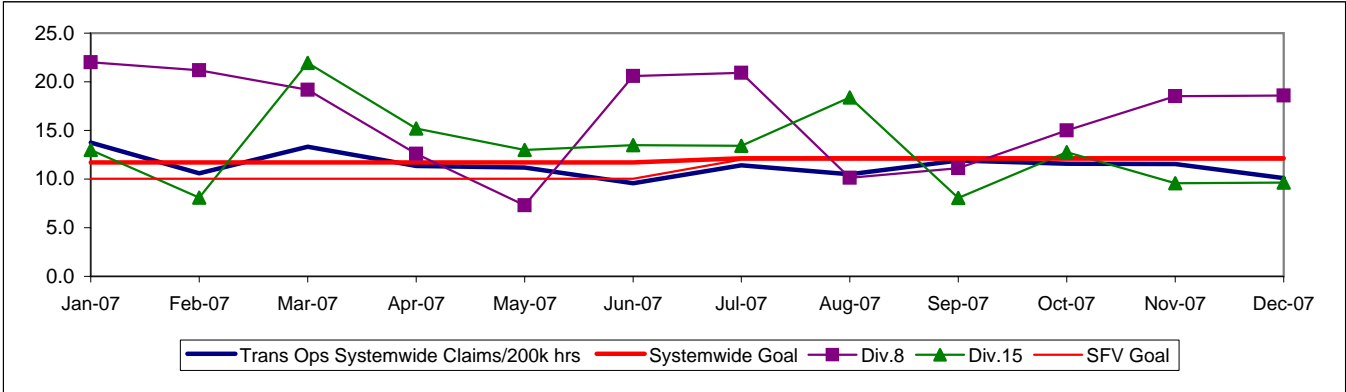

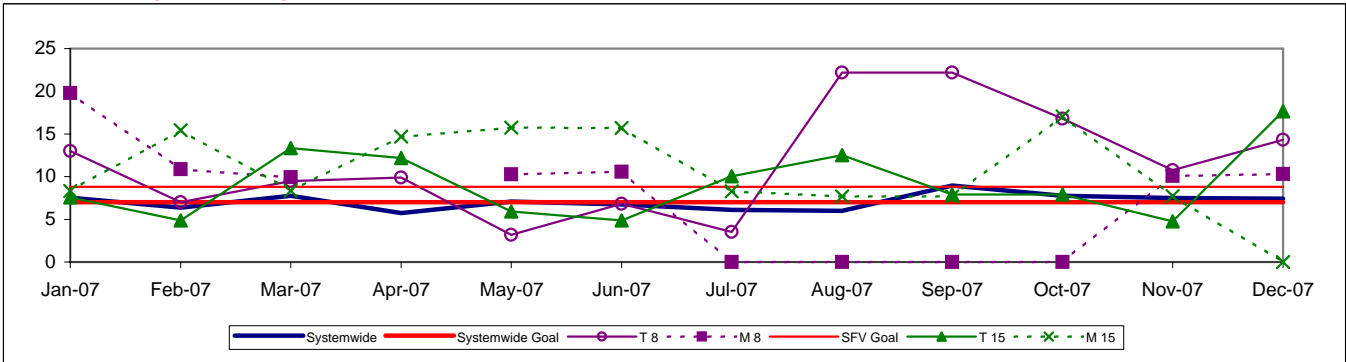

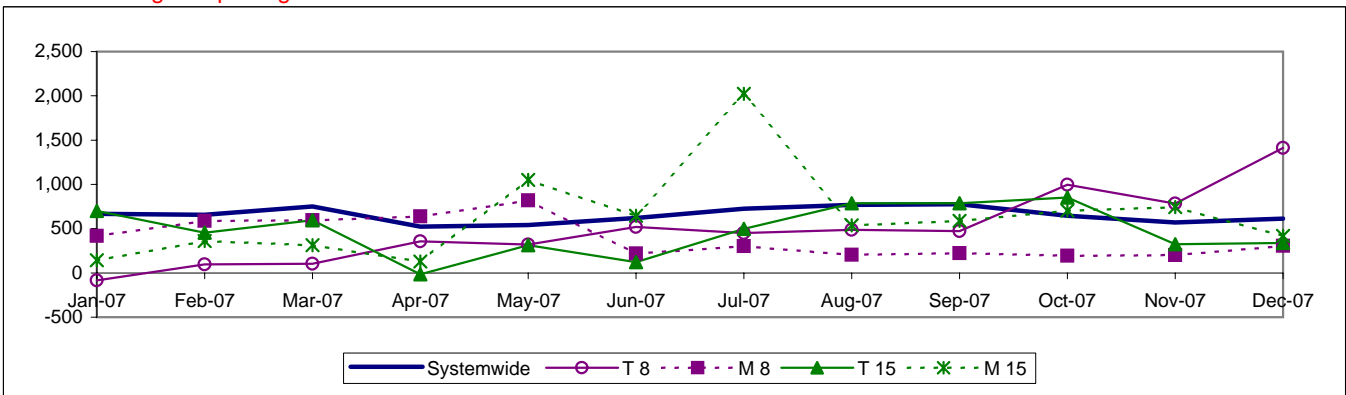

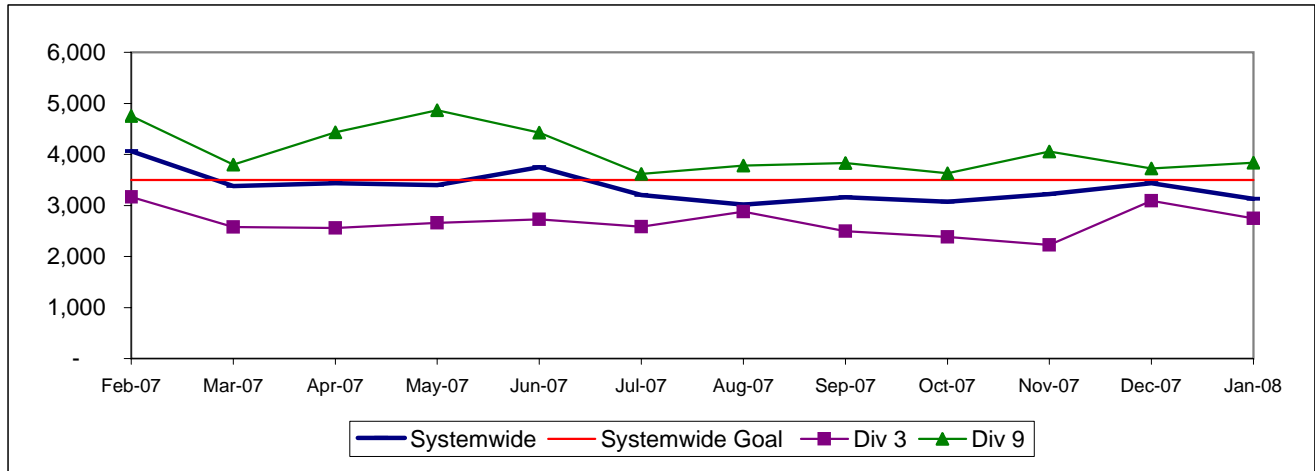

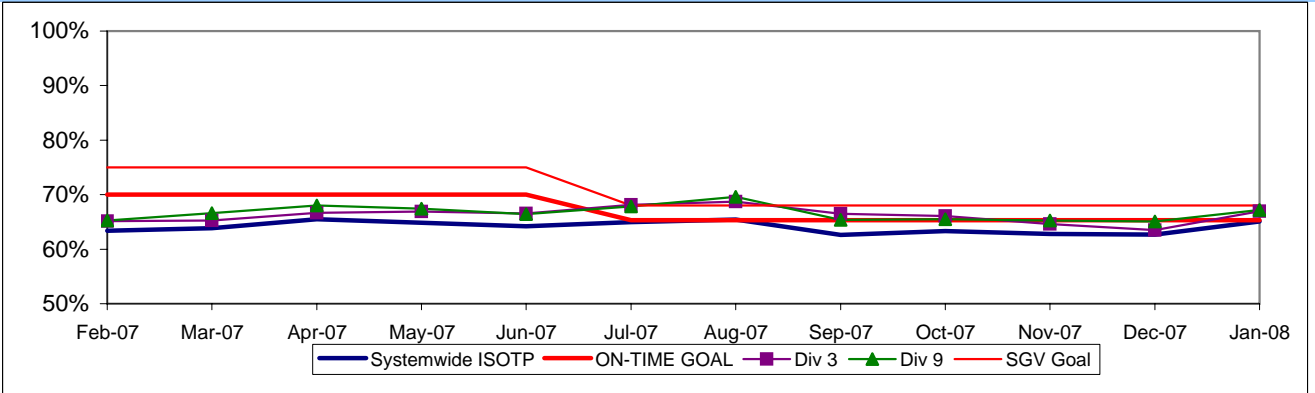

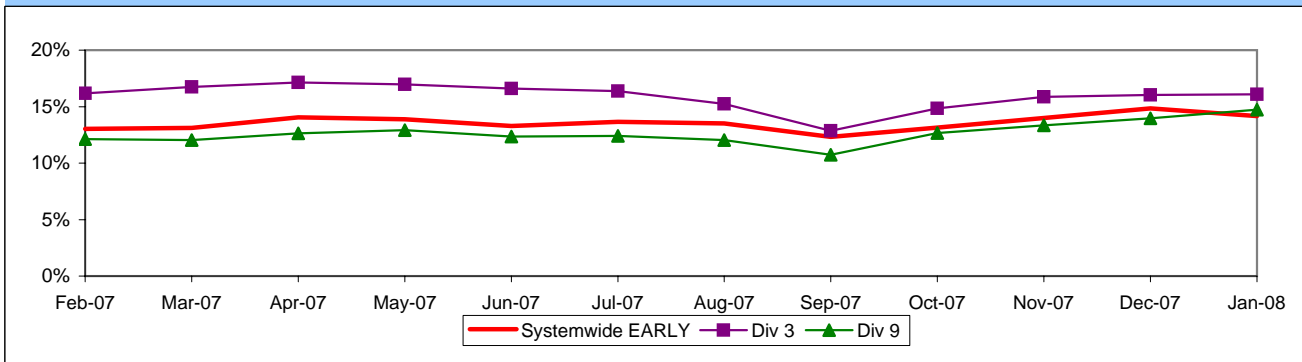

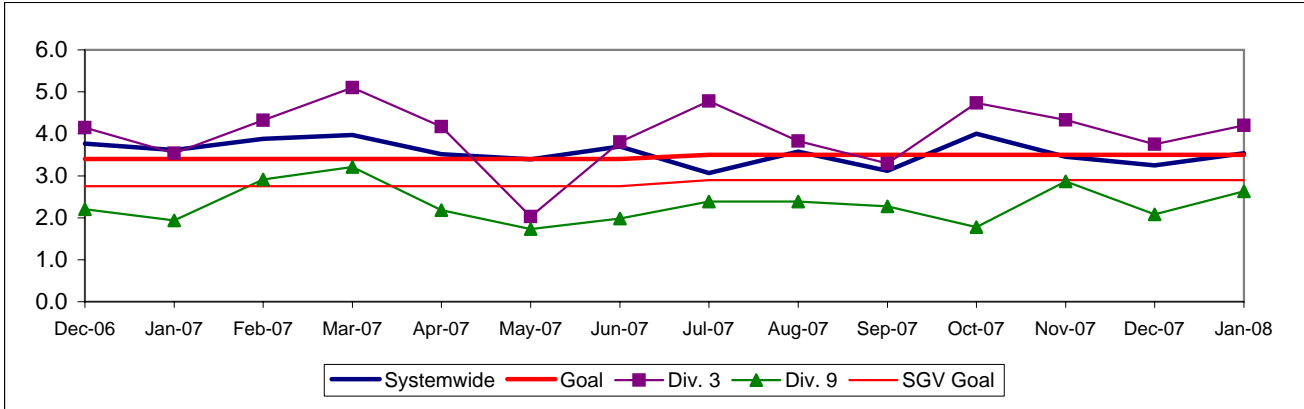

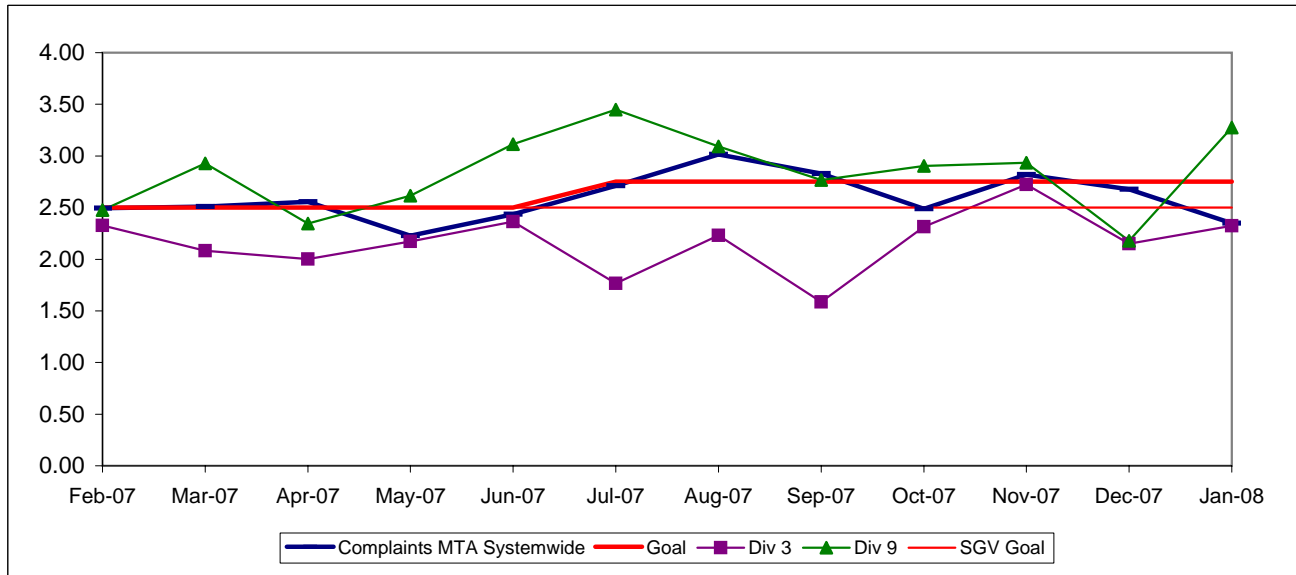

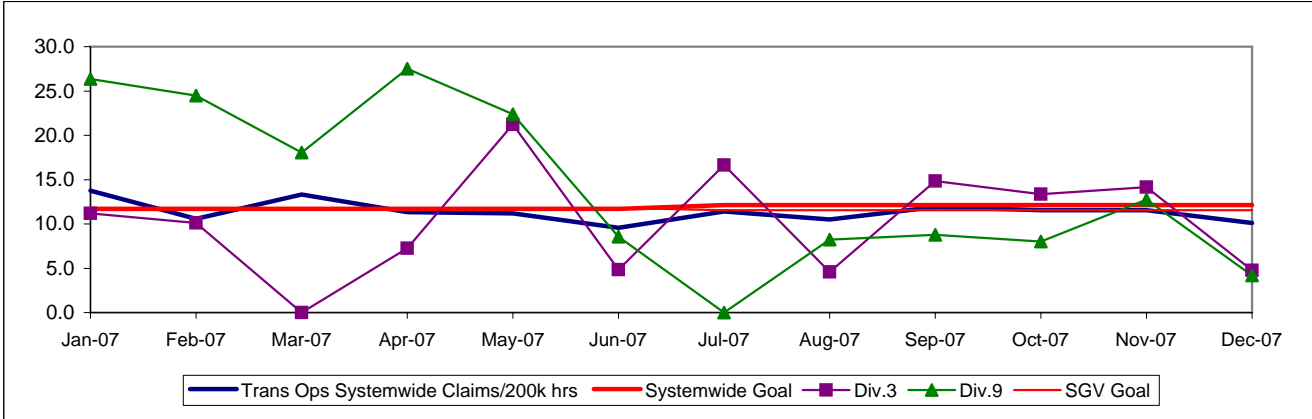

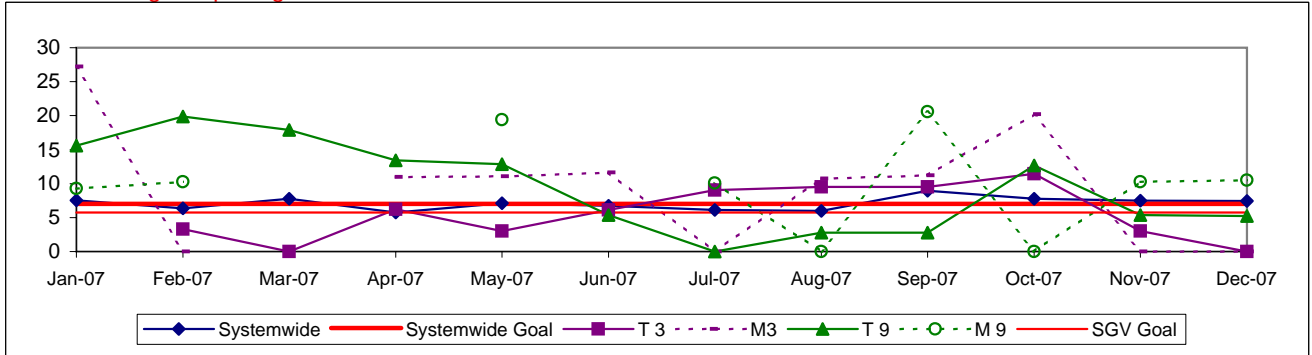

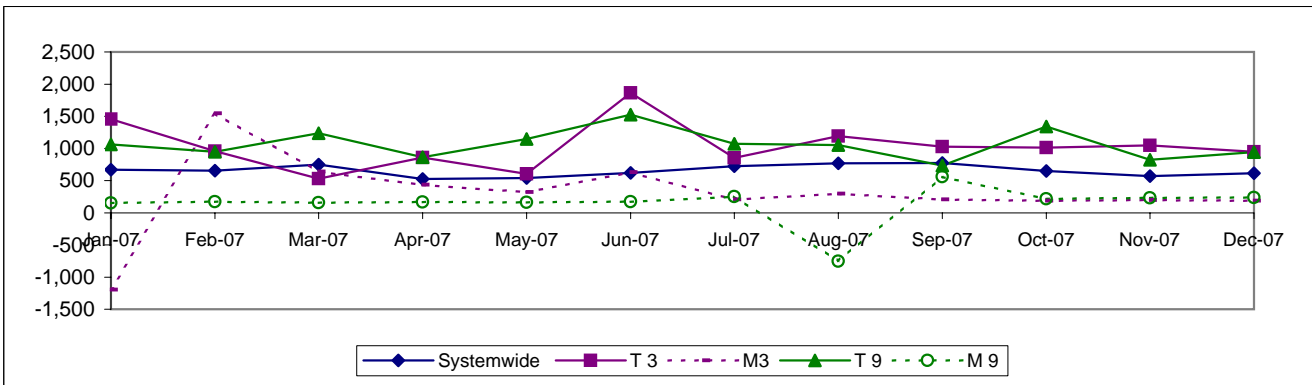

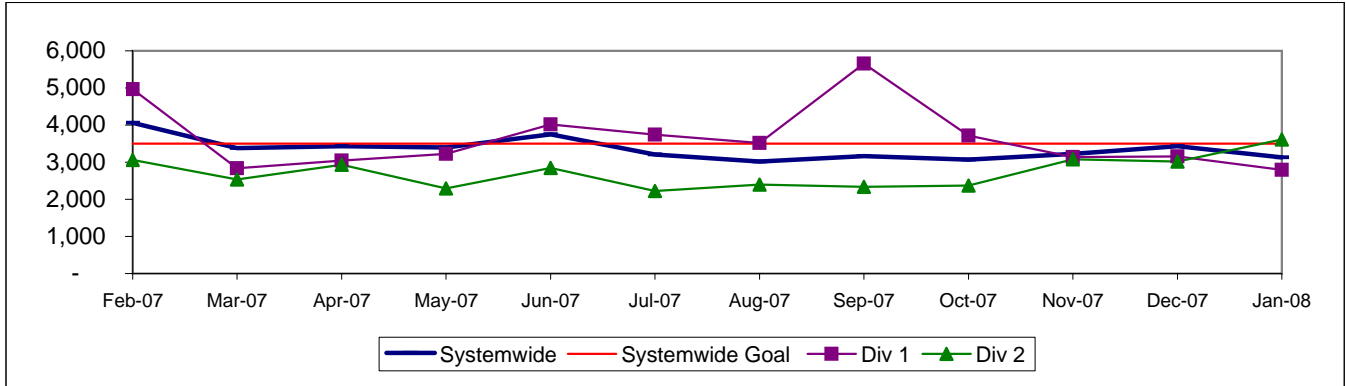

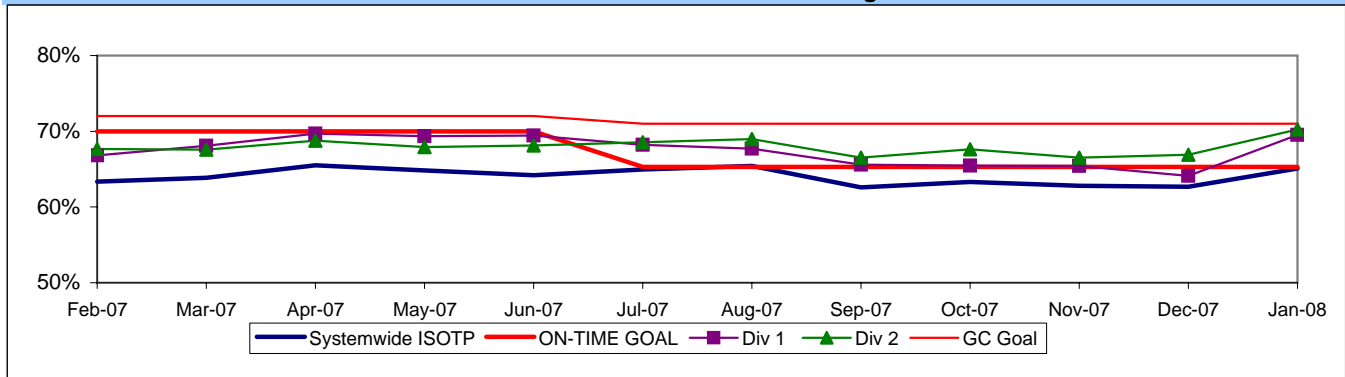

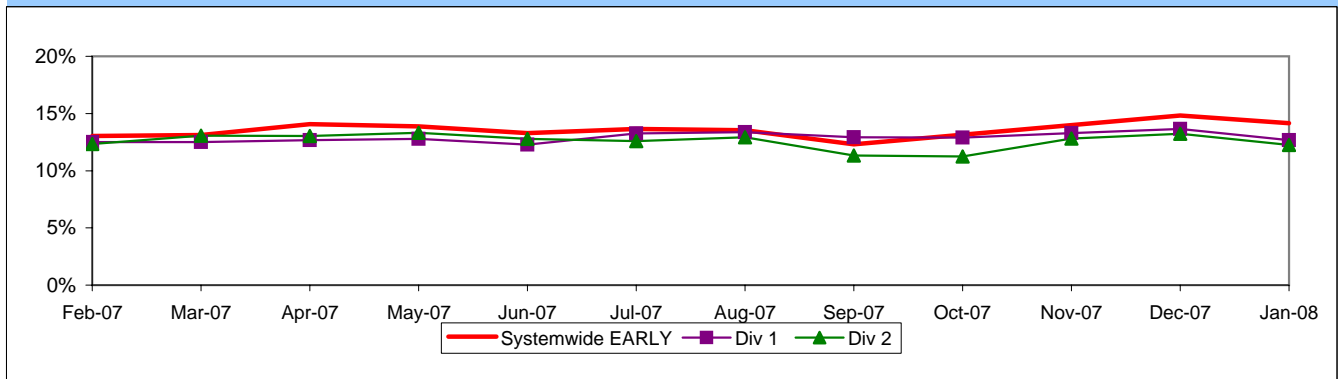

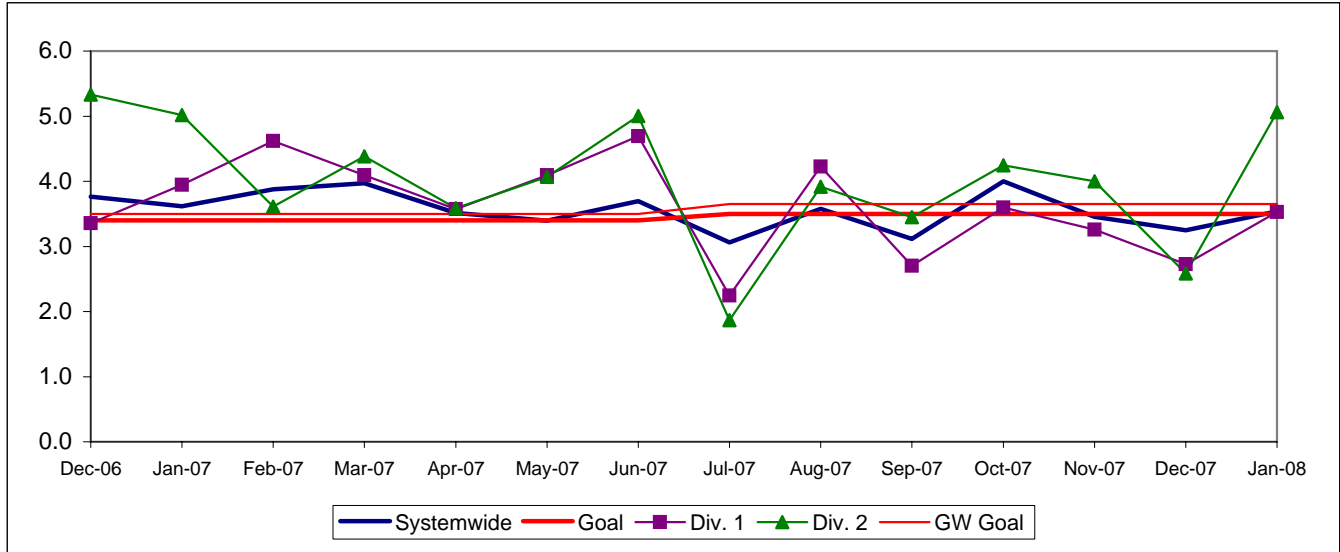

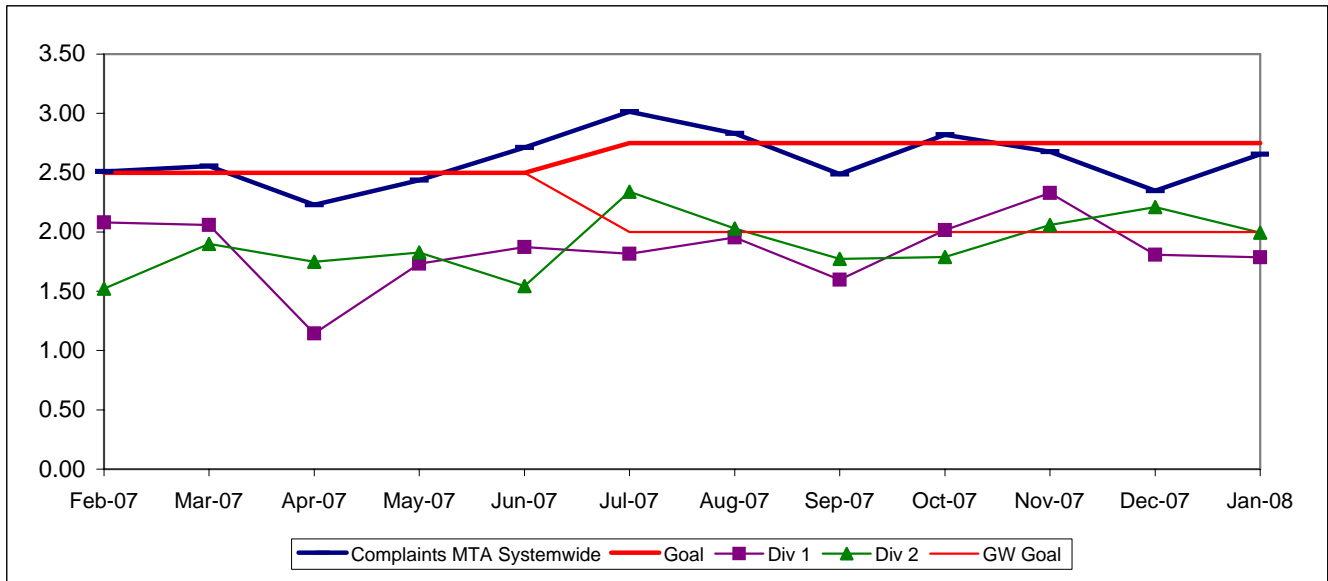

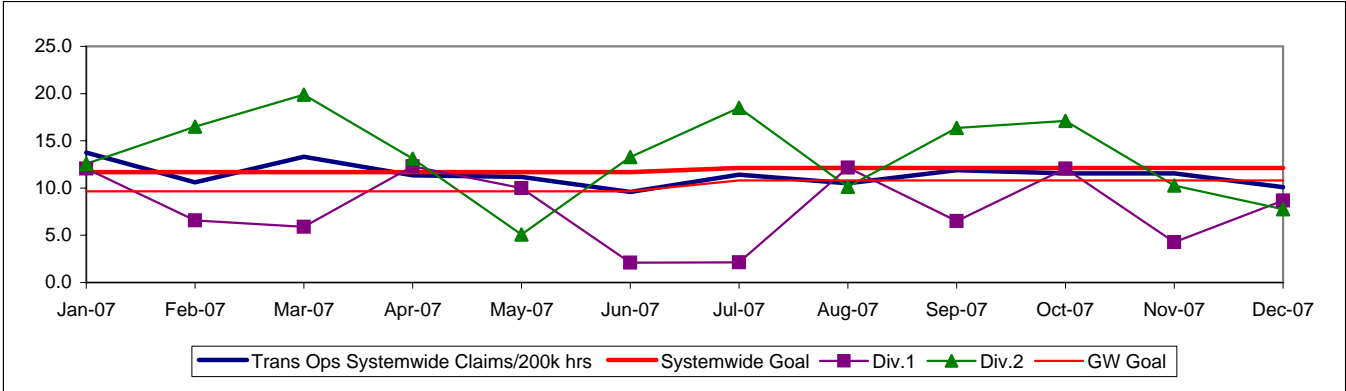

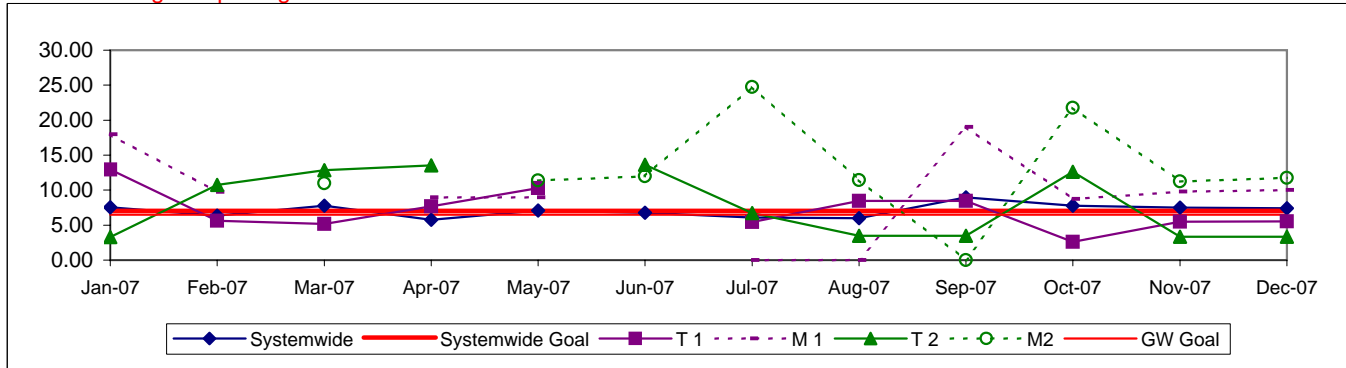

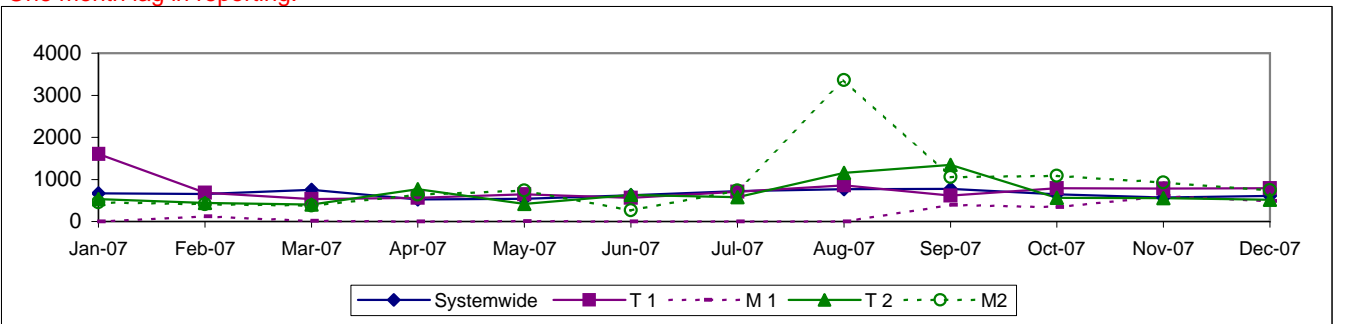

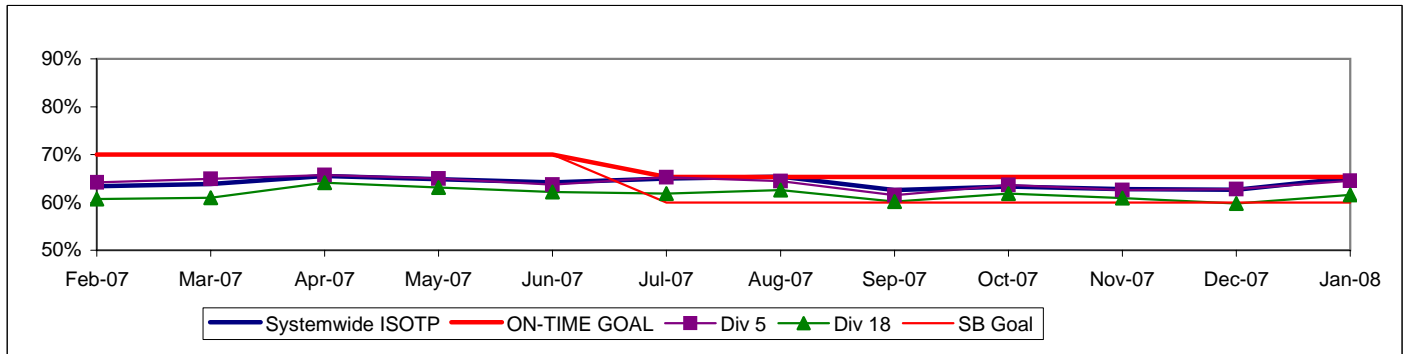

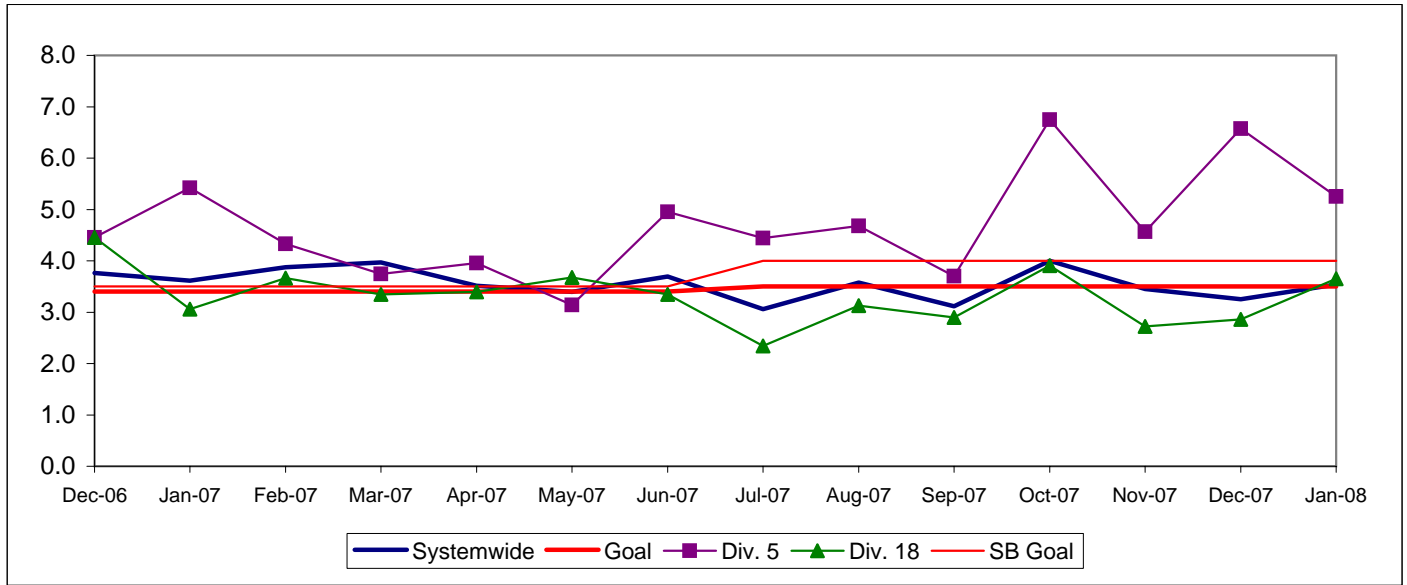

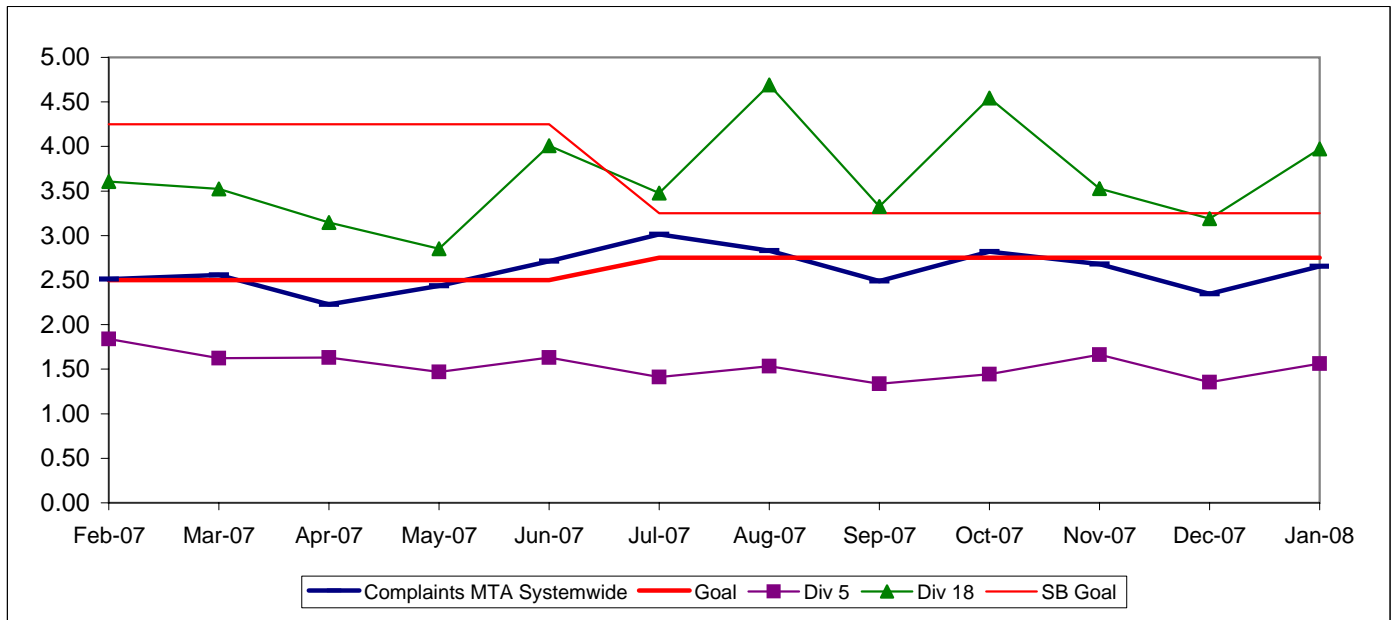

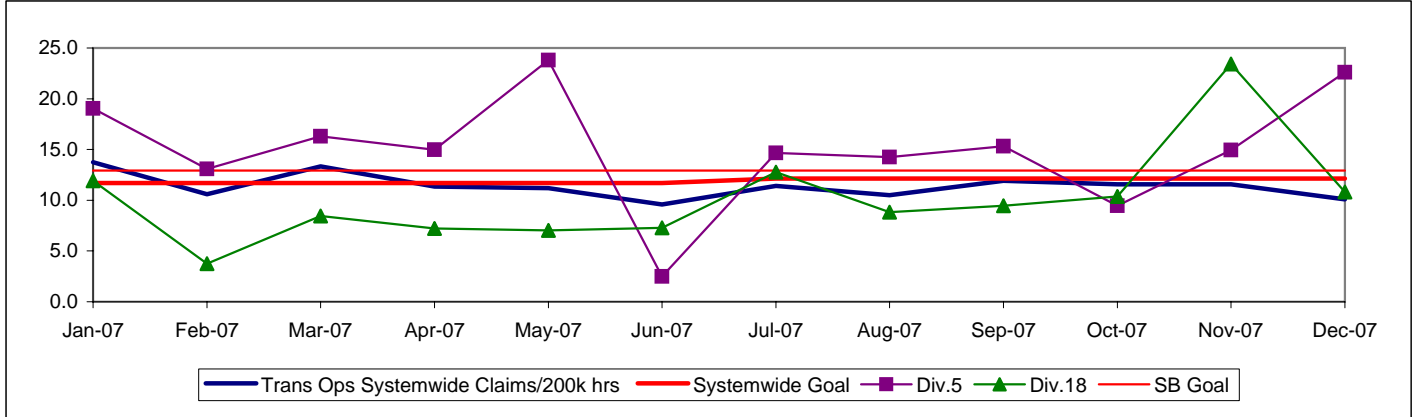

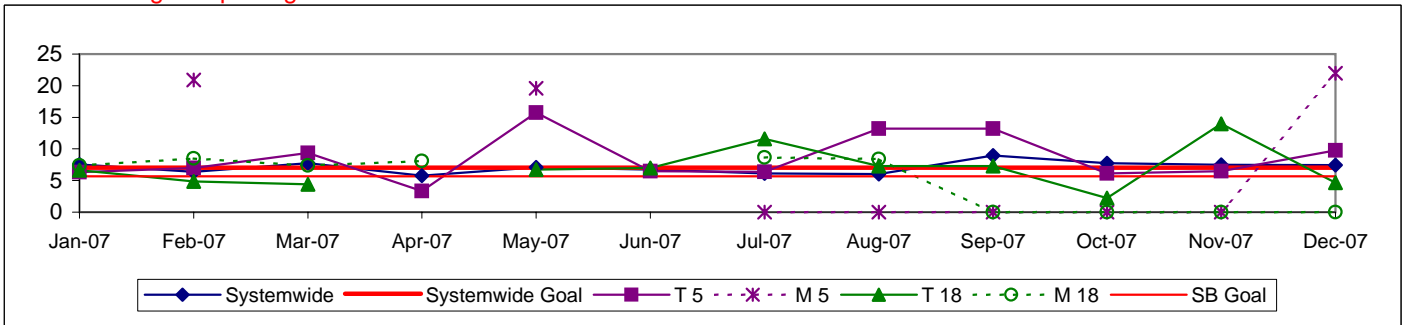

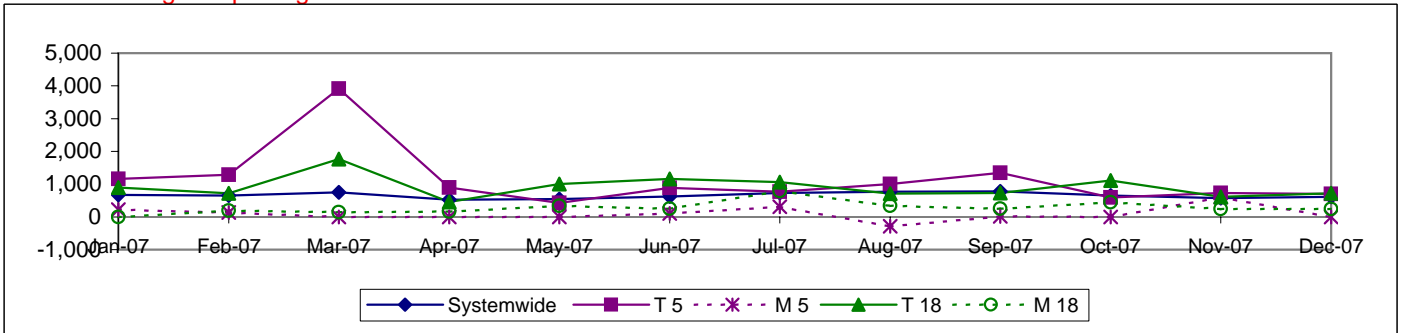

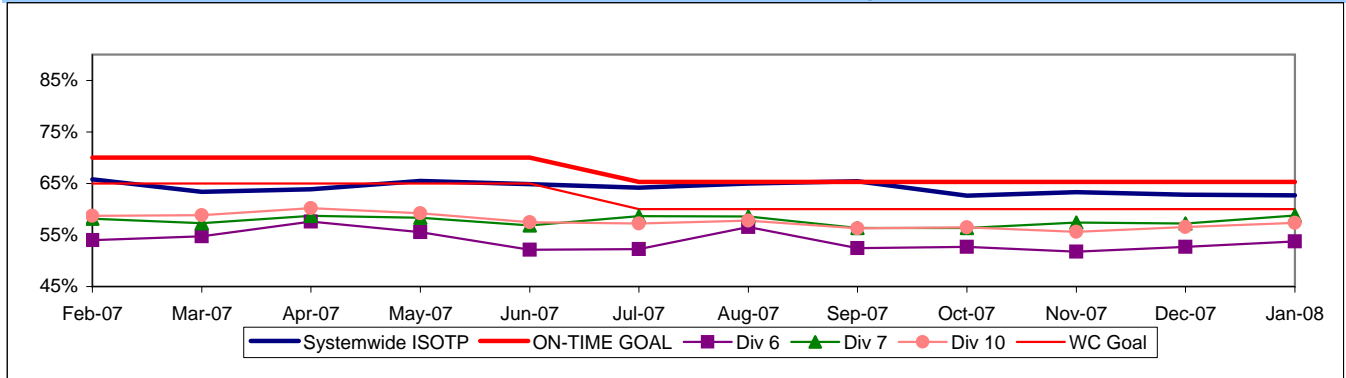

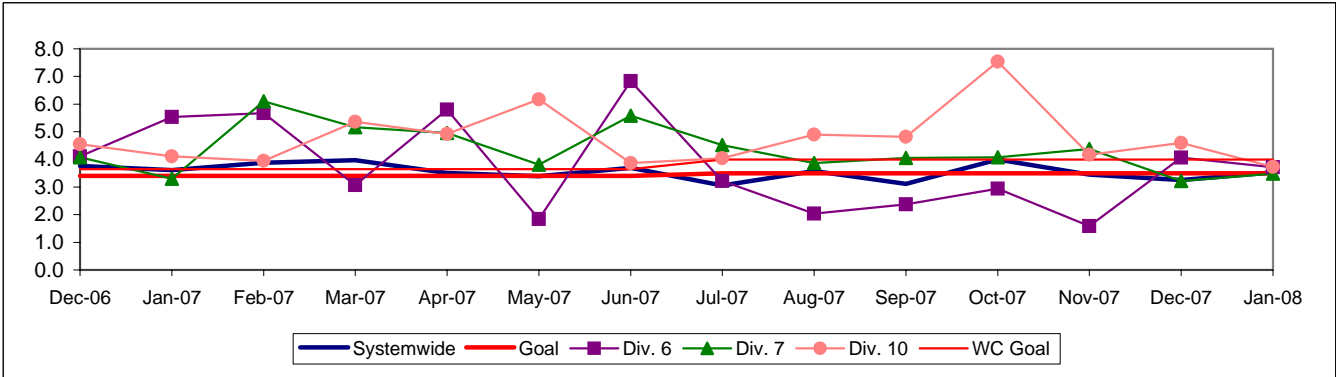

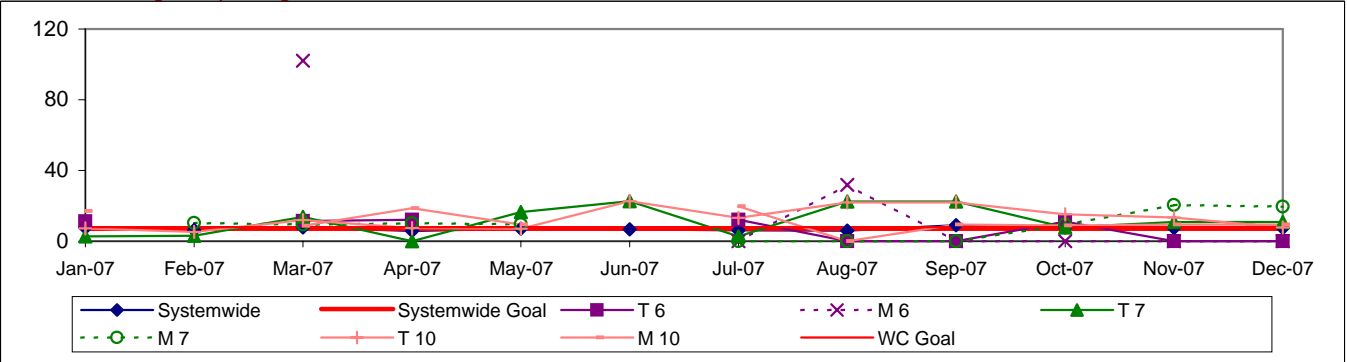

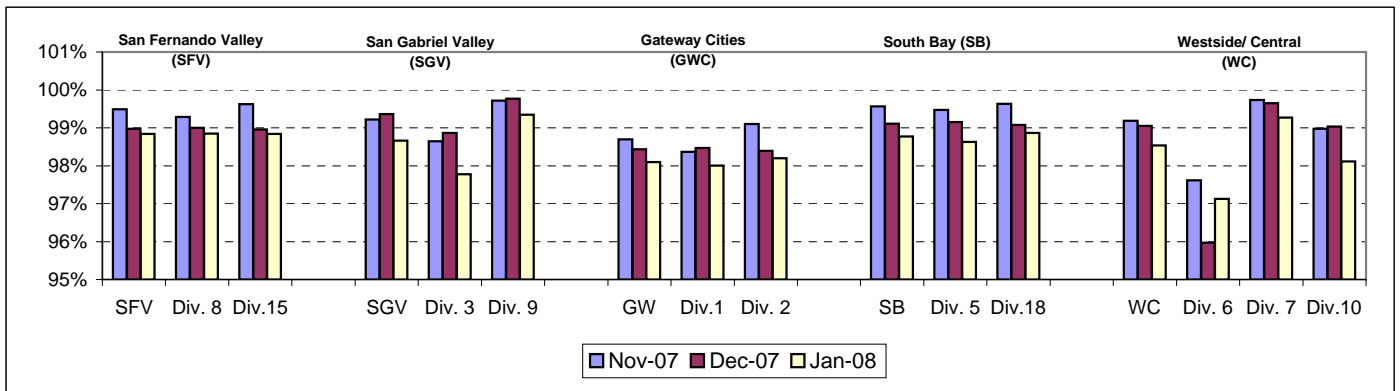

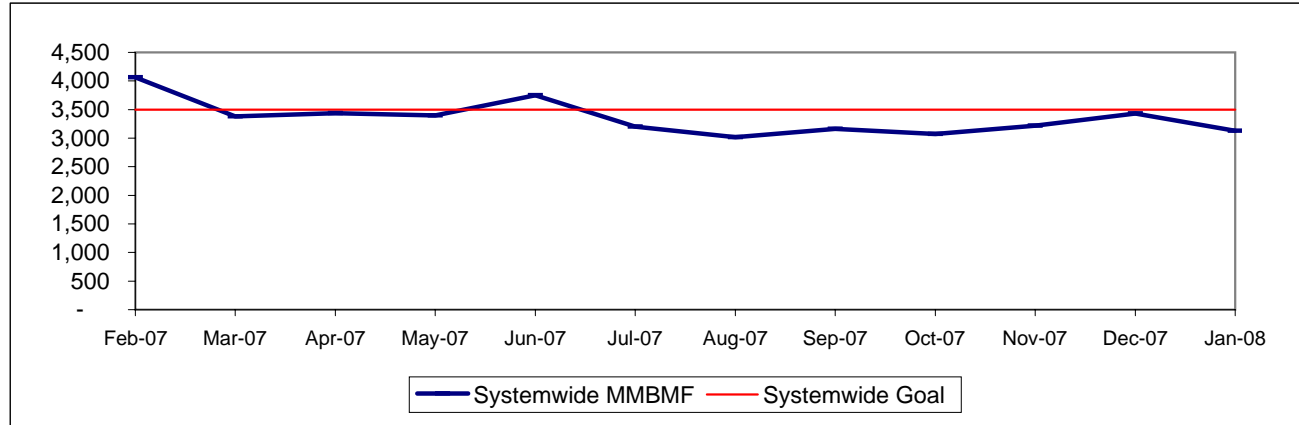

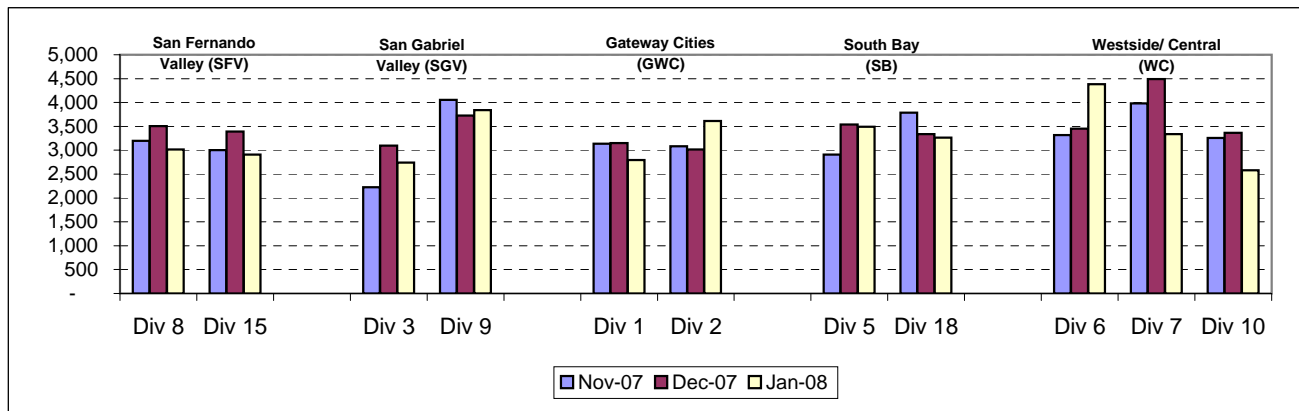

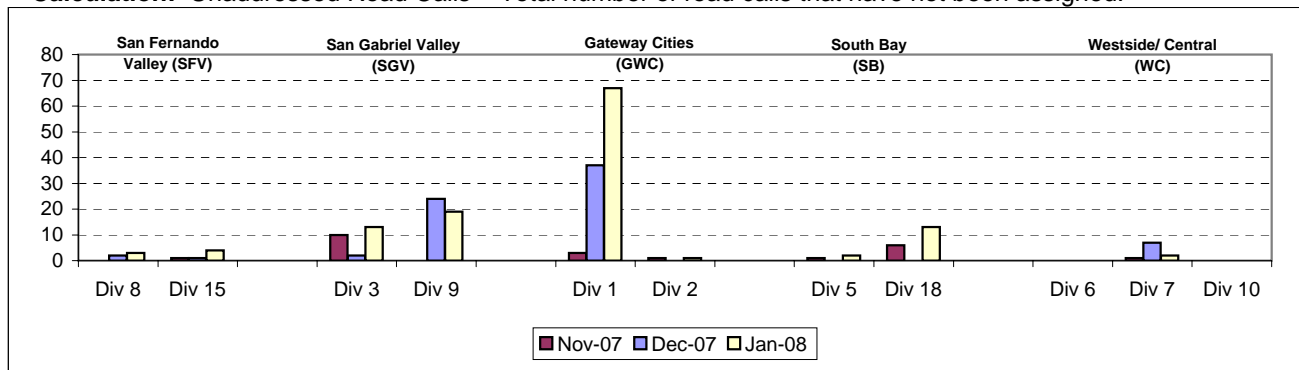

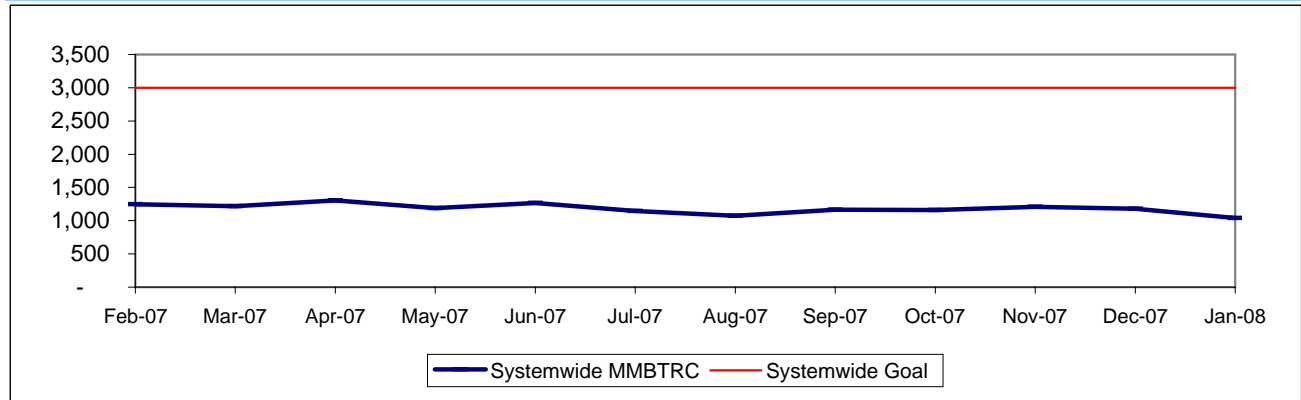

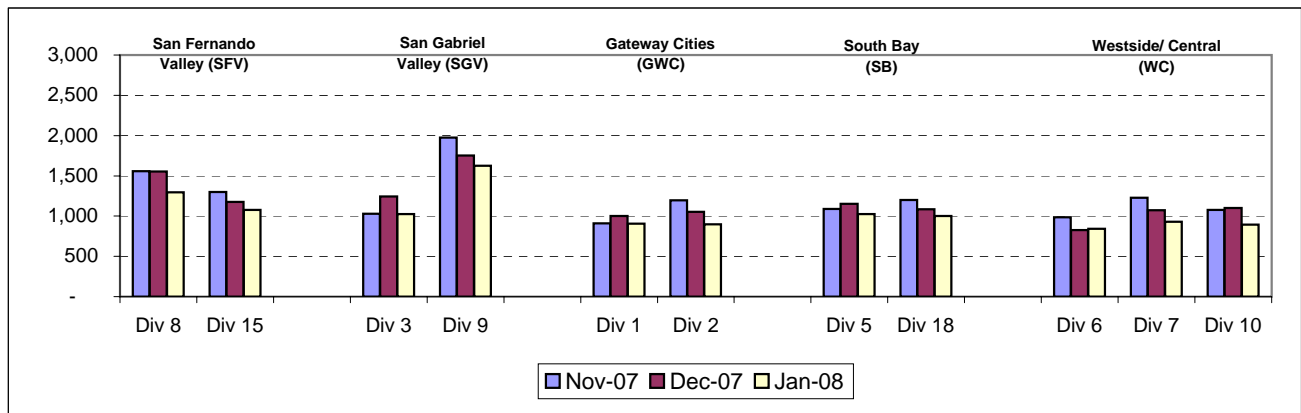

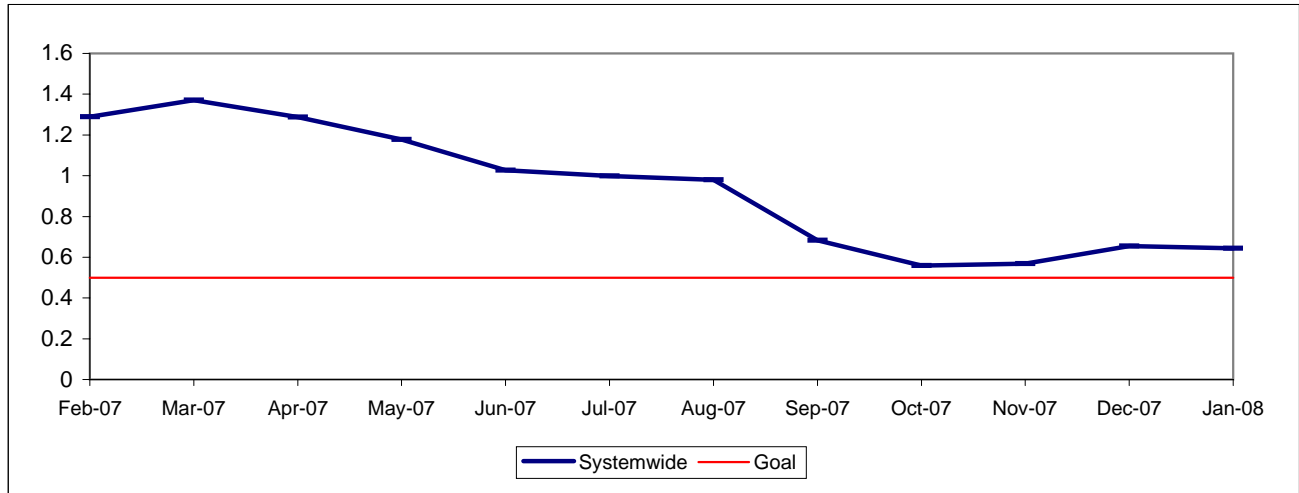

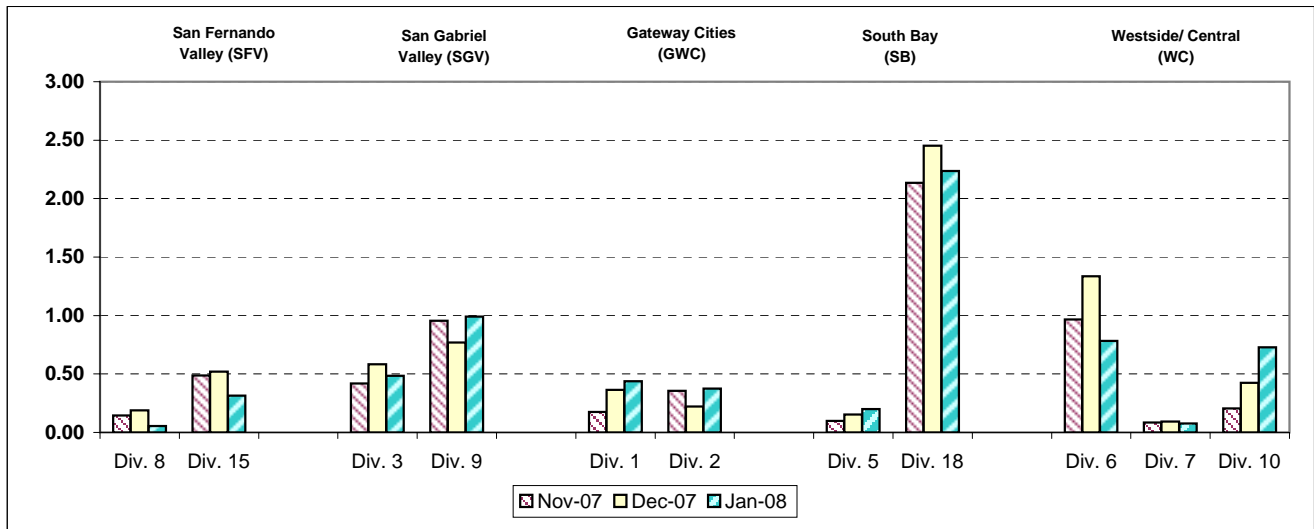

November 2007 - January 2008**



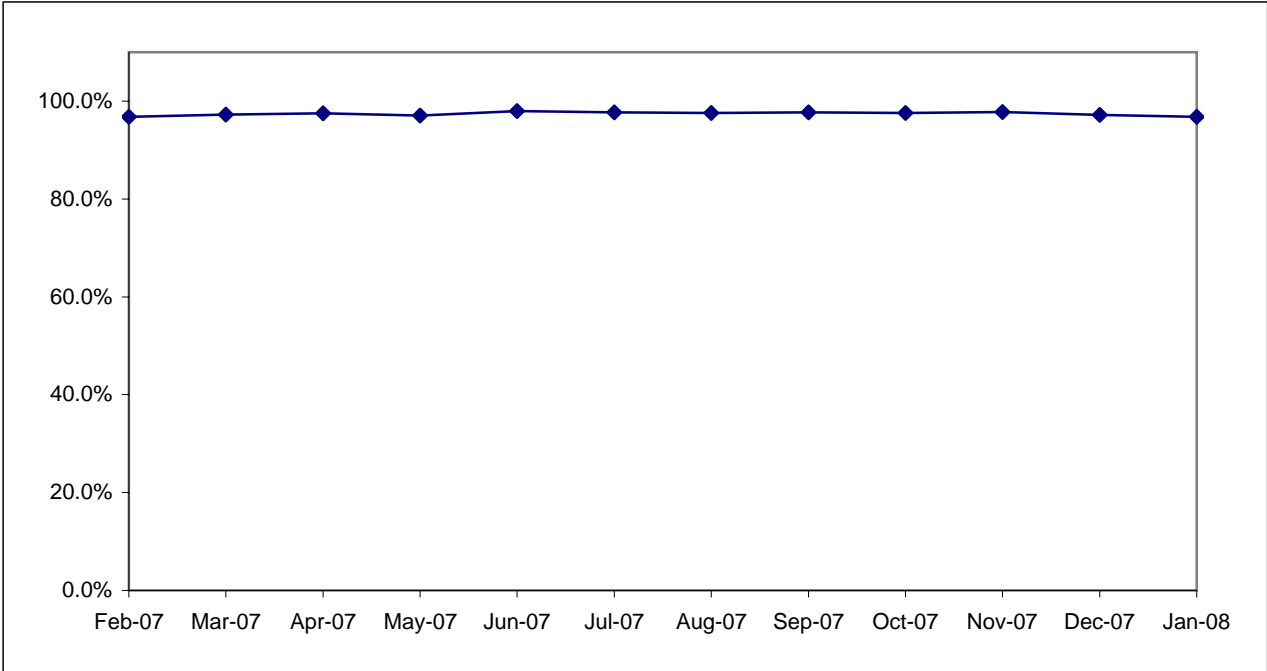

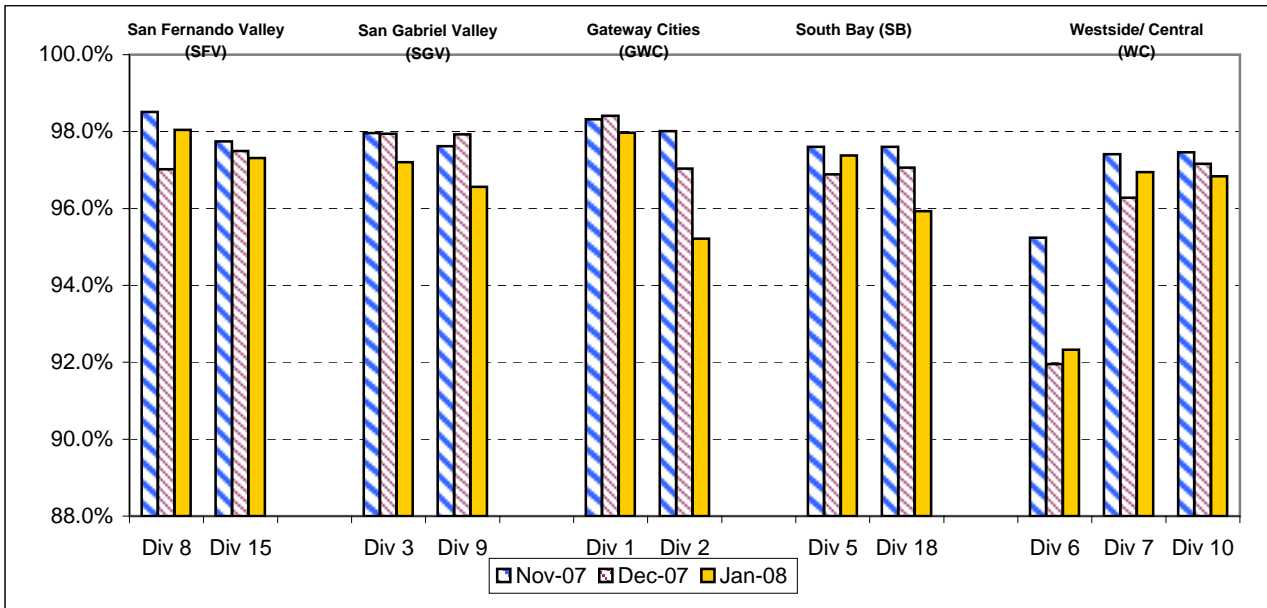

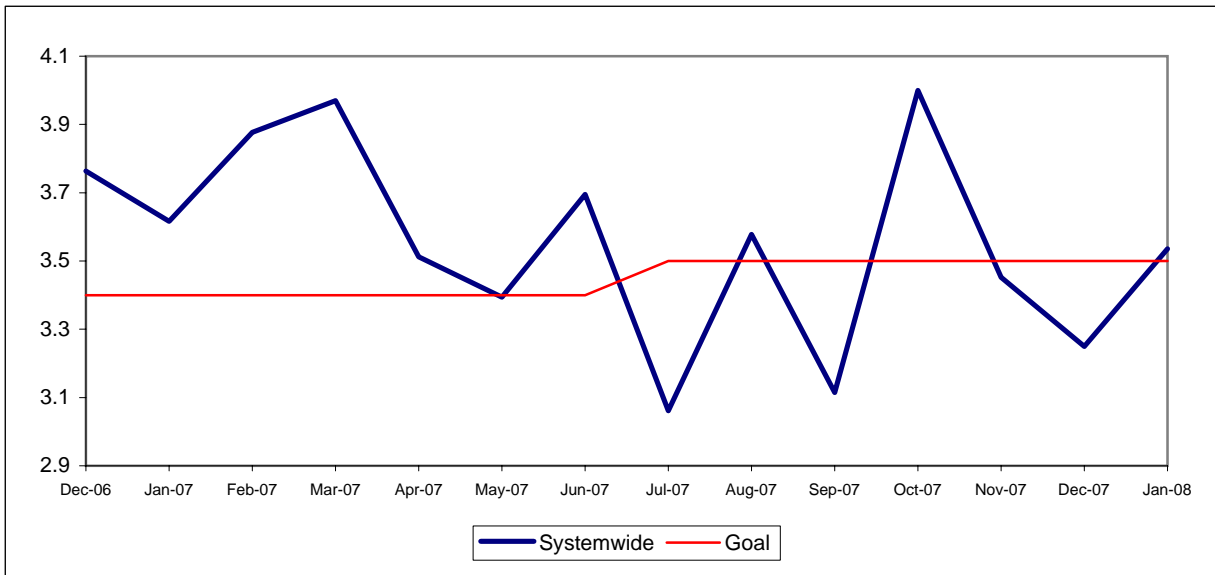

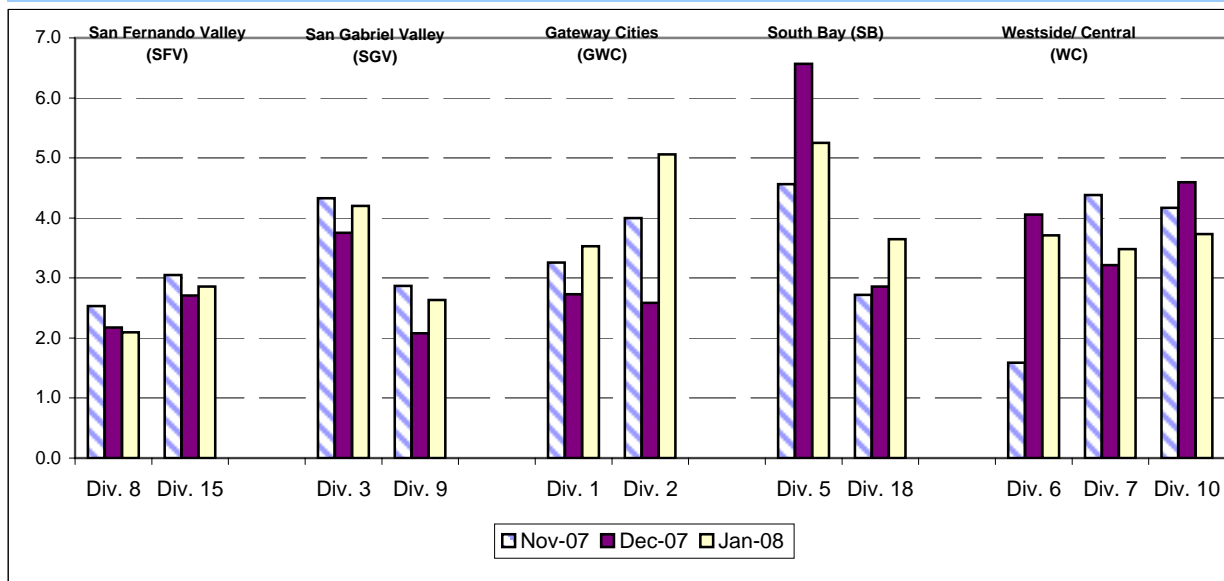

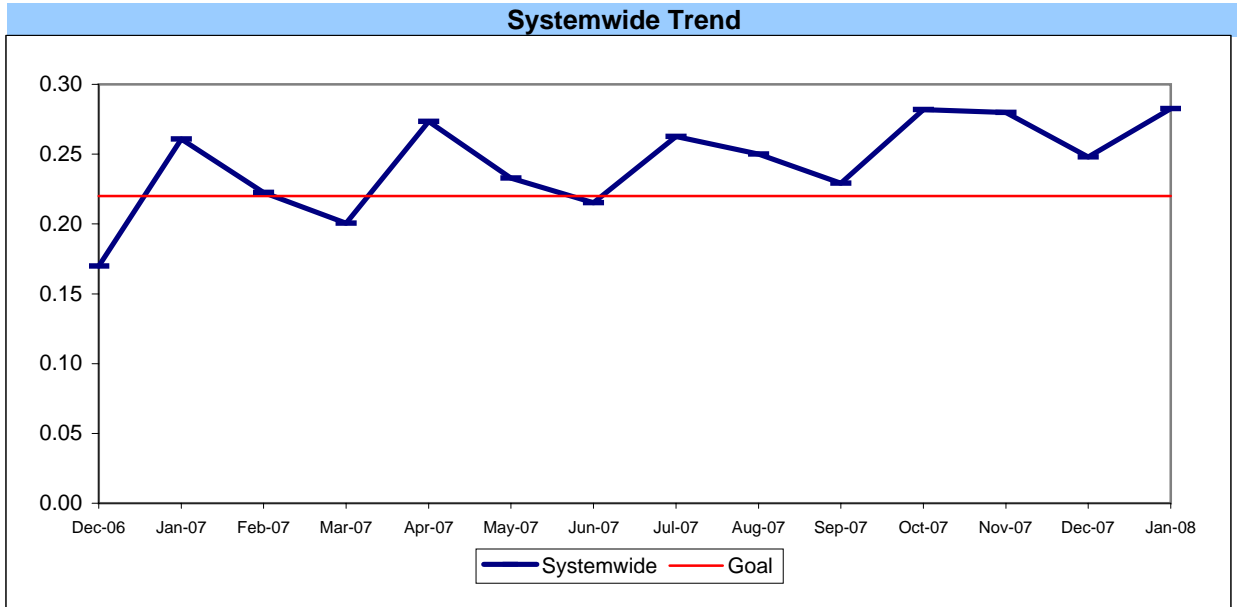
Bus Operating Divisions - by Sectors' Divisions November 2007 - January 2008

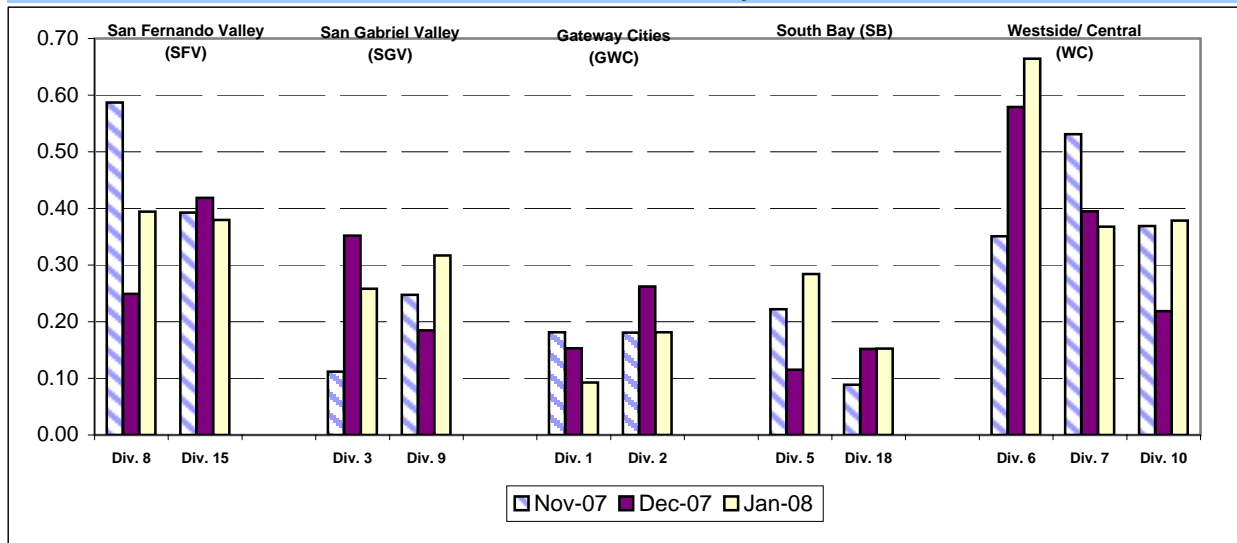

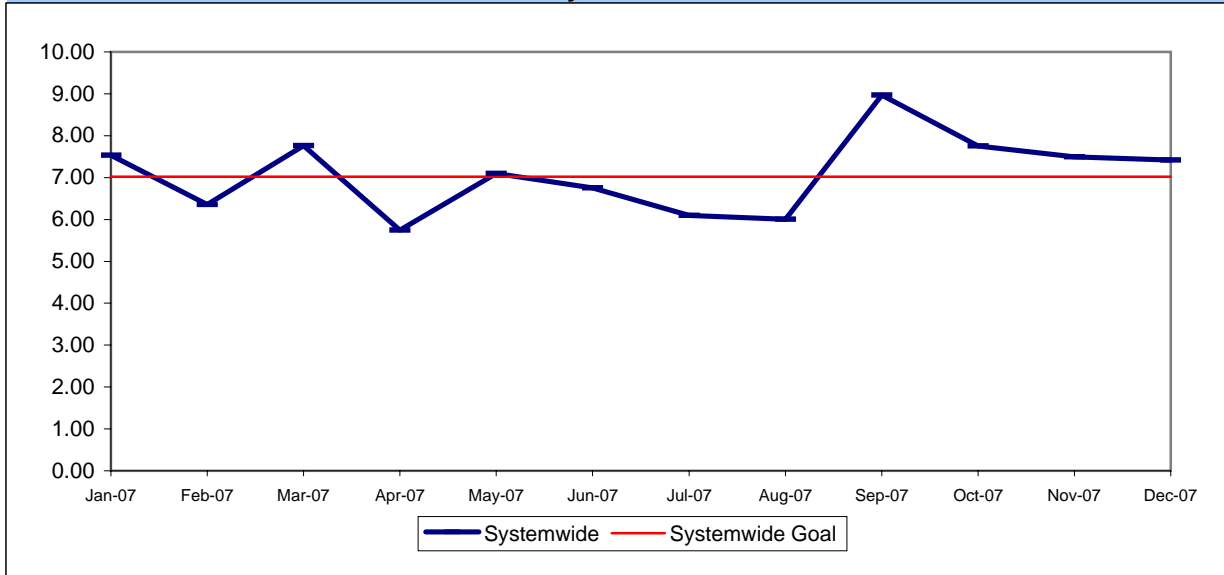

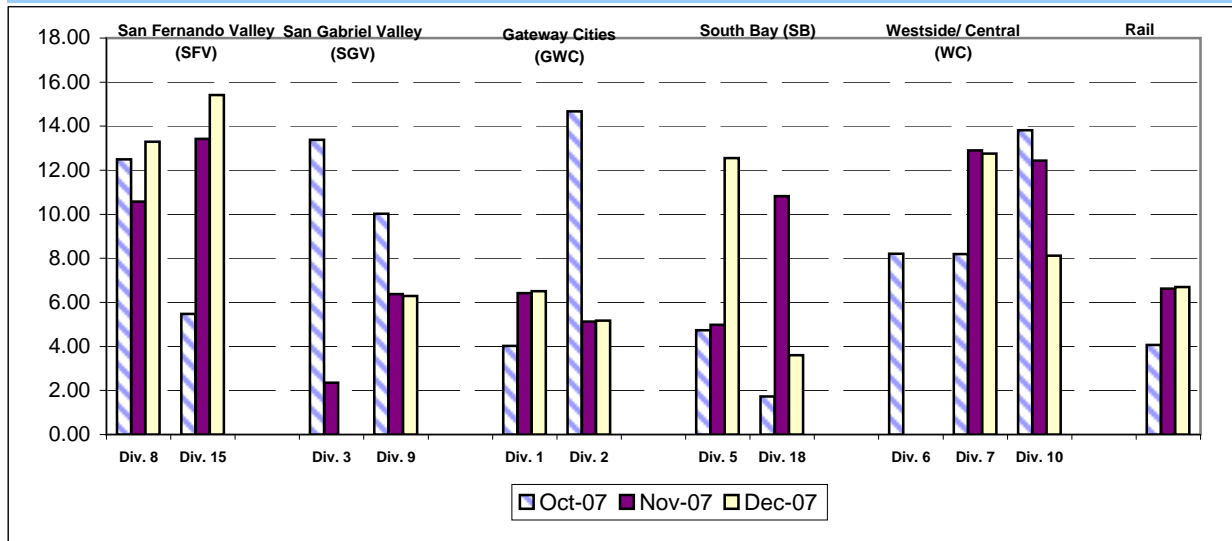

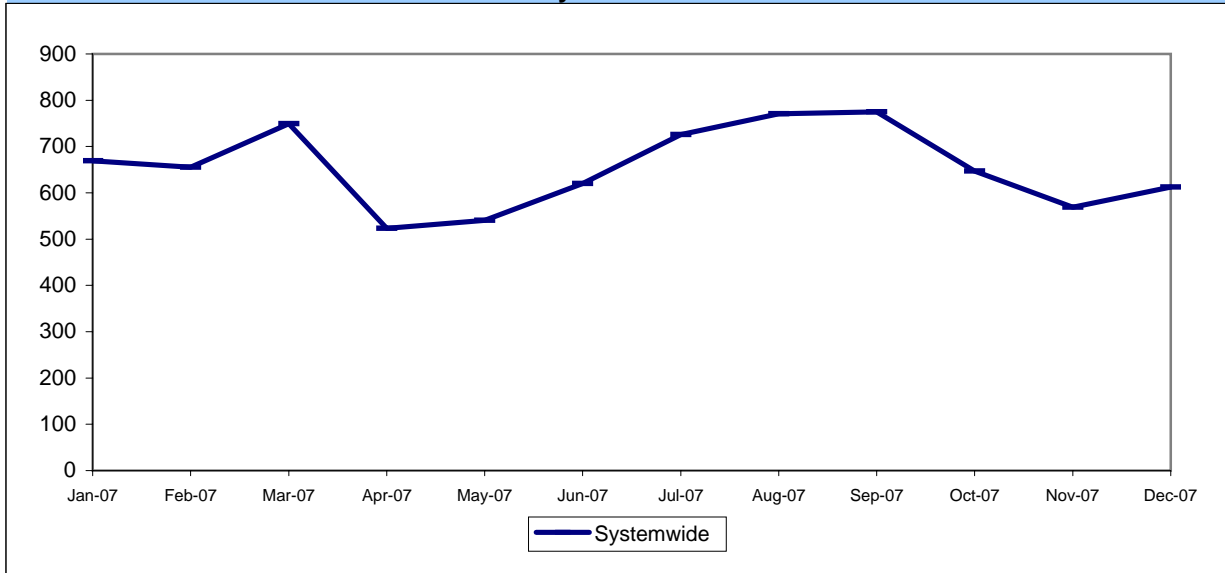

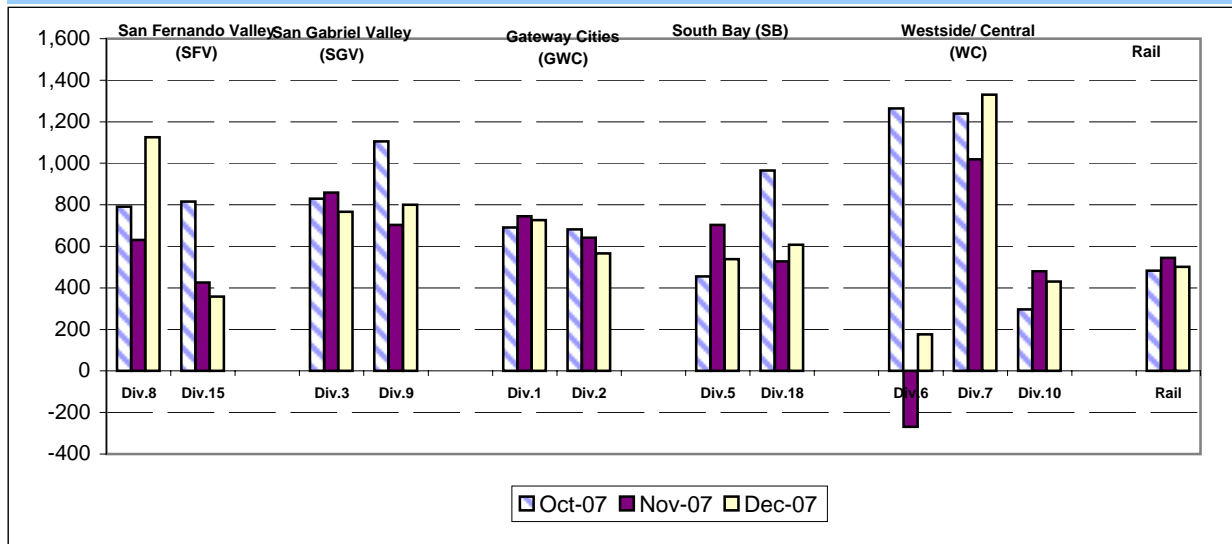

October - December 2007**

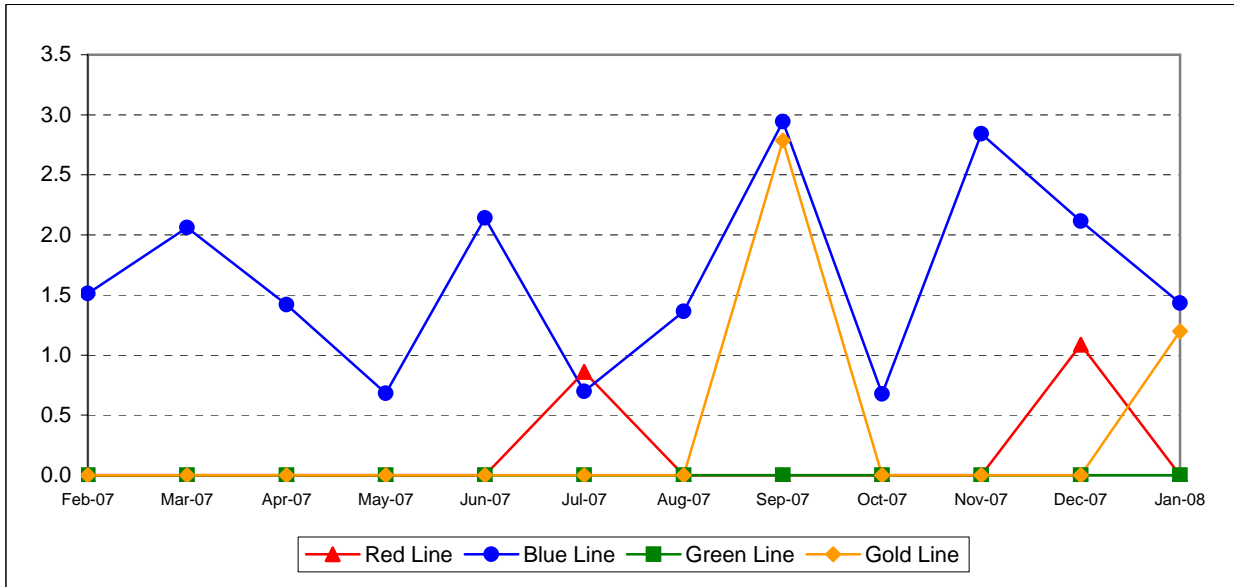

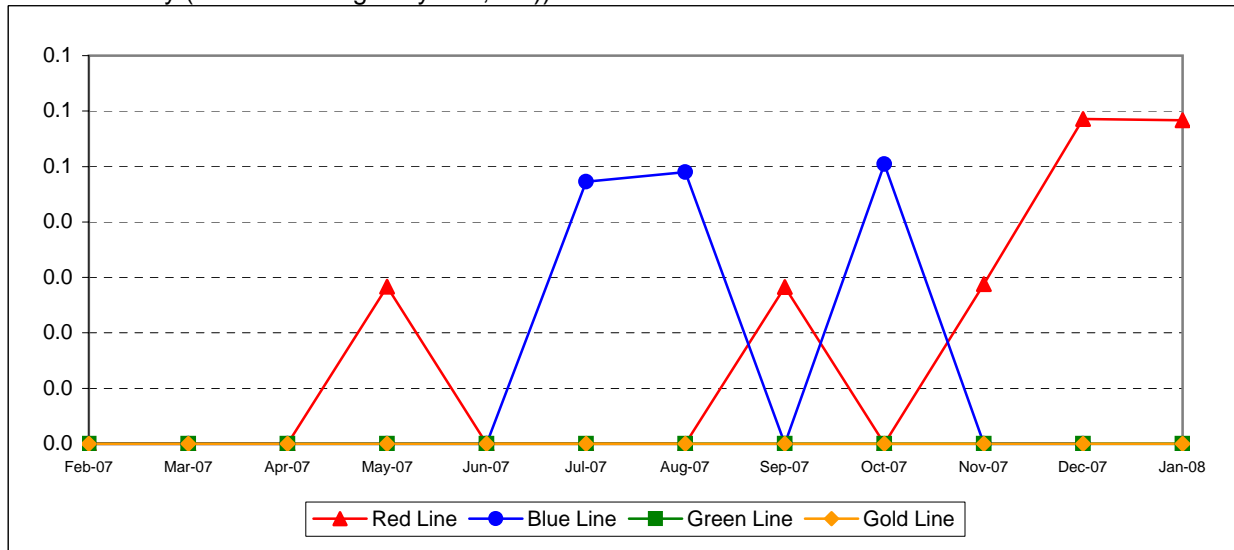

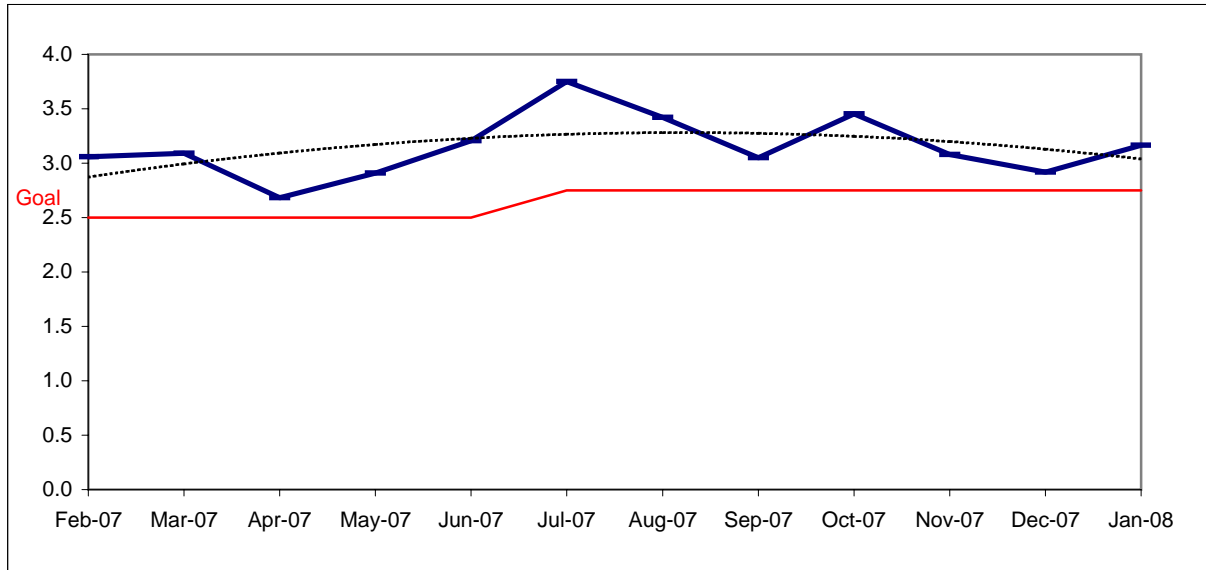

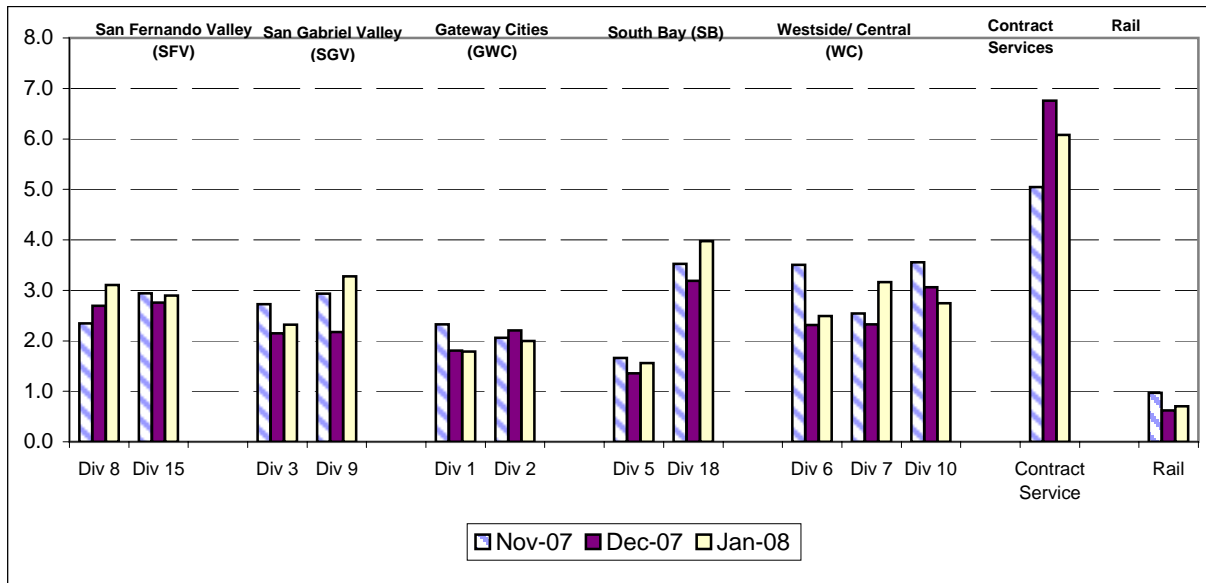

Bus Operating Divisions - by Sectors' Divisions November 2007 - January 2008



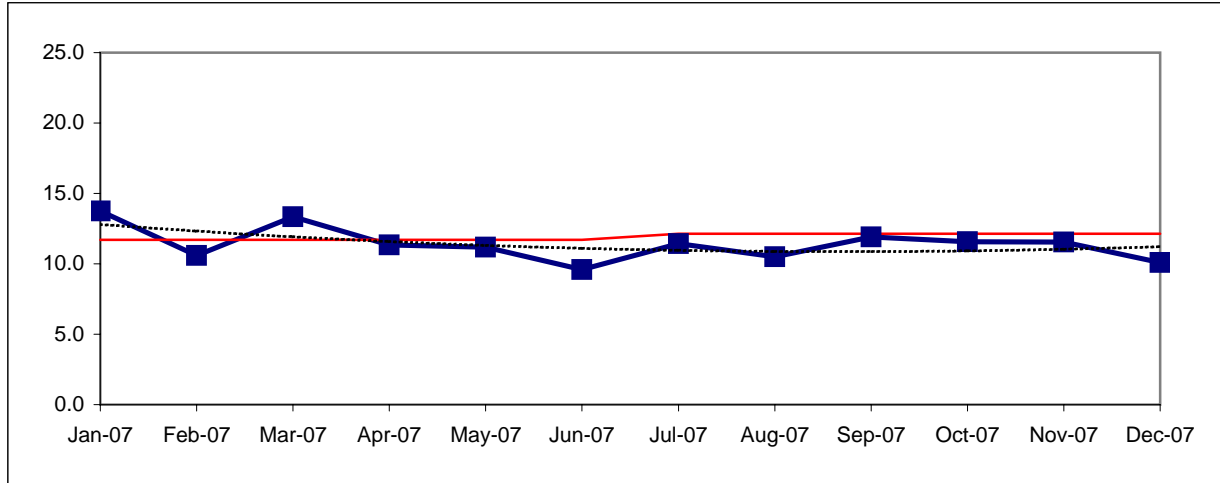

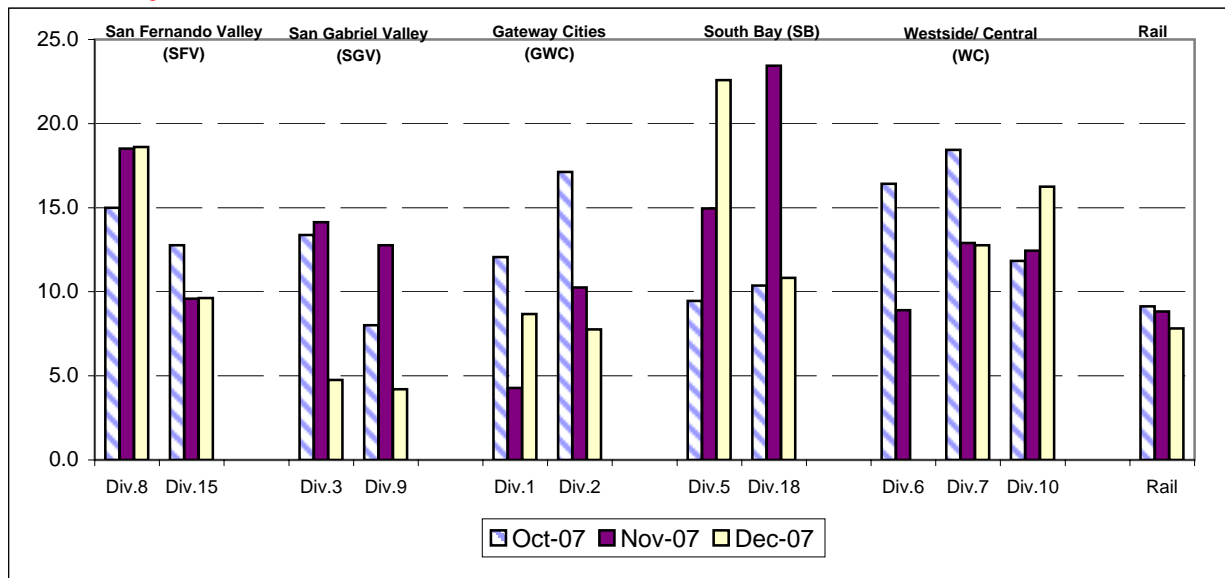
