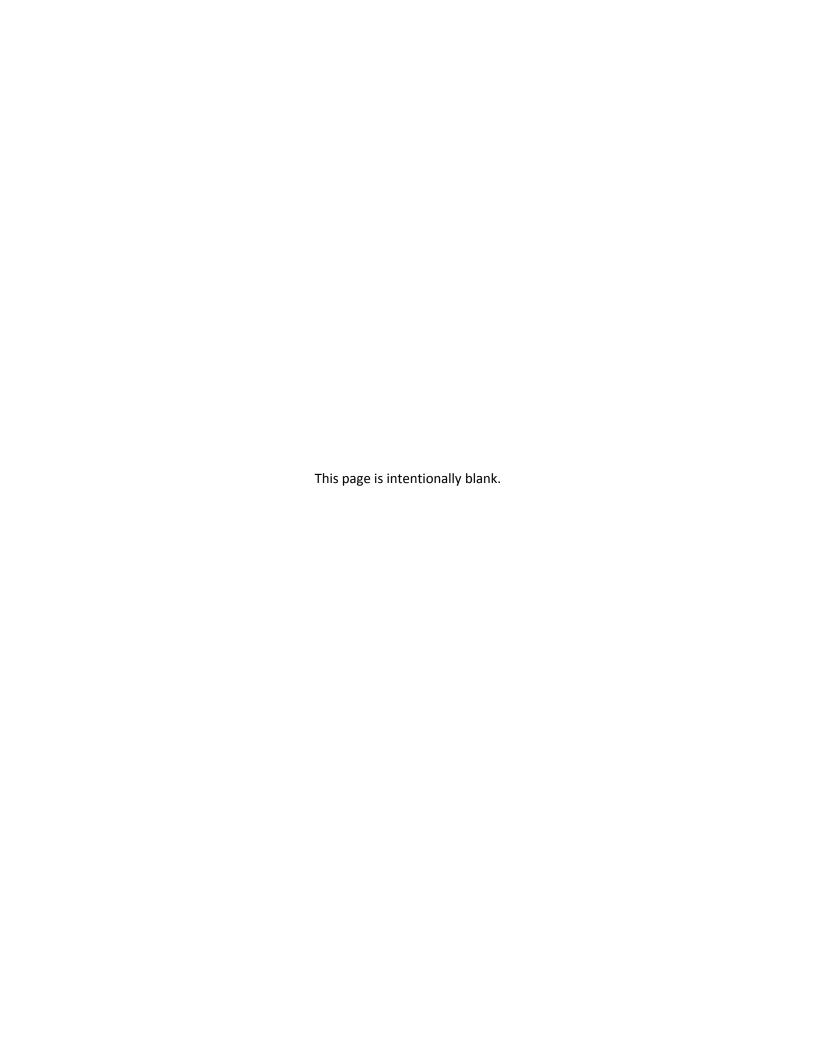

Dear Judge Bushey:

LAUSD has reached an agreement in principle with Expo that the parties expect will resolve the District's protest and allow it to support the anticipated amended application for the Farmdale crossing. The proposal is based on the amended application option for an at-grade crossing with a station at Farmdale. The station design incorporates features to provide for heightened pedestrian safety. Expo and Metro will make binding commitments regarding safe operation, including provisions requiring that all trains stop at the station and ensuring permanence of the station. Expo will purchase or condemn the nuisance property at the northeast corner of Exposition and Farmdale, will improve it with faculty parking and security according to a design that takes full account of environmental and aesthetic considerations. Once the improvements are completed, the property will be conveyed to LAUSD in exchange for a piece of property at Dorsey High School on which Expo will be constructing the pedestrian plaza, again to a design that is safe and attractive. The exact terms of the property exchange and the design details are being worked out in meetings between Expo and LAUSD. Of course, the parties will be conferring with Mr. Pererya and his colleagues.

This resolution will render it unnecessary to construct a pedestrian bridge at Farmdale, a facility that, further discussion has led the District to conclude, presented significant public safety risks.

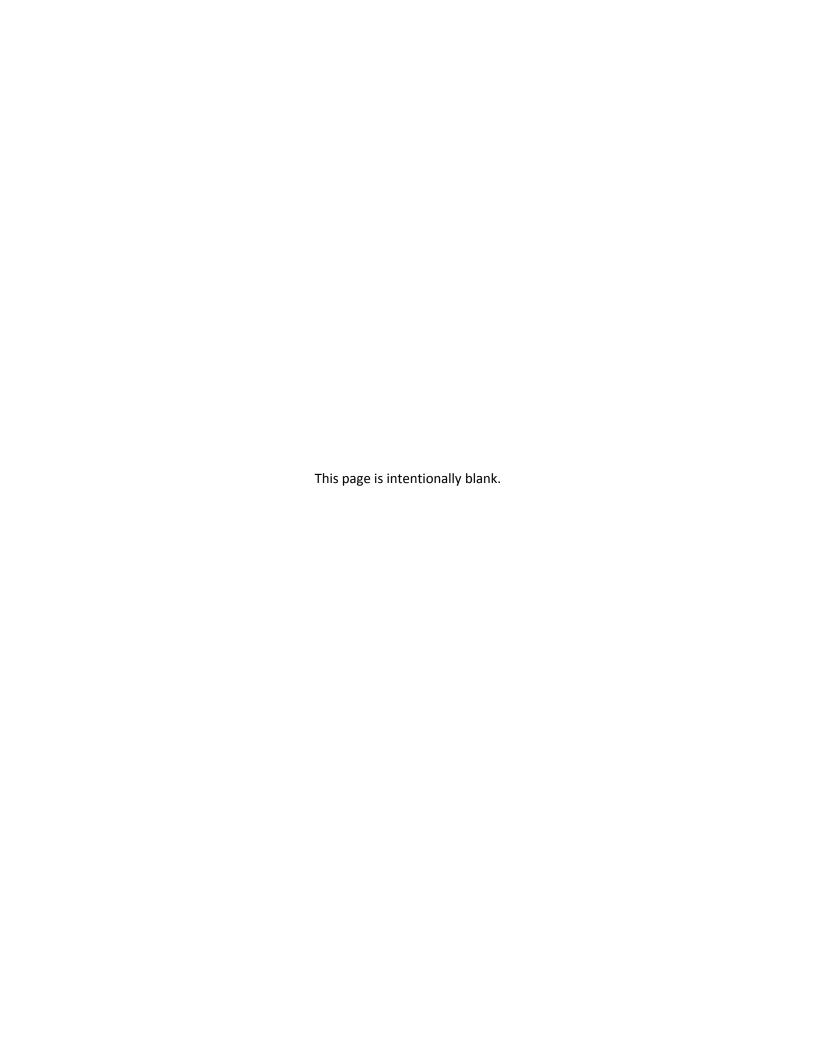

This agreement is solely between Expo and LAUSD. The community groups have been involved in the discussions and are aware of the decision.
