Exposition Metro Line Construction Authority Board Meeting

On Thursday, July 3, 2008, the Exposition Metro Line Construction Authority (Expo) Board is scheduled to meet at 10:00 a.m. in the Board of Supervisors' Hearing Room (381B) in the Kenneth Hahn Hall of Administration.

During the meeting, the Expo Board will consider the following:

- Receive and File a monthly report on contracts approved by the Chief Executive Officer (CEO) or under his delegated authority. This report details contract awards for June 2008;
- Authorize the CEO to issue contracts with selected artists and fabricators to implement the station public Art Program, in an amount not-to-exceed \$1,620,000;
- Authorize the CEO to decline the purchase of earthquake insurance during major construction of the Expo Line;
- Authorize the CEO to execute two work orders in the combined amount of \$453,553, to complete Southern California Gas Company utility relocations at Arlington Avenue and Exposition Boulevard and La Salle Avenue and Exposition Boulevard;
- Authorize the CEO to execute the City of Los Angeles FY09 Annual Work Plan on behalf of the Exposition Metro Line Construction Authority in an amount not-to-exceed \$3.07 million;
- Authorize the CEO to execute the Los Angeles Department of Water and

Power-Water Services FY09 Annual Work Plan in an amount not-to-exceed \$350,000;

- Authorize the CEO to issue a limited notice to proceed for Contract Package C2, La Cienega Boulevard Structure, to FCI/Flour/Parsons, a joint venture, in an amount not-to-exceed \$8,790,050; and
- Authorize the CEO to issue a change order for relocating overhead power lines to underground conduit installation at La Brea Avenue and Exposition Boulevard, to FCI/Flour/Parsons, a joint venture, for a lump sum fixed price in the amount of \$987,991.

In addition, the Board will Receive and File the Monthly Phase I and Phase II Project Status Update for the Exposition Light Rail Transit Project.
