(June 8, 2005) Metro's Accessibility Advisory Committee staffed an information booth at last weekend's Abilities Expo at the Anaheim Convention Center – an event that drew some 7,000 disabled persons from around California.

"Metro attends the event so we can answer questions from our customers with disabilities and provide current information on the accessibility of our services," said Chip Hazen, ADA compliance administrator.

"Many of the visitors did not know that all of Metro's buses are accessible and very few of the visitors with disabilities knew that our trains have level boarding platforms," he added.
