**MTA SEEKS PUBLIC'S INPUT ON PROPOSED SANTA MONICA BOULEVARD  
TRANSIT PARKWAY PROJECT**

The MTA has scheduled a public hearing and a review period to allow community members to give their input on a proposed project aimed at relieving traffic congestion on one of West Los Angeles' busiest streets.

The Santa Monica Boulevard Transit Parkway Project would extend on Santa Monica Boulevard from Moreno Drive at the Beverly Hills City Limit on the east to Interstate 405 (San Diego Freeway) on the west and would include the interchange between Santa Monica Boulevard and the freeway.

The Draft Environmental Assessment/Environmental Impact Report on the project is in the process of being released. The community will have the opportunity to submit written comments on the report between **March 15, 1999** and **May 7, 1999** to:

The proposed project consists of four alternatives:

*No Project* - includes no changes to the roadway, geometric configuration, no capacity improvements and no traffic improvements to roadways or intersections along either Big or Little Santa Monica Boulevards;

*Transportation Systems Management* - utilizes low-cost methods of providing operational and safety improvements to traffic flow at a number of key intersections and entails modifying the existing roadway geometric configuration of Big and Little Santa Monica Boulevards and the intersecting north and south arterial roadways;

*Classic Boulevard* - features a center roadway with three vehicular travel lanes in each direction, a bicycle lane in each direction, a landscaped center median, one-way westbound frontage roads on the north side for parking and access to local streets, one-way eastbound frontage roads on the south side for the same purposes, on-ramp improvements at the 405 Freeway interchange, landscaping/urban design and bicycle lanes;

*Classic Boulevard with Design Options* - includes all of the basic design elements of the Classic Boulevard alternative plus design options at Overland Avenue, the Century City Shopping Center, Club View Drive and the transition at the Beverly Hills City Limit.

The Draft EA/EIR is available for public review at the LACMTA Library on the 15<sup>th</sup> floor at the aforementioned MTA address.
