## **MTA TO HOLD PUBLIC HEARING ON PROPOSED BUS/RAIL INTERFACE PLAN, METRO RAPID BUS DEMO PROJECT AND OTHER SERVICE CHANGES**

The MTA will hold a public hearing on Saturday, Nov. 13, 1999 to outline proposed service changes in connection with the opening of the North Hollywood segment of the Metro Red Line scheduled for mid-2000.

In addition, the public is encouraged to comment on MTA's Metro Rapid Bus Demonstration Project to be implemented next year as well as other service change proposals designed to improve the operation of the Metro Bus system.

The public hearing will begin at 10 a.m. at the MTA's Headquarters Building, One Gateway Plaza in downtown Los Angeles. The hearing will take place in the Board Room on the Third Floor.

In mid-2000 the MTA is scheduled to begin passenger revenue service on the Metro Red Line subway extension to North Hollywood in the San Fernando Valley. To enhance rail service and reduce service duplication, the following bus routes are proposed to be modified as part of the bus-rail interface plan: Lines 96, 152, 154, 163, 166, 183, 230, 418, 420, 424, 425, 426, 427 and 522. These service changes would take place in May 2000 or later. (See attachment for specific service modification details)

A Metro Rapid Bus Demonstration Project will introduce new, fast, high quality bus service in key transit corridors in the Eastside, Mid-City and San Fernando Valley. This service will upgrade and replace existing service in the Whittier/Wilshire and Ventura Boulevard corridors.

More...

The Metro Rapid Bus Project will provide more reliable service using low-floor buses, signal priority at intersections, streamline on-street boarding and alighting of passengers and improved bus stop spacing at planned rapid bus stations.

Metro Bus lines affected by the demonstration project includes Lines 318, 320, 322 and 425. A new rapid bus line is proposed to be implemented along Whittier and Wilshire Boulevards effective March 2000 or later. The rapid bus line demonstration project along Ventura Boulevard is proposed for May 2000 or later.

Other service changes proposed to improve the operation of the bus system include implementation of a new experimental route 418 (LACBD-Roscoe Bl. Express) and new route 434 (Los Angeles-Santa Monica Express). Line 429 (Los Angeles-Sunset Blvd. Express) would be cancelled. The effective dates for implementation would be December 1999 or later for these three service modifications.

These proposals may be approved in whole or in part at a later date following the public hearing. No Board action will be taken at the public hearing. The public is encouraged to attend the hearing and provide testimony on these proposals.

### NOTICE OF PUBLIC HEARING

#### Los Angeles County Metropolitan Transportation Authority

A public hearing will be held by the Board of Directors of the Los Angeles County Metropolitan Transportation Authority (LACMTA) on **Saturday, November 13, 1999 at 10:00 AM** in the MTA's Headquarters Building, located at One Gateway Plaza, Los Angeles. The hearing is being held in conformance with federal public hearing requirements outlined in Section 9 (e) (3) (H) of the Surface Transportation Assistance Act of 1982, as amended, and public hearing guidelines adopted by the MTA's Board of Directors in 1993, as amended.

The purpose of the hearing is to receive public comment on the proposed route and schedule modifications on the following service change programs: 1) MOS-3 Bus-Rail Interface Plan, 2) Metro Rapid Bus Demonstration Project and 3) Other FY 2000 Service Changes. The proposals under consideration under each program are listed below.

#### **FY 2000 SERVICE CHANGES**

Listed below are the major service change programs proposed for this fiscal year or later. The proposed service change for each line is listed under the appropriate program. Line numbers shown in **bold type** indicate a major service change. Additional detail about these proposals will be available for public inspection after October 13, 1999 at the MTA's Administration Building in downtown Los Angeles.

#### **MOS-3 BUS-RAIL INTERFACE PLAN**

In May 2000 the MTA is scheduled to begin passenger revenue service on the Metro Red Line extension to North Hollywood in the San Fernando Valley. To enhance rail service and reduce service duplication, the following bus routes are proposed to be modified as part of the bus-rail interface plan for MOS-3.
