## RFP for Contracted Transportation Services

We have released a Request for Proposals (RFP) for Contracted Transportation Services for the North Region. The procurement process blackout period is expected to run from December 31, 2007, through April 15, 2008.

This procurement will seek proposals for the operation of local transit lines in the San Fernando Valley region, referred to as the North Region. Because of the increased maintenance costs and age of the existing bus fleet, Metro staff has determined that reducing the current contract period and issuing a new solicitation will be a more cost effective way to avoid and/or otherwise mitigate the need for additional equitable adjustments.

#### IFB for Contractor

We will release an Invitation for Bids (IFB) next week to seek a contractor to furnish, deliver and warrant fiber optic transmission system equipment. The procurement process blackout period is expected to run from January 10 through March 10, 2008.

The fiber optic transmission system is being procured to upgrade the existing system on the Metro rail lines.
