## Assemblymember Feuer Introduces Package of Transportation Bills

On Friday February 22, 2008, Assemblymember Mike Feuer issued a <u>press</u> <u>release</u> announcing the introduction of his package of transportation bills which we are currently considering. While most of the package had been introduced previously, two new measures were introduced on Friday and now have bill numbers assigned. The revisions to our sales tax authority are contained in AB 2321 and the authorization for us to pursue a greenhouse gas emission fee is contained in AB 2558.
