- Yesterday evening, the Assembly passed SB 1152 (Polanco), the bill regarding the composition of the MTA Board. SB 1152 passed on a 46-17* vote, with 17 members not voting (vote was originally 43-19 with 18 members not voting). As noted in the attached vote count, the vote for and against the measure was bi-partisan despite opposition by Democratic Leaders Richard Katz and a "not voting" position by Assembly Speaker Curt Pringic. (*The amended vote count is not yet in print). SB 1152 now returns to the Senate for concurrence. That vote may occur early next week. Staff will continue to keep you informed.
- The Conference Committee on SB 160 met today in the early morning. The Assembly Members (Miller, Villaraigosa, Bowler) presented a plan providing for not more than \$150 million in State Highway Account funding to address the funding shortfall for toll bridge seasone retrofit. Senator Kopp does not want more than \$450 million to be allocated from toll bridge revenues. Nothing was decided at today's meeting.
- SB 1505 (Kopp), the STIP reform bill, is still on Assembly 3rd Reading.
- AB 3020 (Bowler), the omnibus transportation bill that includes a provision allowing the use
 of SAFE funds to provide call boxes on unincorporated county roads, is still on the Senate
 floor.
