- Today, the Assembly passed SB 89 (Hayden) 70-0. SB 89 is a measure which would restrict contributions from businesses and firms doing business with MTA Board members to \$10, provide for a three-year "revolving door" policy for key staff and board members, provide certain requirements regarding recordable injuries and the MTA Construction Bonus Program. The bill returns to the Senate for concurrence in the amendments introduced in the Assembly and then will be "enrolled," or forwarded to the Governor for action. The MTA has a formal support position on SB 89.
- A special meeting of the City of Los Angeles' Transportation Committee has been called for 9:00AM September 3, 1997, to discuss the funding agreement between the City and the MTA for MOS-3. Councilman Alarcon has expressed concerns about the milestone identified in the agreement. The Councilman has specifically requested MTA staff to be present at the hearing to answer questions. The special committee hearing relates to the motion which will provide for the payment of \$55.4 million to the MTA from the city's Proposition A and Proposition C local return funds. This motion is scheduled for action by the City Council tomorrow.

MOTION

The contract (C-95684) between the City of Los Angeles and the MTA for Metro Reil Segment 3 requires the City to pay MTA a total of \$55,445,690, which is \$58 million less administrative credit of \$2,554,310, by September 5, 1997.

\$45.716,986 of the funds is in various MOS-2 and MOS-3 reserve accounts in Proposition A Fund No. 385; and \$8,100,000 in Proposition C Fund No. 540. However, an additional \$1,628,704 from Account No. 1.400 "Unallocated Account" is needed to make the total amount of payment. Also, the \$55,445,690 from the various accounts needs to be transferred to a single account in order to pay the MTA.

I THEREFORE, MOVE that the City Council, with the concurrence of the Mayor:

- 1. Approve the transfer of various Metro Rail funds in Proposition A, Fund No. 385, totaling \$45,716,986 from Account Nos. B220, F220, G220, H220, I220, K220, and M290 to a new Account, "Metro Rail Segment 3 Construction," number to be designated by the Department of Transportation (DOT).
- Appropriate \$1,628,704 in Proposition C Fund No. 540, from Unallocated Account No. 1,400 to Metro Rail Segment 3 Construction Account, number to be designated by DOT.
- 3. Approve the transfer of \$9,728,704 from the Proposition C Fund No. 540, \$8.1 million from MOS-2 Capital Reserve Account No. 1.209 and \$1,628,704 from the Metro Rail Segment 3 Construction Account No. MXXX, to Proposition A Fund No. 385, Metro Rail Segment 3 Construction Account No. MXXX.
