Los Angeles County Sheriff's Department, Transit Services Bureau, Los Angeles School Police Department, and Los Angeles County Probation "Disarm" Officers, arrested fifteen suspects in a search warrant / probation operation targeting graffiti vandals.

On Tuesday, August 16, 2011, at 6:00 A.M., a graffiti law enforcement task force arrested fifteen suspects for a variety of crimes ranging from graffiti, narcotics, and theft of auto parts. Additionally, five suspects were found to have given false information to their probation officers and are now wanted.

Two search warrants were served on three graffiti vandals for causing over \$10,000 in damages to Sylmar High School, Metro's Gold Line, and local freeways. L.A. School Police Officer Jamison and L.A. County Deputy Moen initiated one of the search warrants after noticing the "tag" "Mars" spray painted on Sylmar High School properties. Officer Jamison identified Omar Carpio MH/21 through departmental resources and graffiti databases and tied Mr. Carpio to thousands of dollars in damages. The search at Mr. Carpio's home resulted in deputies discovering significant evidence supporting Mr. Carpio is an active tagger. An additional three family members were also arrested for similar graffiti crimes and suspicion of auto parts theft.

Lieutenant Armando Farias, LASPD, stated Officer Jamison's thorough investigation will result in Mr. Carpio paying restitution for the damages he caused to the local schools and communities. Their agency will continue to monitor another person detained during the execution of the search warrant for any further criminal behavior.

On July 5, 2011, a taskforce was formed to target vandals that have damaged the school systems within the Los Angeles Unified School District and the Metropolitan Transportation Authority's transit system. The taskforce includes the Los Angeles County Sheriff's Department, Los Angeles Unified School District Police, Los Angeles County Probation Department, and a cadre of twenty civilian volunteers with the Los Angeles County Sheriff's Department of thirty-two probation and search warrants throughout the cities of Los Angeles County.

• Fifteen suspects arrested

• Suspects were charged with graffiti crimes, i.e., such as felony vandalism, possession of vandalism tools, possession of methamphetamine, and possession of auto parts with the VIN numbers removed. Five of the suspects had provided false probation addresses to the probation department which is a violation of their conditions.

• One family member was arrested for aiding and abetting a vandalism suspect by warning this suspect via cell phone that law enforcement were at his home

Four suspects were arrested for felony vandalism:



Harold Lopez, 21-year old Hispanic male from Los Angeles, arrested for failing to appear in court

The communities and victims where the warrants and probation searches were conducted, and/or damaged by graffiti included the cities of Los Angeles, Inglewood, Lynwood, Sylmar, Gardena, Compton, and Cudahy as well as Metropolitan Transportation Authority and LAUSD property.

Investigations were led by deputies from the Sheriff's Transit Services Bureau, the LASD unit that provides law enforcement services for the Metropolitan Transportation Authority. Deputy James Whitmore, the lead investigating officer said, "These types of operations are essential to our (LASD/TSB) mission to not only keep the public safe, but also to help mitigate the thousands of dollars that Metro is forced to spend replacing equipment and cleaning damage caused by these criminals."

Lieutenant Larry Gregg, LASD Community Oriented Policing Bureau, stated "These compliance checks are law enforcement tools we utilize to ensure that those people we searched today are compliant with their early release programs from jail. Our collaborative law enforcement approach is a proven successful tactic which enables us to lower crimes in an area and to achieve our mission of protecting lives and property."

FOR GRAFFITI REMOVAL in the unincorporated areas of the Los Angeles County, contact the LA County Dept. of Public Works hotline at (800) 675-4357. The graffiti removal hotline is available with live operators 24 hours a day seven days a week. The LACoDPW strives for a 48-hour response when calls are received via the hotline. In order to have a response in a timely manner, please answer the brief questions the operators may ask you. Often questions may be related to graffiti on property which is not the responsibility of the County of Los Angeles. For example, information is offered for the agency providing graffiti removal services to the following: Parks and Recreation, Caltrans, Metropolitan Transportation Authority (MTA), Metrolink, United States Post Office, Southern California Edison, and the 88 Cities within the County of Los Angeles.
