- Reason: May Day Marches
- Note: Due to multiple marches converging on the CBD from different directions, there will be periods throughout the day when buses are not allowed to operate across some intersections along the detour routes below. When this occurs, <u>it is not necessary for</u>
 <u>Operators to contact BOC</u> Controllers will be unable to assist, as there will be no alternative routes available. In such a situation, the Operator should stop the bus in a safe location, open the doors to allow passengers to alight, and wait for the marchers to pass the location. LADOT will reopen intersections behind the marchers as soon as it is safe to do so.

Please make announcements to inform passengers about the delays. **Operators must exercise patience, professionalism and good judgment in dealing with this major service interruption.**

- Westbound: Regular route to 6th St. and Mateo St., then continue via 6th St. to (R) Alameda St., (L) Cesar E. Chavez Ave., (L) Grand Ave., (R) Temple St., (L) Hope St. Flower St., (R) 3rd St., (L) Bixel St., (R) 6th St. and regular route.

Line 720 (Maple and 6th St. Short Line)

Line 26 (Rtes. 51 & 52)

- Eastbound: Regular route to Hoover St. and 7th St., then continue south on Hoover St. to (L) 8th St. 9th St., (R) Grand Ave., (L) 12th St., (L) Main St., (R) 7th St. and regular route.
- Westbound: Regular route to 7th St. and Maple Ave., then continue via 7th St. to (L) Los Angeles St., (R) 11th St., (R) Olive St., (L) 8th St., (R) Hoover St. to 7th St. and regular route.

Line: 28

- Eastbound: Regular route to Olympic Blvd. and Figueroa St., then continue via Olympic Blvd. to (R) Grand Ave., (L) 18th St., (L) into Terminal 28 (east lot).
- Westbound: Depart temporary layover at Terminal 28 via (L) 17th St., (R) Olive St., (L) Olympic Blvd. and regular route.

Line 30 (Rtes. 31 and 330)

- Eastbound: Regular route to Pico Blvd. and Hill St. then continue via Pico Blvd. to (L) Main St., (R) 4th St., (L) Alameda St., (R) 1st St. and regular route.
- Westbound: Via Detour Notice 08-0175 (4th revision) to Alameda St. and 1st St., then continue via Alameda St. to (R) 3rd St., (L) Los Angeles St., (R) Pico Blvd. to Broadway and regular route.

Line 30 (Judge John Aiso Short Line Layover)

- Eastbound: Regular route to Pico Blvd. and Hill St. then continue via Pico Blvd. to (L) Main St., (R) 4th St., (L) Central Ave. to temporary layover between 3rd St. and 4th St.
- Westbound: Depart temporary layover via Central Ave. to (L) 3rd St., (L) Los Angeles St., (R) Pico Blvd. and regular route.
