PURPOSE OF REPORT:

The Scheduled Service Operating Cost Factors Report shows daily vehicle miles, hours, and equipment requirements for scheduled transit service. Revenue miles and hours include layovers and intraline deadheads. Interline savings indicate buses that are used on more than one line. Operating Cost Factors reflect the school day service. Temporary service changes for the period June 27 through September 11 will be issued later. Special event service is projected until November 1993. Rail service statistics are shown both at vehicle and train levels, adjusted to accommodate gap train operation. Yard duties are excluded.

HIGHLIGHTS OF THIS ISSUE:

Line 110 weekday base service was extended to Jefferson Blvd. and Alla Road.
Line 434 service was retracted to Trancas Canyon for the winter season.
Lines 515 and 573 continue to operate only on temporary letter.
A program to add 40 peak buses on various lines was implemented beginning September 7 on temporary letters.
