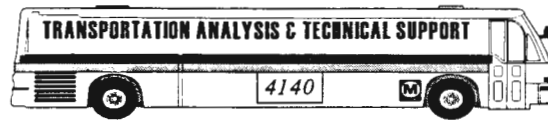

PURPOSE OF REPORT:

The Scheduled Service Operating Cost Factors Report shows daily vehicle miles, hours, and equipment requirements for scheduled transit service operated by LACMTA, including BDOF but excluding privatized lines. Revenue miles and hours include layovers and intraline deadheads. Interline savings indicate buses that are used on more than one line. Operating Cost Factors reflect the school day service. Temporary service changes are reported separately. Special event service is projected until December 1998. Rail service statistics are shown both at vehicle and train levels, adjusted to accommodate gap train operation, and are provided by the Scheduling Department. Yard duties are excluded.

HIGHLIGHTS OF THIS ISSUE:

Lines 462 and 470 have been replaced by Lines 362 and 318. Route 471 is operated by a shuttle on temporary letter. Line 112 is operated independently of Line 111.
Lines 16, 94, 200, 211, 483, and 484 schedules were implemented July 26, 1998.
Lines 168, 220, 236, 265, 362, 426, 439, 444, 445, 466, 489, 497, 550, and 576 are BDOF.
Owl services are extensively interlined, and some are BDOF.
