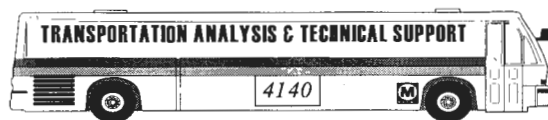

**PURPOSE OF REPORT:**

The Scheduled Service Operating Cost Factors Report shows daily vehicle miles, hours, and equipment requirements for scheduled transit service operated by LACMTA, including BDOF but excluding contract (privatized) lines. Revenue miles and hours include layovers and intraline deadheads. Interline savings indicate buses that are used on more than one line. Operating Cost Factors reflect the school day service. Temporary service changes are reported separately.

Special event service is projected until December 2000. Rail service statistics (supplied by Scheduling Dept.) are shown both at vehicle and train levels, adjusted to accommodate gap train operation. Yard duties are excluded.

The *Scheduled Service Operating Cost Factors Report for Contract Lines* effective June 25, 2000 will be issued separately.

**HIGHLIGHTS OF THIS ISSUE:****6-25-00**

**Line 305 service was inaugurated January 30, 2000 as BDOF out of Divisions 7 and 18.**

**Line 802 (Red Line) was extended to North Hollywood effective June 24, 2000. Pre-revenue testing began May 1.**

**Lines 152, 154, 201, 206, 426, and Route 183 had minor re-routes to Red Line stations effective June 25.**

**Lines 720 and 750 (Rapid Bus) service was inaugurated June 24, operating out of Divisions 7 and 8, respectively.**

**Line 18 was extended to Whittwood Mall effective June 25.**

**Line 22 is operated independently of Line 20 effective June 25, operating out of Divisions 6 and 10.**

**Line 119 and Route 126 common terminal was moved to Hawthorne Green Line Station effective June 25.**

**Line 150 and Route 240 service was inaugurated June 25, operating out of Division 8.**

**Line 156 service was inaugurated June 25, operating out of Division 15.**

**Line 212 was extended to Hawthorne Green Line Station effective June 25.**

**Line 418 alternate route was cancelled effective June 25. Trips were moved to the regular route.**

**Line 471 was extended from Whittwood Mall to Brea Mall effective June 25.**

**Lines 420, 424, 427, 429, and 522 were cancelled, along with Routes 318, 322, and 425, effective June 25.**

**Route 320 was cancelled effective June 24.**

**Line 803 (Green Line) operations were moved to new Division 22 effective June 25.**

**All bus Divisions were impacted by the above changes and rebalancing of other lines.**

**Load Factor Protection for Lines 720 and 750 reflects the minimum assignment, and is subject to Supervisor's orders.**
