INTENT

- 1. This addendum is issued prior to receipt of proposals to provide for modifications in plans and/or specifications and clarifications which were brought up at the Preproposal conference on August 4, 1997 Acknowledgment of this addendum shall be made and cost of work included in proposer's submittal.
- 2. The questions and responses addressed at the pre-proposal conference are attached (Attachment B).
- 3. The due date for submittals in response to this RFIQ is September 12, 1997.
- 4. A Project Study Report (PSR) must be conducted and completed consistent with Cal Trans standards and with the final result being a Cal Trans approved PSR. This work may be conducted by a sub-contractor specifically qualified to perform environmental and PSR clearances. Presentation of the conceptual designs must include pricing information for Phases II and III, and an additional PSR price proposal submittal. The PSR price proposal must be in a sealed, envelope clearly labeled "PSR PRICE PROPOSAL" (refer to page 39).

- 6. The cutoff date for questions is September 4, 1997.
- 7. The sample contract has been revised to include language regarding Architect-Engineer and Artist Ownership rights (see Attachment A).
- 8. The insurance requirements for General Liability and Errors and Omissions have been reduced. The insurance requirements are \$1,000,000 and \$1,000,000 respectively.
- 9. Bonding requirements do not apply to Phases I, II and III of this project. The requirement for Phases I, II, and III are deleted.
- 10. The revised list of MTA certified firms which is dated August 1, 1997 is attached (See Attachment E).
- 11. The Metro Art "List of Qualified Artists" for this project is attached. (See Attachment D).
- 12. Item Nos. 9 and 10 of the SF Form 255 were not included in the package. These Items are attached. The ten page limit for the SF Form 255 has been deleted (Attachment C).
- 13. The Pre-Qualification Application will be requested from the firms invited to participate in the Interview process only. The Pre-Qualification Application is not a submittal requirement at this time. These firms will be notified by mail, and the request to submit the Pre-Qualification Application will be addressed in the interview correspondence.

- 14. Page 5, Item 3, Paragraph 1, section entitled "Submittal Requirements" has been revised to provide for the submission of photographs and renderings at the proposer's discretion as follows:
 - "3. Recent project experiences that demonstrate the skills necessary for this project and, experience in community relations/consensus planning. description should include evidence of sensitivity to historic context, citizen concerns and/or appropriate multi-lingual ability. Include references including contacts and phone numbers of clients for which you have performed similar work (not to exceed ten pages of text). The prospective proposer may include up to ten (10) photographs or renderings. Do not include company brochures, or exceed the page limits stated above."
- 15. All other terms and conditions of the RFIQ will remain the same.

This is a Cost-No Fee type contract. You will be paid \$ as full compensation for the satisfactory completion of all services. This sum includes payment for taxes, insurance, and fringe benefits, as well as indirect costs, overhead allowance, materials and supplies.
Total compensation for all service will not exceed this Not to Exceed Amount. Your services will be billed on upon the completion of the conceptual design, and payment will be made within thirty (30) days of receipt of an acceptable invoice, approved by the Project Manager (Director) or a designated representative. All invoices must be made in writing and delivered or mailed to the MTA as follows:

CONSULTANT/CONTRACTOR represents that its taxpayer identification number (TIN) is as evidenced by a completed Federal Form W-9 on file with the Accounting Department on the date of execution of this Agreement.
CONSULTANT/CONTRACTOR agrees to file such tax forms as may be reasonably requested by the MTA to implement Internal Revenue Code Section 3406 and to accept as a part of any compensation due, any payments made by the MTA to the Internal Revenue Service pursuant to

The MTA may, by written notice to the (Consultant/Contractor), terminate this Agreement in whole or in part at any time, either for the MTA's convenience or because of the failure of the (Consultant/Contractor) to fulfill its contractual obligations. Upon receipt of such notice, the (Consultant/Contractor) shall: (a) immediately deliver to the MTA all data, drawings, specifications, reports, estimates, summaries and such other information and material as may have been prepared or developed by the (Consultant/Contractor), or its subconsultants in performance under this Agreement.

Any amendment to this Agreement must be in writing and signed by both you and the MTA.

You agree to treat as confidential and return to the MTA all data, specifications, reports, drawings, and other materials made available to you for use in performing your services under this Agreement.

All data, specifications, reports, articles, drawings, surveys, and other materials prepared by you in performing services under this Agreement will be treated as confidential by you, will be the property of the MTA, and will be delivered to the MTA at its request or upon completion of your services.

In performing services under this Agreement, you will be acting as an independent contractor and not as an agent or employee of the MTA. You will have no authority to contract in the name of the MTA and you will be responsible for your own acts and those of your agents and employees.

You agree to indemnify the MTA, its officers, agents and employees from all liability, damages and expenses resulting from your acts or omissions and that of your agents, employees or subcontractors in the performance of your services and you agree to defend at your expense all legal proceedings brought against the MTA as a consequence of your services and to pay any resulting judgements.

In connection with the performance of services provided for under this Agreement, you agree that you will not, on the grounds of race, religious creed, color, national origin, ancestry, physical disability, medical condition, marital status, sex, sexual orientation, or age, discriminate or permit discrimination against any person or group of persons in any manner prohibited by Federal, State or local laws.

All documents and materials prepared or developed by the Contractor and its subcontractors pursuant to this Contract shall become the property of the MTA without restriction or limitation on their use and shall be made available upon request, to the MTA at any time. Original copies of such shall be delivered to the MTA upon completion of the Services or termination of the services. The Contractor shall be permitted to retain copies of such items for the furtherance of its technical proficiency; however, publication of this material is subject to the written approval of the MTA.

No material or technical data prepared by the Contractor under this Contract is to be released by Contractor to any other person or agency except as necessary for the performance of the Services. All press releases or information to be published in print or electronic media, shall be distributed only after first being authorized by the MTA.

Ownership of Architect Drawings, Specifications and Other Documents

The drawings, specifications, and other documents furnished by Contractor or any lower tier subcontractor submitted pursuant to the contract, and all copyrights associated therewith , shall be the property of the MTA.

The MTA shall have the right to submit, and distribute such documents to meet official regulatory requirements for purposes of operating and maintaining the pedestrian crossing or for similar purposes in connection with the Project. This shall not be construed as publication in derogation of any reserved rights which the Contractor may otherwise claim.

The Contractor hereby grants to the MTA and to its officers, agents, and employees acting within the scope of their official duties, a royalty-free license to publish, translate, reproduce, deliver, and use as they deem fit all technical data covered by copyright supplied for this Contract. No such copyrighted matter shall be included in technical data furnished hereunder without the written permission of the copyright owner for the MTA to use such in the manner herein described.

The Contractor warrants that the processes, design, equipment, materials, or devices used in providing the Services shall be delivered free of any rightful claim of any third party for infringement of any United States patent or copyright. If a suit or proceeding based on a claimed infringement of a patent or copyright is brought against the MTA, the Contractor shall, at its own expense, defend or settle any such suit or proceeding if authorized to do so in writing by the MTA, and indemnify and hold harmless the MTA, its subsidiaries, agents and employees from all

liability, damages, costs, and expenses associated therewith, including, without limitation, defense costs and attorneys' fees.

Artist (Subcontractor)

During the performance of Contract for Phases II and III, the Contractor will retain an artist (Subcontractor) to collaborate with the Contractor. The Subcontractor hereinafter called the "Artist" will perform artistic design services described in the Contract for the design of a Pedestrian crossing over the 101 Freeway.. The following provisions apply to the Artist (Subcontractor) and shall be incorporated in full in the subcontract between the Contractor and the Artist (Subcontractor).

The MTA agrees that it shall not intentionally alter, modify, or change the Work of the Artist without first conferring with the Artist and obtaining the prior approval of the Artist to the proposed modification or change. Notwithstanding an Artist's refusal to provide (or the MTA's failure for any reason to otherwise obtain) approval provided for in the aforementioned paragraph herein, the MTA at its sole discretion, shall have the right to remove or alter any work of art providing the following terms and conditions are met:

- 1. The removal or alteration proposal shall first be submitted to and considered by the Source Selection Panel which selected the Contractor/Artist. In the event that any member(s) of the Source Selection Panel are unavailable, the MTA may select replacement member(s). The selection of any such replacement member(s) shall be subject to the approval of the Artist, whose approval will not be withheld unreasonably. In the event that the Source Selection Panel does not exist at the time removal is proposed, the issue and request for a recommendation shall be submitted to an impartial panel selected by the MTA consisting of three to five visual arts professionals (e.g., Artists, museum curators, art critics and/or art historians and a member of the community in the project area). The selections of such persons shall be subject to the approval of the Artist, whose approval will not be withheld unreasonably. Following review and consideration of the removal or alteration proposal by the Art Panel, the recommendation on removal or alteration shall be submitted to the MTA.
- 2. The MTA shall have a right to decide that the Work may be removed or altered. The decision to remove or alter shall not be made by the MTA until the recommendation required by Paragraph 1 herein, is received and considered.
- 3. In the event that the MTA shall decide to remove or alter the Work, the Artist shall have the first right of refusal to purchase the Work, providing it stands alone and is not integrated into a larger piece and can be removed undamaged without undue expense to the MTA.

- 4. Should the Artist choose to exercise his/her rights under Paragraph 3 herein, a Price Review Board (PRB) shall be established to determine a reasonable purchase price. The membership of the PRB shall consist of the following:
 - A. One member selected by the MTA, with no direct business relationship with the MTA, who shall be a member of the Art Dealers Association.
 - B. One member selected by the Artist, with no direct business relationship with the Artist, who shall be a member of the Art Dealer's Association.
 - C. A third member selected by the first two members and approved by both the MTA and the artist. The third member shall act as the chair of the committee.

The fees and expenses of all three members of the PRB shall be negotiated between the parties to this Contract at the time the PRB is established. The PRB shall adopt the rules of operation. The rules shall be kept flexible, but shall not relate to or modify any issues of fees and costs.

To the extent that the provisions of this Contract differ from those stated in California Civil Code Section 987, the provisions of this contract will govern. To that extent, the rights and duties created under California Civil Code Section 987 are expressly waived.

This contact shall be governed by and interpreted in accordance with the laws of the State of California. The Artist shall also abide by all applicable City and County Ordinances.

You will not assign or subcontract any part of this Agreement without the prior consent of the MTA, and any attempt to do so will be void and unenforceable.

If you agree, please sign three (3) copies of this letter in the place provided below and return it to Susan M. Dove, Contract Administrator. A fully executed contract will be mailed to you.

ATTACHMENT A-1

INSURANCE REQUIREMENTS

Contractor shall procure and maintain for the duration of the contract insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the Services hereunder by the Contractor, its agents, representatives, or employees.

A. Insurance coverage shall be at least as broad as:

- 1. Insurance Services Office Commercial General Liability coverage (occurrence form CG 0001).
- 2. Insurance Services Office form number CA 0001 (Ed. 1/87) covering Automobile Liability, code 1 (any auto).
- 3. Workers' Compensation insurance as required by the State of California and Employer's Liability Insurance.
- 4. Errors and omissions liability insurance appropriate to the Contractor's profession.

B. Contractor shall maintain limits of insurance no less than:

- 1. General Liability: \$1,000,000 per occurrence for bodily injury, personal injury and property damage. If Commercial General Liability Insurance or other form with a general aggregate limit is used, either the general aggregate limit shall apply separately to this project/location or the general aggregate limit shall be twice the required occurrence limit.
- 2. Automobile Liability: \$1,000,000 per accident for bodily injury and property damage.
- 3. Employer's Liability: \$1,000,000 per accident for bodily injury or disease.
- 4. Errors and omissions liability: \$1,000,000 per occurrence.

Attachment B 101 Pedestrian Bridge Design Competition Questions and Answers

1. Question: Will MTA pair selected teams with pre-qualified artists or will the team make the selection?

Answer: The design team will select the artist based on the meeting that has been facilitated by Metro Art. The MTA will not pair selected teams with pre-qualified artists.

2. Question: Is it a requirement to have proof of \$5,000,000 of General Liability and Errors and Omissions prior to Phase II and III Negotiation or is it sufficient to indicate the ability to provide should the contract be awarded?

Answer: The prospective proposer must have the required insurance (\$1,000,000 for General Liability and Errors and Omissions) by Phase II - Contract Award date.

3. Question: Design Firms can not obtain bonding requirements; Will this requirement be deleted?

Answer: This requirement has been deleted for Phases I, II, and III.

4. Question: There is no language regarding ownership rights or a release of liability if MTA re-uses the design for construction on any other site. There is also no language regarding the display rights.

Answer: The attached sample contract references these issues (see attached sample contract - clause entitled "Ownership of Architect Drawings, Specifications and Other Documents.

5. Question: What purpose does the cost proposal serve, given that a \$10,000 amount has been fixed?

Answer: Based on procurement policy, a proposal must be submitted in order to receive a contract. Contract Award is based on the proposer's cost proposal. In this instance, the Contractor will be reimbursed for \$10,000 only.

6. Question: Is the MTA Pre-Qualified List of Artists available?
Answer: The MTA Pre-Qualified List of Artists is attached

7 Question: Which certifications/forms must be completed by the Subcontractor?

Answer: The Prime Contractors and Subcontractors are required to complete the following forms for Phase I included in the section entitled "Proposal Requirements":

Note: Section 8.1 is not required for Phase I, since the Contract Value is \$10,000. Only the Prime Contractor is required to complete the Proposal letter. For Phase II, the Prime and Subcontractor must complete Section 10

- 8. **Question**: Is there a separate budget for the Artwork? **Answer:** At this time, there is no separate budget for the Artwork.
- 9. Question: Under submittal requirements, should items 2 and 3 be submitted on SF255 and SF254 or should they be in addition to these forms?
 Answer: The submittal requirements should be on the SF255 and SF254 forms only.
 The submittals should not be in addition to these forms.
- 11. Question: Has a budget been established for the additional improvements including buildings and other architectural improvements? What is the funding source for these elements?

 Answer: There is no budget established for additional improvements at this time.
- 12. Question: Do DBE firms need to be certified with the MTA prior to the submittal of the proposal for Phase I, or can they be certified by the proposal due date for Phases II and III?

 Answer: They must be certified by the proposal due date for Phases II and III.
- 13. Question: Is the Standard Form 254 required for subcontractors?

 Answer: Yes, this form is required for subcontractors.
- 14. **Question:** What is the page limit for backup documentation and photographs? **Answer:** The photographs can be included in the submittals in response to Submittal Requirement 3 Project Experiences. The limit for photographs and renderings is ten pages.
