Remaining at their existing assignments are Ralph E. Costello, manager at Division 12; and Verle A. Wetmore, manager at Division 2.



More Than 200 See Johnny Off

More than 200 employees, retirees and friends gathered July 1st at South Park Shops to wish a happy retirement to Supervising Clerk Johnny C. Boyce following 38 years loyal District service.

Johnny started on November 26, 1934, as a conductor at Division 1, where he later served as a clerk and extra clerk/cash receiver. He also worked at Division 2 as an operator, at Department 18 as a dispatcher and at Department 20 (formerly Division 4 which was at the site of the Convention Center) as senior clerk.

At South Park Shops, he has served as shop clerk, chief clerk to the superintendent and finally as supervising clerk.

The supervisor has been very active in District and community activities. He once headed the District Credit Union.

Johnny was born in Chidress, Texas, on June 4, 1911.

The following is the retirement speech as presented by Fred Harrington, of South Park Shops:

"Honored retiree, supervision and fellow

When I was asked if I would speak on behalf of the Body Shop employees I said it would be an honor and a privilege. It is my small token of thanks for the many services this man has done for others. With your indulgence I will tell you some of the things I found out about John.

The man we are honoring today is a Texan. His bigness is the service he has so generously given to others. His employment with the Los Angeles Railway and, subsequently, with the Rapid Transit District began November 26,

"Most of us remember Hank Mann. He and John started as motorman and conductor just two days apart. This was in Division 1 in the street car days.

From 1942 to 1945 John Boyce was in the Navy. From seaman second class he became chief petty officer as a parachute rigger.

"Upon his return to civilian life and his former employer his capacity to accept new assignments started to unfold. He became a trafficman, checker, extra clerk and stenogra-

"He was mechanical dispatcher, then shop clerk at Division 2. He then bid in as shop clerk at South Park in June 1948. John later became chief clerk and is retiring with the title of supervising clerk.

"All work and no play could make John a dull boy. But his avocations are as varied as his vocations. They include lapidary and rock hound and trailering with the International Association as a charter member since 1955.


"As a delegate for four years, this took him to rallies of over 400 trailers throughout the U.S.A. He is president of the Harbor area. John has been a shop steward and union president representing over 500 employees.

"His credit union work he calls a hobby.

8:10 8:15	#59 arrives. Board bus #5600 and ride to 1st and Locust. Embark at 1st and Locust practically falling into the movies. A corner of 1st and Locust is occupied with the filming of a police chase. The normal bus was filled with cameras, electrical generators and the intersection police cars, prop men, grips, actors and stand-ins. (Bus riding in Long Beach can be fun).
8:26	Ocean and Locust. Well-placed sign clearly indicates proper place to board bus #36. Others waiting but I go into ticket counter to check. Courteous and well-informed woman gives me instructions on the bus departure time and where to board it. Buses are also announced by speaker outside — nice touch. I hear two loud shots — the cameras must be rolling.
8:30	More shots and other buses leaving for other destinations.
8:43	#36F arrives right on time. P.A. announces it is ready for boarding and two more loud shots are heard as 1 board bus #5504.
8:45	We're away with 12 passengers. There are periodic pickups along Long Beach Boulevard. The last passenger to board prior to the freeway boards at Market Street at 9:07. He pays lesser rate of 70¢ for the ride to the city.
9:18	Skimming along the freeway.
9:29	7th and Central.
9:36	Pull into RTD station right on time on the money. Get information from the information counter relative to taking a bus back to the office and taking two short bus rides to 11th and Broadway.

All in all I found riding the bus to be a very pleasant and relaxing experience. The drivers all maintained good control of their vehicles and the stops and starts were very smooth. Riding the RTD Freeway Flyer is the most trouble-free and relaxing freeway travel I have experienced in years. I wonder if there are any studies to show the added years of life to a person as a result of eliminating "freeway strain."

Commendations Please Everyone

Operator David B. White, who retired from District 10 on July 7th, was cited in The Record-Ledger newspaper in Tujunga by columnist Richard Stewart.

His column said:

"Last Monday I decided to travel to work in downtown Los Angeles via the 'Extracar' as my automobile was being repaired. The last time that I rode a bus was in 1955 and I was rather hesitant as to what awaited me after an 18-year absence.

"Although I didn't have to be at the office until 8:30 a.m., I left the house rather early to give myself plenty of traveling time. After a good brisk walk of about 10 minutes I arrived at the bus stop on Foothill Boulevard across the street from Sunland Park.

"I had no sooner gotten there when the bus arrived at 5:40 a.m. and greeted me with that old familiar staccato hissing sound of air brakes.

"The driver, a mustached man in his mid forties, waved me on up the steps with early morning friendliness and enthusiasm and informed me that the cost to downtown 5th and Spring was 94 cents and that my transfer to 5th and Flower was only an additional nickel.

tion, the bus began to accelerate with that old nostalgic roar of the rear engine, and soon a light mist appeared on the front windshield causing the rubber wipers to make a rhythmic swishing sound.

"Above the bus aisle on both sides a small, but colorful Time's Square barrage of bill-boards — advertised suntan lotion, yellow pages, National Family Planning, a driving school, Equal Housing Opportunities and a race track which all vied for my attention and support.

"As we continued up Foothill Boulevard toward La Crescenta we began picking up passengers. These were not newcomers like myself who got on with hesitation and timidity, but seasoned regulars who hopped on with self-assurance and carried with them a gaiety and esprit de corps towards one another.

"The bus driver's response was affectious with the increasing number of riders and he would greet them with a fraternal familiarity that would make an Elk's member proud!

"I was witnessing the cross section of America going to work as evidenced by people of all sizes, shapes and colors. There were persons in suits, overalls, levis, white and blue collar workers, construction workers, secretaries and students along with a multitude of jobs and skills that I had no knowledge of.

"The woman on my left was engrossed in a paperback while the lady sitting perpendicular to me was continually yawning. Across the aisle a tackle-sized student was studying a text of some kind for a probable Monday morning quiz.

"As we approached the middle of Glendale the bus was nearly filled and our congenial driver would sing out the on-coming stops much like an aria. We turned left on San Fernando Road and traveled in an easterly direction past the Southern Pacific Freight Yard which so reminds you of Chicago and all that has been written about it.

"Here one can see the railroad homes that appear on the sides of boxcars and gondolas with animal insignias and wordings, such as 'Don't stand me still.' As we continued to our final destination the conversation centered on X-Rated motion pictures, the Watergate Affair and, of course, the proverbial unusual weather we were having!

"We were now on a short span of the Pasadena Freeway, our bus straining against the steepness of the incline and heading towards colorful and mysterious China Town.

"It was hard for me to believe as I arrived at Spring and Fourth that I had traveled some 23 miles in about an hour's time aboard the safety and warmth of a rapid transit system that I had abandoned many years ago."
